**Free Entry Sought By Bathurst Power And Paper Company**

OTTAWA, Aug. 2—(C.P.)—Free entry of salt cake imported from Great Britain, is sought by the Bathurst Power and Paper Company, Bathurst, N. B. in a reference placed before the tariff board today. Under the heading "Sodium, sulphate of, crude or salt cake," this item appears in the Canadian Customs tariff as follows: British preferential, 1-2 cent per pound, intermediate, 3-5 cent and general 3-5. Prior to September, 1930, this commodity entered free.

With a 10 percent discount on the duty of imported direct from Great Britain to a Canadian port, the duty per ton is \$9.00. The company, which uses a large quantity of this salt in making kraft paper, claims to have been operating at a loss, employing when at full capacity, more than 600 men, while the Canadian salt cake industry which is protected at a rate of 112 percent of its production cost, employs only about 50 people.

Furthermore, the Bathurst company claims, the Canadian production, which is from natural deposits of glauber salts in Saskatchewan, is exported and marketed to the extent of 40 percent in the United States.

Salt cake is produced also as a by-product of the manufacture of muriatic or hydrochloric acid. The Canadian source by this method is in Hamilton and Sulphide, Ont., but the companies producing it have never been able to supply the Bathurst company.

At full capacity the plant at Bathurst uses 4,500 tons of salt cake annually. The Saskatchewan product costs them \$20.00 per ton, made up as follows: Cost F. O. B. Fustler, Sask., \$8.00; freight to Bathurst, \$12.50. The company declared no other instance could be found in the tariff in which a raw material was given such high protection in proportion to its value.

The same commodity imported from the United Kingdom, cost the Bathurst company \$22.36 per ton, including the \$9.00 duty. All operations of the company in recent years have been at a loss which could be greatly reduced, or turned into profit, if the duty were taken

off pounds per ton of wool pulp for kraft paper and that the duty paid on the salt amounted to seven percent of the total cost of raw material entering into the manufacture.

The board will also hear other references today and tomorrow. W. E. Thorne, sole owner of Engravers Specialties, Toronto, protests against "charging a Canadian manufacturer 68 cents in duties, excise and bond fees for each and every gallon of collodion sold in Canada, whereas the engraver can import collodion at a lower price than the cost of manufacture in Canada."

Bowron Brothers, Limited, Hamilton, Ont., seek to have the duty on furs imported from California removed. They argue that these furs are not produced anywhere in the British Empire and no hardship would result from removal of the duty. The company imports the furs in gallon containers and reprocess them in fancy small jars.

The Jones Tent and Awning Limited, Vancouver, seek to have a duty placed upon Venetian blinds imported from the United Kingdom. The blinds contain 50 percent Canadian lumber, they argue, 35 percent of their cost goes to Canadian labor, give percent in Canadian paint, 2 1-2 percent in Canadian made hardware, and 7 1-2 in webbing and cord imported from the United Kingdom free of duty.

The United Kingdom product, the company claims, utilizes lumber imported from Sweden or Russia at a cost lower than it is obtained in Canada by Canadian producers.

**Poll Will Test New Voters Act**

HALIFAX, Aug. 3—(C.P.)—As the date of polling in the provincial general election August 22 draws nearer, the Provincial Franchise Act itself has taken its place as a campaign issue. Members of the Liberal opposition claim the Act, which was placed on the statutes in 1931, does not afford sufficient time for voters to get their names on the revised list. Premier Gordon S. Harrington declares it affords "the freest and fullest expression of public opinion we have ever had."

Briefly, the act provides that registrars must be appointed by the 25th day before polling; that notices of sittings must be posted by the 31st day, and preliminary voters' lists posted by the 29th day. The 27th day shall be the first on which the registrar must sit to add names. He must continue these sittings on two out of the three days immediately following, the latitude being given to allow for Sunday.

The 22nd day before polling is the limit for preparing final list of voters; copies must be posted and sent to the candidates, and copies of preliminary and final lists and affidavits to the revising officer.

The revising officer must confer with the returning officer immediately after appointment, in connection with polling divisions. Nine-teen days before the voting he is to give notice of sittings for four days, which begin on the 15th day. The 10th day is the last for certification of lists by the revising officer, and statements of changes must be sent to the candidates.

In Premier Harrington's view the act will be beneficial because "it will permit young people coming of age as voters within one month of the election to have their names placed on the list," as well as individuals qualifying under the residence clause within the same time. It would also permit a cleansing of the lists of persons who died or left the province.

He remarked, in reviewing the act, that under the old system, municipal election lists were used. Revision of these lists, when it did take place, closed early in the spring, so that many individuals who came of age later or qualified to vote as residents of the province were unable to have their names included.

**Share Honors In Winning Jasper Park Golf Meet**

JASPER PARK LODGE, Alta., Aug. 3—The new internationally famous silver Totem Pole trophy, emblematic of the mens championship of Totem Pole Golf Week, September 3rd, is on its way back here from Ireland. This beautiful trophy, since last September has been on the mantle piece of the Royal Portrush Golf Club, Portrush, Northern Ireland, having been won in 1932 by Major G. N. C. Martin.

Major Martin, a former Walker Cup player and Amateur Champion of Ireland, played faultless

golf throughout the week to win the trophy defeating H. Pollock Jr., of Havana, Cuba, in the final. He immediately expressed the wish to have the trophy shipped to his home club for the winter months where it attracted much attention.

In 1931 J. Leslie Ball of Calgary was champion. For two years previous to 1931 the trophy was at the home club of that great player Gardiner White, of New York.

The first three years it was won by three Vancouver players. The trophy is sterling silver and represents one of the best known totem poles in Indian history. This trophy goes to the club of the winner while a replica goes to the champion as permanent possession. Entries should be sent direct to Jasper Park Lodge.
