

UNIONISTS WILL HOLD EMPIRE DAY

Arrange Celebration and Invite Chief Secretary of Ireland

(Canadian Press.) LONDON, May 23.—A committee is arranging for an Empire Day celebration at Belfast on May 24, the chief feature of which will be a parade of unionist clubs.

BAD WRECK NEAR CALGARY

CALGARY, Alta., May 22.—One man was seriously injured and badly hurt, nine men and two women cut and bruised, and fifteen Chinese more or less lacerated in a wreck on the C.P.R., one mile west of Millford, about 35 miles west of Calgary, this afternoon. The wreck was due to the derailing of a tender on train No. 4, east. The two colonist cars, one tourist, a diner and standard sleeper were derailed, but the entire load of injuries occurred in one of the colonist cars which broke from its couplings and rolled down an embankment, turning over twice before leaving the ditch. The colonist car which contained the injured people was en route from Vancouver to Toronto with a mixed allotment of passengers.

FRENCH SOLDIERS ARE DISSATISFIED

PARIS, May 22.—Some French soldiers are displaying considerable opposition to the decision of the Government to keep them for another year in active service, instead of discharging them at the expiration of their two year term. Demonstrations have occurred in a number of garrison towns, and the Government is acting with great energy in suppressing opposition. A number of officers who took part in a demonstration at Toulon on Sunday were tried by court martial and sentenced to serve the rest of their term with the disciplinary battalions in Northern Africa. At Maceon yesterday 100 soldiers assembled in the public square and sang "The International," the Socialist hymn. Speeches were made condemning the introduction of the three years' term of military service.

ABANDONS THE RAILWAY FOR LAW

Prominent Official Resigns Position to Resume Law Practice

(Canadian Press.) MONCTON, May 23.—J. B. T. Caron, who was a member of the I.O.R. Board of Management until its abolition of the Intercolonial, has resigned and left for Ottawa. Before accepting the position with the I. C. R. Managing Board he was a prominent barrister in the Federal capital and maintained his office in Ottawa during his residence in Moncton. He is, therefore, returning to an established law practice.

CHEAPER FOOD FROM AUSTRALIA

SAN FRANCISCO, May 22.—One hundred and ninety-two thousand tons of meat, veal, beef and mutton arrived at this port today on the steamer Sonoma from Australia. This is the third shipment of meat received from the antipodes in the campaign to combat the high prices asked by local wholesalers. The meat is consigned direct to retailers. George F. Richards, who represents the Australian shippers, was a passenger on the Sonoma. He comes to this country to investigate the facilities for storing frozen meats on this coast and also will go to Chicago. In speaking of the shipment of meats to this country from Australia, Mr. Richards said: "We are prepared to ship all kinds of meat from Australia to the United States and an unlimited amount of butter just as soon as we find it can be cared for. We can place Australian meat and butter on this market at present transportation rates so that it will sell at a good profit at a considerably lower figure than the prevailing rates."

THE CANADIAN EXPEDITION FOR ARCTIC

NEW YORK, May 22.—Dr. R. M. Anderson, zoologist and second in command on the Stefansson Arctic expedition, left here today for Victoria, B. C., to join the party gathering for the northward voyage next month. He went by way of Ottawa for a brief stop at the capital of the Dominion, whose government is financing the expedition. Mrs. Anderson accompanied the scientist and will travel with the expedition as far as Nome, Alaska. Stefansson is busy here with final preparations for departure and will leave in two or three days for the Pacific coast.

UNKNOWN WRECK ON THE PACIFIC COAST

MARSHFIELD, Oregon, May 22.—An unidentified sailing vessel lies a wreck off the mouth of the Rogue river. It was reported late today that two men were clinging to the capsize hull, which is a mile and a half from shore, but the fate of the rest of the crew is not known. After the receipt of this news the telephone line between Bandon, Oregon, and the scene of the wreck, sixty-five miles distant, became disabled, and no further news is expected until the return of Captain Johnsen and the Bandon life saving crew.

HALF MILLION DOLLARS IN COMMISSION

TORONTO, May 22.—Half million dollars, perhaps the largest commission given in a Canadian court, was awarded today by Justice Latchford to M. I. Stewart in his action against R. I. Henderson for the sale of secret steel processes to Sir William Mackenzie. The defendant claimed that the sale to Sir William Mackenzie had nothing to do with the attempted sale to Sir Donald Mann, in which Stewart had conducted negotiations. His lordship said he could not avoid coming to the conclusion that what was done after Sir Donald left for England, after he had stopped negotiations personally with his friends and associates. The sale of the secret to Sir William is in an optional condition, as Sir William has until January next year to decide whether he will buy the universal rights of the secret. At present he holds the Canadian rights. The plaintiff according to this judgment, will receive his commission as the money is paid to Mr. Henderson through a trust company, which had been arranged previously.

TORONTO, May 22.—Sir Donald Mann, was a witness today in the action of M. I. Stewart against R. I. Henderson, for commission in the sale of secret steel processes for \$500,000 to Sir William Mackenzie. The action today was adjourned for the cause of the absence of Sir William Mackenzie, and Justice Latchford stated, that he would be obliged to answer the subpoena as others had.

BULGARIANS AND GREEKS FIGHTING

Continue Warfare With Great Fury Definite Agreement With Serbia

(Canadian Press.) ATHENS, May 23.—In consequence of the resumption of hostilities between the Bulgarian and Greek troops, King Constantine of Greece, accompanied by Prince Alexander and the general staff of the army left for Salonika this morning.

(Canadian Press.) LONDON, May 23.—A Salonika despatch says that fighting between the Greek and Bulgarian armies was continued all day with great fury. A Sophic despatch says that a definite territory agreement exists between Serbia and Greece excluding Bulgaria from all the region West of Rivers Yarder and Varesnik.

RECEPTION FOR BISHOP O'LEARY

A splendid reception will be tendered to His Lordship Bishop O'Leary on his arrival in Charlottetown on Tuesday evening. His Lordship will arrive at the Steam Navigation wharf by steamer about 7 p.m., and will be met by the citizens and the societies of the Knights of Columbus, League of the Cross, A. O. H. and B. I. S. headed by the League of the Cross Band and 4th Regiment Band. The line of march will be from the Navigation wharf up Great George street to the Pro-Cathedral, where a solemn Te Deum will be sung. After Benediction the procession will return to Queen street, down Queen to Water along the esplanade to St. Anthony's Villa where addresses of welcome will be presented by the citizens and City Council. The line of march will be handsomely decorated with red and blue electric lights while the regiments will be decorated with flags. The decorating committee are asking citizens on the different routes to illuminate their buildings. Some five hundred flags have been ordered and will be given to the boys grouped on Great George street. 300 Chinese lanterns will decorate around St. Anthony's Villa and with the other well thought out decorations, the scene will be one of loveliness. The sub-committee on decorating, Dr. Ledwell, Mr. P. A. Smith and Mr. Sixtus McLellan, has so far secured no pains or money to have their work effective and to give His Lordship a good impression on his arrival here.

THOUSANDS OF DELEGATES

TORONTO, Ont., May 22.—The men in charge of the reception of the delegates to the marmoth congress to be held by the Presbyterian Church of Canada, at the end of this month and the first two weeks of June, are beginning to realize the immensity of their task. Four thousand one hundred and ninety-two delegates are registered.

BECKER TO MOVE FOR NEW TRIAL

NEW YORK, May 22.—Joseph A. Shay, attorney for Charles Becker, the retired police lieutenant now under sentence of death for the murder of Heyman Rosenthal, notified the District Attorney yesterday that he will move for a new trial for Becker on May 23. The notification was accompanied by affidavits of Becker and other witnesses who will appear for him in the event of a new trial being granted.

SUMMER SCHOOL FOR TEACHERS

The Provincial Government has completed arrangements for a Short Course for teachers, to be held in Charlottetown during the coming summer, probably during the last of July and first of August. Arrangements somewhat similar to those under which the Farmer's Short Course was conducted are being made and it is hoped, the results will be equally gratifying. The work of the course will be mapped out by a committee consisting of Hon. M. McKinnon, Commissioner of Agriculture, Dr. E. N. Robertson, Principal P. W. College, Mr. R. H. Campbell, Superintendent of Education, Prof. Theodore Ross, Secretary of Agriculture, Messrs J. D. Seaman, D. J. Mullen, President Eastern Teachers Association, M. E. Francis, President Western Teachers Association. This committee will meet in the Assembly Chamber on Monday next to complete arrangements for the course. Teachers attending the course will have their travelling expenses paid and will also receive an allowance to help defray living expenses while in Charlottetown.

ROYAL WEDDING BERLIN EN FETE

Prince Ernst Marries the War Lord's Only Daughter

BERLIN, May 24.—In the presence of one of the most distinguished assemblies that could be gathered in Europe, the Princess Victoria Luise, of Prussia, only daughter of the German emperor, will be married today to Prince Ernst August of Cumberland. The ceremony will be performed in the chapel of the Schloss and consist of the simple wedding service of the Lutheran Church. The spirit of the affair will be plain and domestic, although the costly gowns and jewels and the showy uniforms of distinguished persons, high officials of the empire, the army and the navy, the foreign envoys and the delegations representing the municipalities will furnish a regal setting. The spectacular part of the wedding will consist of the arrival of the bridal party at the chapel. The civil ceremony, which takes place earlier in the day, will be entirely private and the attendance limited to the households of the bride and the bridegroom. But the arrival of the bridal party at the chapel will afford an opportunity for the populace to give vent to their enthusiasm. Representatives of all parts of the empire and many foreigners will be in the great crowd in the vicinity of the palace, while the brilliance of the decorations of Unter den Linden and neighboring thoroughfares appear like a continuous canopy of garlands, banners and arches. Red and black, of course, predominate in the high towers of other color give a delightful picturesqueness to the combined effect. More than half a hundred representatives of the royal families of Europe will be assembled in the chapel to await the arrival of the bride. Most are the Kings and Queens of England, whose every public appearance during the day was the signal for an outburst of public enthusiasm that tokened well for the success of the sincere efforts that are being made on both sides to bring about a closer friendship between Britain and Germany. The guests will all stand in a wide circle about the altar, for there are no pews, and behind them, without regard to rank, the members of the foreign embassies, the rulers of the German states, admirals of the navy, the commanders of army corps, the cabinet ministers, several hundred members of the nobility and a large corps of newspaper correspondents. The bridegroom is of white satin and handmade lace, made with a court train three and one-half yards long. Four maids of honor will carry the train, and behind them will walk two pages. The bride will wear a white lace. The bride will be adorned with a crown of diamonds and rubies. Her only other ornament will be a necklace of diamonds. The bridegroom will wear his uniform as an officer of the Bavarian army, in his left hand he will carry a helmet with white plumes, and his breast will be decorated with the ribbon of the several orders to which he belongs. Although the marriage of Prince Ernst August and Princess Victoria Luise is an alliance of high political significance, it is insisted that genuine affection is primarily responsible for it. Prince Ernst, who became the heir of the Duke of Cumberland a year ago, after the death in a motor car accident of his elder brother, Prince George Wilhelm, is 25 years old, and therefore five years the senior of his bride, who will be 21 next September. The two met for the first time in Potsdam last summer, when the Prince came to thank the Emperor for his sympathy on the occasion of a serious illness of Prince George. The Prince and the Emperor's daughter are said to have been mutually attracted at first sight and a brief courtship was followed by the announcement of their engagement early in February. The political significance of the marriage is the fact that it regards as a satisfactory settlement of the long-standing quarrel over the succession to the throne of the Kingdom of Hanover, to which the Duke of Brunswick, father of the bridegroom of today, and who also bears the English title of Duke of Cumberland, is a claimant. Naturally the dispute has had a tendency to disrupt the friendly relations of the German and English royal families. It is now expected that the breach will be permanently healed by the Emperor placing his new son-in-law on the throne of Brunswick, with the title of Duke.

MORE MILITANT TACTICS EMPLOYED

(Canadian Press.) LONDON, May 23.—Militant outrages are now being committed in the vicinity of the aristocracy in the west end. At several recent social functions in that section pictures and tapestries were cut. Hostesses, alarmed, are employing detectives to protect their homes.

NOVA SCOTIAN DROWNED IN WEST

WINNIPEG, May 22.—Charles Getson, from near Halifax, Nova Scotia, was drowned in Rainy River this morning being upset out of a small canoe. Joseph Graux, his companion, swam to shore. The Indian recovered the body by dragging with fishing line an hour after. An inquest will be held to-morrow.

BANK MESSENGER GAVE BATTLE TO HIGHWAYMAN

NEW YORK, May 22.—James T. Wintress, a bank messenger, gave battle in the street today to four highwaymen who leaped into his carriage and attempted to wrest from him the pay roll of the Nathan Manufacturing Company. Resisting their efforts to subdue him with a rifle, revolver and clubs, he fought to such good purpose that he saved the money, although he was shot in the arm and had his scalp laid open with a blow from a club. Two of the men were caught.

DARTMOUTH GIRL FATALLY BURNED

DARTMOUTH, May 22.—Much sympathy is expressed for Mr. and Mrs. Vernon Smith, King Street, in the death of their six year old daughter, Muriel Ethel which occurred yesterday afternoon. Mr. Smith had lighted a bonfire in the yard early in the morning for the purpose of burning some old rubbish and thinking he had distinguished it he went away, but about ten o'clock the little girl while playing around the refuse, which were evidently still burning, while the misfortune of having her apron catch on fire and in the high wind her clothes were soon a mass of flames. HOLDS COURT ON TRAIN

FOUGHKEEPSIE, N. Y., May 22.—District Court, is the first judge to hold court on a train speeding fifty miles an hour. For six years Judge Mack and a jury had been hearing a suit between the Amsterdam Building Company and the R. V. Delapena Company. Judge Mack's patience had been worn to the ragged edge when one of the lawyers turned to oppose counsel and said: "If I thought the judge would agree, I would take this court and jury to Foughkeepsie and let them see the work and decide for themselves." The Judge agreed to the idea with alacrity. He saw no objection to the suggestion, especially as both sides promised to charter a special train for the legal excursion. So the lawyers retired to see which side should foot the bills, and it was arranged that the journey should be made yesterday.

KAISER IS LATE FOR FIRST TIME

BERLIN, May 22.—At the arrival this morning of the venerable Duchess of Baden, for Saturday's wedding, the Emperor William, who is always a model of punctuality, was late for the first time in his life and the few spectators on the station platform were treated to the spectacle of His Majesty, in a hasty run, endeavoring to reach the halting place of the railway car before his aunt stepped out. He lost the race.

THE KING MAKES STIRRING SPEECH

Says Preservation of Peace is His Desire as it Was His Father's.

(Canadian Press.) BERLIN, May 23.—King George of Great Britain, the present guest of Emperor William on the occasion of the marriage of Princess Victoria Luise to Prince Ernst August of Cumberland, spoke earnestly but briefly today of the necessity of the maintenance of peace throughout the world. In replying to an address presented to him by British residents of Berlin, who gathered at the British embassy, His Majesty said: "The preservation of peace is my fervent desire as it was the chief aim and object of my dear father's life. This was the first and only political note sounded during the wedding festivities of Emperor William's only daughter. The chief significance of the Royal Imperial visits is the demonstration of peaceful and friendly relations existing between three powerful dynasties."

FEARS REVOLT IN U. STATES

NEW YORK, May 22.—Sir Robert Perks, Bart, who has been stopping at the St. Regis for some time, said this morning on the Mauretania for England. "The idea of liberty in this country is a farce," said Sir Robert last night. "New York is leaning and leaning hard," towards paganism. Where will it end? It is hard to say, but I fear that unless your people return to the elementary forms of Christianity there will be an age of decadence in your country followed by a revolt which will overthrow the whole social system."

LIGHT EARTHQUAKE IN NAPLES

NAPLES, Italy, May 23.—Vesuvius during the night and this morning showed renewed signs of activity, one eruption causing a slight earthquake shock. A new and larger central fissure has opened round the crater from which ashes are emitted which however, have not yet gone beyond the limits of the volcano.

CONGRESSMEN LABELLED AND THEY KICK

NEW YORK, May 22.—A warrant was received here from Washington today, calling for the re-arrest of Henry W. A. Page, a wealthy English linen merchant, convicted in Washington a year ago for libelling members of congress. At that time he was sentenced to five years imprisonment, and fined \$1,000, but was released under suspended sentence. The order for re-arrest, it is understood, was issued on the ground that he had violated the terms under which sentence was suspended by writing of his grievances to the president attacking the department of justice. Page's conviction followed his circulation of pamphlets calling congressmen "crooks." He believed that the courts had treated him unfairly in giving his wife the custody of their children, after granting her a separation. He memorialized congress, asking for the impeachment of certain New York judges, and when the house judiciary committee, to which his petition was referred, gave him no satisfaction, he printed and mailed to members of both houses, pamphlets containing a lurid attack on various congressmen. Page could not be found at his office this afternoon, and it was said he was out of town.

JAPANESE EMPEROR HOLDING HIS OWN

Palace Officials Declare Prospects for His Recovery Hopeful

(Canadian Press.) TOKIO, May 23.—An official bulletin on Emperor Yonaito's condition by the court physicians, says: "His Majesty's temperature has risen to 103.46 fahrenheit. His pulse is 90, respiration 30. The young Emperor is holding his own, according to officials at the palace, who declare the prospects for his recovery are more hopeful. Multitudes of Japanese prayed throughout the day in the neighborhood of the palace and also in temples and churches and at various shrines."
