

BRITISH STUDENTS TAKE VENGEANCE

(Canadian Press) BRISTOL, England, Oct. 24.—Students of Bristol university today avenged the burning of the sports pavilion of the university by suffragettes by smashing the windows of offices of Militants, dumping their furniture into the streets and making a bonfire of it. The students were cheered by large crowds.

GENERAL DIAZ HAS FULL LIBERTY

(Canadian Press) MEXICO CITY, Oct. 24.—There is no intention on the part of the Mexican government to arrest General Diaz according to Querido Mehone, Minister of Foreign Affairs who says that Diaz is at liberty to come to the capital when he chooses. The fact that General Diaz was officially relieved of his mission to Japan relieves him of the charge of insubordination, according to officials here. Other members of the embassy to Japan were arrested for disobeying orders. All the other candidates for presidency are assured they have nothing to fear from Huerta.

SOCIETY LEADER IS FINED AS SMUGGLER

NEW YORK, October 23.—Mrs. Frank B. Wiborg, of Cincinnati, was fined \$1,750 in the United States district court today for having failed to declare dutiable goods on her arrival on the steamship Mauretania, September 5. Henry W. Taft, brother of the former president, and Frank A. Munsey were on hand in court today ready to testify as character witnesses in her behalf.

Mrs. Wiborg, who is a niece of General Sherman, pleaded guilty through her attorney and threw herself upon the mercy of the court. The attorney asked that a prison sentence be not imposed on the ground of his client's poor health. "I am surprised," said Judge Hunt, in imposing the fine, "to see a person of your prominence and intelligence" not giving the customs regulations proper consideration.

SIX KILLED AND SCORE INJURED

By Explosion of Gas Oven on Sixth Floor. Sensational Escape of Frapped Workers.

(Canadian Press) NEW YORK, Oct. 24.—A gas oven in which metal was being enamelled on the top floor of a six-story factory building on Canal street, exploded today killing six persons. More than a score of others were injured or burned in the fire succeeding the explosion, some of whom may die. The identity of the dead was not known for many hours after the bodies had been removed from the morgue. Three of those killed were women and all were workers in the building. Search lights were placed on the ruins to-night while the firemen sought for more bodies which it is thought might have been overlooked, but no more were found. The district attorney's office has begun investigations. About 200 persons were employed in the building and the escape of some trapped workers was spectacular. With their clothing ablaze they climbed out through the flame-swept windows on to the fire escapes and leaped to the sidewalks. Many were badly injured by the drop from the upper floors. The spectators beat the flames from their clothing and saved them from burning to death.

IMPORTANT MEETING I.O.F.

Yesterday afternoon a special meeting of the High Court, I. O. F. was held in Castle Hall, city. There was a large representation of Foresters from quite a number of the subordinate courts throughout the province. That an opportunity might be accorded for a full and free discussion of the matter for which the meeting was called on motion it was unanimously agreed that the meeting be resolved into a conference of Foresters of the Province, that all members might have the privilege of expressing their opinions.

Rev. E. J. Katte, H. C. Ranger, and Representative of the High Court at the Supreme Court lately held at Toronto, gave a full and lucid report of the proceedings of that meeting, contending that in general the arrangement made in regard to the pre-1913 members was about as equitable as could be devised; but admitting that, possibly, some better solution could be found.

Bro. John Anderson, P. H. C. Ranger and special representative of the High Court to the Supreme Court, submitted a very thorough and critical review of the proceedings of the Supreme Court, and expressed his conviction that the settlement effected in respect to the members who joined prior to 1898 was very far from being just to this class of the membership.

Bro. M. E. Grass, High Court Ranger of New Brunswick, was present as a visiting brother and was invited to take a place on the platform. By his intimate knowledge of the subject under consideration and by his clear and lucid manner of presentation he assisted very materially in the elucidation of the intricate matters being considered.

Bro. Mollison, Rev. Marshall, Hodgson and others contributed to the discussion, some maintaining that the arrangement was fairly equitable; others that the old members were unfairly treated, especially in that the surviving members of the pre-'99 class are obliged not only to make good the deficiency occasioned by the inadequate rates paid by themselves but by the deficiencies accruing from the inadequate rates paid by those whose policies have been settled in full. A committee, consisting of Dr. A. Ross, Rev. Mr. Marshall, Messrs. Horatio Nelson, J. E. B. McCreedy, and Neil McLeod, K. C., was appointed to draw up a resolution embodying the views of members. At the opening of the evening session the committee submitted their report which was discussed very thoroughly clause by clause and was adopted with scarcely a dissenting voice. It was further resolved that Bro. Dr. A. Ross, Jno. Anderson, and Neil McLeod be a committee to present the resolution adopted to the members of the House of Commons and Senate from Prince Edward Island to the end that they urge the Parliament of Canada to take such action in the premises as they may deem proper. Before retiring many of the leading members urged the membership by any means to drop out of the order until they had carefully considered the matter, or at least to wait till they saw if some improvement might not be made or until they had secured other adequate protection. The resolution adopted will be given in next issue of The Guardian.

MARITIME REPRESENTATIVES ARRIVE AT OTTAWA

Preparing Memorandum for Presentation to Conference. Restoration of Original Representation and Readjustment of Subsidies Chief Features.

(Special to The Guardian) OTTAWA, Oct. 24.—Delegates at next week's Provincial Conference arriving tomorrow will see the first preliminary meeting of the Maritime Provinces delegates. Premier Fleming, Attorney General Grimmer, of New Brunswick, Premier Mathieson, Hon. A. E. Arsenault, Senator, Murphy, A. A. LeFurgey, Ex-M. P., of Prince Edward Island, reached the capital today. Premier Murray of Nova Scotia,

and Hon. W. S. Stewart, of Prince Edward Island will be here tomorrow; Sir James Whitney, Premier of Ontario, is expected tomorrow. Delegates from the Maritime Provinces will meet tomorrow to draw up a memorandum for presentation to the Conference. The memorandum contains a number of counts, chief among which will be a demand for a fixed minimum representation in the House of Commons, and for read-

justment of subsidies. The Maritime Provinces insist that their representation should never fall below the figures prevailing at Confederation. They demand larger subsidies based upon the contention that the territories added to the Prairie Provinces, Ontario and Quebec belonged to the whole of Canada including the eastern provinces, and that the eastern provinces should be compensated for the loss.

HOW MEXICANS ARE MISLED

(Canadian Press) MEXICO CITY, Oct. 24.—The controversy between the United States and Britain appears to be having the effect of convincing the Mexicans that the European nations generally are coming into line in opposition to the United States.

MARITIME TRADE IN GOOD CONDITION

(Canadian Press) MONTREAL, Oct. 24.—Business conditions and the outlook in Nova Scotia are satisfactory, said F. B. McCurdy, M. P., Halifax, today. The Maritime Provinces business is not subject to violent fluctuations that occur in more volatile communities.

FRANK HAYNE'S TRIAL POSTPONED

(Special to The Guardian) SYDNEY, N. S., Oct. 24.—Frank Haynes, charged with the murder of B. S. Atkinson, will not be tried at the coming session of the Supreme Court. This decision was reached by counsel for the crown at a conference yesterday. This is agreeable to the defense. Special sitting will probably be held by the end of November.

LORD DECIES SPENDS \$150,000 IN COURTS.

LONDON, Oct. 23.—Lord Decies, who married Vivien Gould of New York, is still keeping the English lawyers busy. Already the costs of his varied litigation has amounted to \$150,000. A new complicated action connected with the renovation of Seton Park is to be heard this session on appeals by Lord Decies and his builders against judgments given in former suits.

BISHOP SHOT AT.

HARBOR GRACE, Nfld., Oct. 22.—His Lordship Bishop MacLeod was shot at, whilst celebrating mass on the cathedral altar here Sunday. One bullet slightly grazed his lordship's head, the other being found embedded in the plaster. The would-be assassin is a young Catholic man of this community, named James Hare, who recently returned from Canada. He bore a good reputation previous to leaving here, but it is believed is now mentally afflicted. He is a hard drinker and also has acquired anarchistic ideas, and is reported to be connected with some such association abroad. He says he is a socialist. Hare approached the altar through the vestry door, entered the chancel and fired the first shot from a seven-chamber 22-calibre revolver at his lordship 12 feet distant. Then he quickly advanced to within six feet and fired the second shot. Several men hurried over the altar rail, captured the man and took the revolver containing four unfired cartridges. They removed him to the prison cell in the court house jail. Intense excitement prevailed, many of the women fainting whilst others rushed from the church. The man at first was unrecognized and was supposed to be an anarchist. His lordship, after seeing the man properly protected from the violence of the excited men, returned to the altar and continued celebrating mass. At its conclusion he asked the congregation not to attach any importance to the incident, stating that the poor man was evidently demented and therefore not responsible for his action. He expressed sympathy for the unfortunate man.

MARITIME BAPTIST CONVENTION

(By Special Correspondent) A. HERST, N. S., Oct. 20.—The Report of the Board of Governors of Acadia University was a most important one. The Baptists of the Maritime Provinces have splendid educational institutions at Wolfville, N. S. Last year in all the departments there was an enrollment of 712. This year the enrollment is larger. Last year the enrollment in the College proper was 244, in the Academy for Boys 184 and at the Ladies' Seminary 284. Some changes have been made in the teaching staff and the Faculty has been enlarged by a number of new Professors. Dr. R. V. Jones after 53 years faithful service retired last May. He was one of the distinguished sons of Prince Edward Island and his native place is Powell. There are now on the teaching staff eighteen professors, five instructors and three Laboratory assistants. The Dominion Government has established at the University a fine Meteorological Station under the direction of Prof. Coit. There is a large and efficient staff at the Boy's Academy and also at the Ladies' Seminary. The Academy Residence is fitted to its utmost capacity and the Governors have to consider the enlargement of the building. The Seminary Boarding house is fitted to overflowing and a number of young ladies in attendance have to board in the town. The new fine Art building which is to be erected in the near future will give increased accommodation. The campaign to raise \$150,000 in order to secure \$51,000 more from Mr. Rockefeller is nearly completed. Already another campaign is started to raise another sum of \$250,000. The Hon. Nathaniel Curry has promised \$125,000 on condition that another \$125,000 be raised. This will be done. Mr. Curry has only recently given \$25,000 for the establishment of a Professorship in honor of his son who died. It is called the Ivan Curry Professorship. These gifts make possible still further expansion of the growing schools. Already there are three new buildings of brick and a large fire proof Library building is now in the process of erection. It is the intention ultimately to have all the buildings of brick and stone. There has been the most marvellous development within the past ten years in the schools of Wolfville. In 1903 there were 399 students in attendance. In 1913 it is 712. Ten years ago the Trust Funds amounted to \$241,970. Now they are increased to \$514,546 and this amount will soon be very much greater. Baptists have great reason to be proud of their institutions of learning at Wolfville. At two o'clock in the afternoon a very tender memorial service was held for the departed. Rev. R. O. Morse read a very tender obituary report. Rev. C. H. S. McLeann, North River, Rev. W. M. Smallman, Bridgewater, N. S., took part in the service. Mr. Smallman is a native of O'Leary. Mr. N. B. Smith, a prominent business man of Halifax, N. S. and an ex-elderman of that city was elected President of the Convention on the receiving of the report of the Nominating Committee. A W. Sterns Charlottetown, was elected first Vice President and Rev. W. F. Parker, St. James was chosen 2nd Vice President. Rev. W. C. Goucher, D.D., the retiring President gave his address. His message was to the younger ministers especially. The times were critical and crucial. The answer to the industrial problems rested largely with the Church of Jesus Christ. The Churches cannot dictate but they can inspire. They must marshal the spiritual forces of their day. He grouped his remarks around three suggestive thoughts. 1. The Central Need of the Church today was the deepening of the spiritual life. We must have a religion that conquers the head and the heart. 2. Christianity of today needs to be intensified human and must make much of the brotherhood of man. 3. The Christianity of today calls for a fuller knowledge of the Bible. Every Church should be a Bible school, in session. The cross is the centre of the gospel. The message that proves most effective today, as in the early days, is that which contains the dy-

BISHOP O'LEARY HONORED.

BOSTON, October 21.—It was a notable body of about 400 successful men, former residents of Prince Edward Island, that gathered in one of the large dining rooms of Copley Plaza Hotel last evening to do honor to Rt. Rev. Henry J. O'Leary, D. D., bishop of Charlottetown, who is in the city attending the sessions of the Catholic Missionary Congress. While the gathering was arranged primarily in honor of Bishop O'Leary there were two other distinguished members of the hierarchy of the Catholic Church present in the persons of Rt. Rev. James Morrison, D. D. bishop of Antigonish, and Rt. Rev. J. T. McNally, D. D., bishop of Calgary, Alberta. Several lay residents of the island, who were attracted to Boston by the Missionary Congress, were also in attendance. His Eminence Cardinal O'Connell, accompanied by his suite, paid the gathering a brief visit, as did also Mayor Fitzgerald, at the conclusion of the reception tendered to the Church dignitaries and delegates to the congress in the main ballroom of the hotel. Cardinal O'Connell and Mayor Fitzgerald were both accorded enthusiastic receptions and they briefly extended the welcome of the diocese and the city. The dinner was an enjoyable one, the after dinner speaking being free from anything of a studied character. Bishop O'Leary was probably more serious than the others who spoke, as might be expected of a guest on such an occasion. He is probably one of the youngest prelates of the Catholic Church on the American Continent, being but 34 years of age. He is rather boyish in appearance, yet his utterances are forceful and indicative of a keen intellect. He was consecrated bishop at Bathurst, N. B., where he had up to that time been rector, May 19th of the present year.

HON. C. DALTON ENLIGHTENS HUB

On the Mysteries of Fox Farming at Complimentary Banquet.

(Canadian Press) BOSTON, Mass., Oct. 23.—Prominent Bostonians tendered a banquet to Hon. Charles Dalton at Copley Plaza Hotel last evening. His brilliant address on fur farming captivated the business men, bankers and chamber of commerce representatives present. A telegram of congratulations was received from Lieut. Gov. David I. Walsh. Referring to the above the Boston American says:— "The vast possibilities of Canadian fox farming were explained entertainingly by Mr. Charles Dalton, the prominent Charlottetown, P. E. I., citizen, who is in Boston in connection with the Catholic Congress, at a complimentary banquet tendered him last evening in the Copley-Plaza. Mr. Dalton is a member of the Prince Edward Island Cabinet and is said to be the logical next Lieutenant-Governor of the island. Besides he is a business man. Mr. Dalton told how modern methods of breeding wild animals for their pelts have replaced the primitive methods. The wilds in addition to the business touch of romance of the Canadian prospects open, upheld the attention of the audience. The speaker was introduced by R. L. Cleveland, who presided at the banquet. The phenomenal expansion that is taking place in the black fox industry on Prince Edward Island was dwelt upon at length by the speaker. He explained how the methods of rearing of the capricious royal black fox and silver fox had become generally known only so recently as 1910. Mr. Dalton said that the skins of these quasi-domesticated animals have come to command the highest prices, not infrequently fetching from \$1,500 to \$2,000. The characteristics of black fox furs were described by the speaker. A perfect skin, he said, has a foundation of jet black, with a sprinkling of hairs on the back and rumps which are silver grey for a portion of the distance between the root and the tip of the hair. The extremity of the tail is always pure white. The brilliancy and sheen of a fine pelt, he said, are notable. The effects of the climate on the foxes, the experience required in growing the animals, the problems in breeding, the selling end of the business, the locating and planning of a ranch, the care and food of the animals and finally the marketing and prices were all described.

\$13,000,000 PROJECT FINANCED

BRITISH MINISTER SYMPATHETIC

(Canadian Press) WASHINGTON, Oct. 24.—The British and Foreign Office through the Embassy here today officially denied to the State Department the authenticity of the much discussed published interview with Sir Lionel Garden, British Minister at Mexico City, which represented the Ambassador in an unsympathetic policy with the United States.

NEW ZEALAND RUGBY TEAM WINS ALL ALONG.

SAN FRANCISCO, October 22.—By defeating Santa Clara university, 42 to 0 today, the all-star Rugby team from New Zealand raised its total of points scored in its six matches in the United States to date to 232 without a point having been scored against them.
