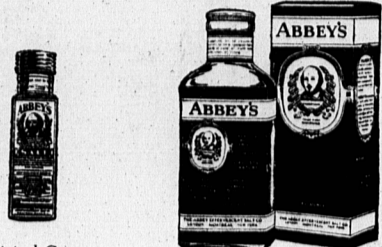

Dobbin Still A Feature on Hilly Montreal Streets

MONTREAL, Sept. 1.—In one city in Canada the horse still holds its own, despite the competition of the automobile and the tram car. The old-time open cabs, with their meticulously groomed horses, which are to be seen waiting in patient line in front of the McGill campus, and at Dominion Square add greatly to the atmosphere of romance which colors the French Canadian city, not only for the native Canadian, but for the visiting tourists.

The mountain, with its beautiful winding drives and criss-crossing paths is sacred to the pedestrian, the equestrian and the cab. Children may roam with safety within the generous precincts of this unique park. The leisurely adult may enjoy a quiet stroll without the disturbance of strident motor horns, free from fear of being run down if he allows his attention to wander to the wide horizon line or to yet more distant vistas of day-meticulously groomed horses, which are to be seen waiting in patient line in front of the McGill campus, and at Dominion Square add greatly to the atmosphere of romance which colors the French Canadian city, not only for the native Canadian, but for the visiting tourists.

CANADIAN LAWYER GIVEN HIGH PRAISE BY LEGAL VISITOR

TORONTO, Sept. 1.—"Our Changing Responsibilities," was the subject spoken on by the Hon. Silas H. Strawn, representative of the American Bar Association to the Canadian Bar Association, at a luncheon meeting of the latter body yesterday.

Introducing his remarks, Mr. Strawn paid a compliment, which he assured his hearers was sincere, to Canadian lawyers. "The plain truth is," he said, "that the education of the Canadian lawyer is more thorough than the education of the American lawyer. You have better lawyers because of that."

Quotes From Dickens

Harking back to legal battles of years ago, Mr. Strawn quoted liberally from the works of Charles Dickens to illustrate the condition of the courts in earlier times. Cases which ran for years, and into which children were born, young people were married, and out of which old people died, were not uncommon. Often such masses of evidence were accumulated that no one really knew what the case was about when it began to draw to a close, and the last eighteen lawyers, each with enormous briefs, arose to present the last few witnesses. In the present day many of the delays and other bad features of that period have been abolished.

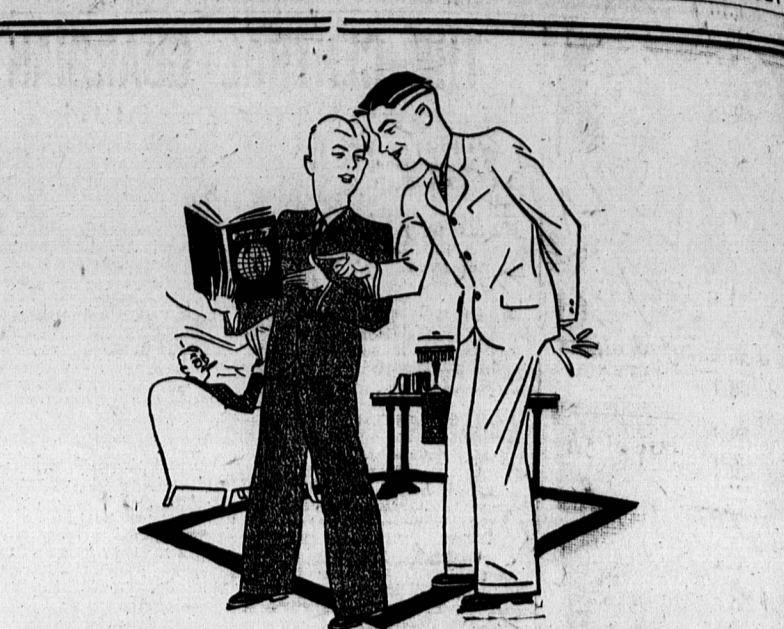
Old Days Recalled

Forty years ago, or less, lawyers were different people from what they are now. Then oratory, free and loud, was their chief stock-in-trade. They had no offices to speak of, and were willing to give at any moment opinions on the most difficult points without consulting any books at all. Those were the days of litigation, when such masses of evidence were gathered by the lawyer "practiced more by ear than by note. His work was destructive rather than constructive." The life of the lawyer today is one of ever-changing experience and increasing responsibility. With the growth of transportation and trade the lawyer has been forced to acquire a knowledge of law and business almost incomprehensible to the layman. He must have a combination of the intellectual and the practical, and know more about everything than does any client calling on his services. This demand for great knowledge leads to the creation of specialists in branches of law. And the increasing demands made upon the lawyer by increasing net-works of corporations force him to know more about his country and other countries. He is, therefore, forced to be a better citizen, spending much more time than was formerly the case on the study of the governmental and economic workings of the nation. Where he formerly thought only of his client, he is now forced to think also of the good of the country, as it will be influenced by the demands of his clients.
