Latest R.C.A.F. Casualty List

OTTAWA, Nov. 18 (CP)—The R.C.A.F. in its 424th report on the progress of the war today reported two men missing and five killed in action during overseas air operations, one missing after overseas air operations, and one seriously injured on active service.

The overseas section of the list also contained the names of three men who are prisoners of war, five previously reported missing, now are for official purposes presumed dead, one dangerously injured on active service, one seriously injured as a result of injuries sustained on active service.

National Christmas

OTTAWA, Nov. 18—Thousands of Canadians will find it easier to give War Savings Stamps and Certificates as Christmas gifts next month, as the result of plans now completed by the National War Finance Committee.

Through the co-operation of the Canadian Greeting Card industry, a whole series of 1942 War Savings Stamp Christmas cards has been produced in striking designs. All cards are printed in five colours, and the inside pages are finished in colour with a place for affixing War Savings Stamps, which may be purchased at the stores carrying the cards. In addition, the National War Finance Committee has produced Christmas greeting cards in two attractive styles for Savings Stamps, and two other types for War Savings Certificates. These, with envelopes to fit, are to be obtained free of charge at Post Offices and banks throughout Canada. War Savings Stamps and Certificates to be placed inside the cards, may be purchased over the counter at the same time, and mailed immediately.

This undertaking is being carried out by the National Committee on the Government of Municipalities incorporated under the laws of this Province, and on the law enforcement officers acting under the direction of these governments. We assert that a heavy burden of responsibility rests on that group of medical doctors who have been issuing prescriptions to provide liquor for beverage purposes, and thus to a degree have been defeating the purpose and intention of the Prohibition Act.

"In view of these facts we ask on behalf of the temperance people of this Province the following action:—

"1. That the Provincial and Municipal Governments and their respective law enforcement officers co-operate in a total and continuous effort to close all places of illegal sale and to keep them closed; and that the attorney-general assume responsibility for initiating such co-operation.

"2. That the Attorney-general make available to the secretary of the Temperance Federation a monthly statement to be published in the press of the Province making known the progress of this co-operative effort.

"3. That the Government at the next meeting of the Legislature introduce an amendment to the Prohibition Act providing for a limit of 50 prescriptions of liquor a month for each medical doctor, as requested by the people in the plebiscite of June 26, 1940. We re-
