ALL DELEGATES (Continued from page 1) fully parried the efforts of journalists of all nations who he received tonight to find out what really passed over the tea cups.

At noon tomorrow Stimson will lead the American delegation to pay his formal respects to Mr. Macdonald at Downing St. Tentative arrangements have been made for him to meet Premier Andre Tardieu of France and Foreign Minister Dino Grandi of Italy on Sunday. But unless the Japanese take the initiative, Secretary Stimson will not meet them again before the conference. The chief of the Italian delegation, Dino Grandi, Italian Foreign Minister arrived in London today.

Despite the failure of France and Italy to reach a preliminary agreement for limitation of their naval armaments, optimism prevails in the Italian delegation. The Foreign Minister who is just over 30 years of age and the youngest of all the delegates assembled here, is full of hope that financial burdens of all countries on naval ships will be lowered. Those conversant with Italian affairs know that the views of Grandi are synonymous with those of Premier Mussolini whose right hand man he is. The foreign Minister was one of the earliest Fascists, having joined the movement soon after fighting in the Great War as an officer of Alpine troops. Italians believe Signor Grandi better than any one else can convince the powers here that Italy wishes to achieve her national aspirations through a long period of peace and hard work. Italians feel ample proof of Italy's aspirations for peace is afforded by Grandi's avowed willingness to reduce armaments to an extreme limit, placing only the condition that other powers do so proportionately.

000,000 in 1927 to \$198,000,000 for the year ending November 30, 1929. What had the government done about the menace of tariff increases by the United States. "Well," he continued, "Senator Dandurand at the League of Nations, boasted that Canada was the only country in the world to reduce her tariff since the Great War." The policy of the present regime, the Opposition Leader stated, had brought about a condition under which this country bought three and one half times more goods from the United States, than from Great Britain. In the last year, Mr. Bennett asserted, the Dominion had spent approximately \$900,000,000 for products purchased in the United States. Of this sum he declared \$50,000,000 should have been spent on goods which could and should have been made in this country.

The Y. M. C. A. Song Service The largest group of young people this season, attended the special song service in the Y. M. C. A. last evening. Special attractions were the two speakers - Rev. Robt. Johnson of Ottawa, and Rev. Capt. Casey of London, England - and the popular soloist, Mr. Charles Earle.

Mr. Johnson took as a topic for his short talk, "The life of youth today compared to what it was 25 years ago." He stated that today's youth are different but not inferior to those of yesterday. We are in danger of losing our reverence for things spiritual. There is a time for both seriousness and gaiety. But every young person should take Jesus Christ as their pal and saviour all the time. Another note mentioned by Mr. Johnson was that there is none of the hypocrisy and smug sanctimoniousness that characterized some of the people of 25 years ago. The speaker concluded his talk by outlining the three christian institutions: 1. The home, in connection with which we must remember the holiness and seriousness of marriage. 2. The state which we must help to make christian by using our vote.

CHURCH SERVICES ZION CHURCH

"The Faith that Overcomes," I John V was, the theme of the morning sermon. Reference was made by the minister to the splendid year which Zion Church had experienced in all departments of her endeavor.

The entire Budget Allocation of \$1,100 has been raised in eleven months, while there is a surplus in Current Account. Most of the organizations have a comfortable margin to their credit at the end of 1929. Dr. Johnston grouped his thoughts around four main points. By being too busy a man may lose (1) the joy and charm of living; (2) he may lose his children; (3) his church; (4) his soul. The splendid audience present was deeply impressed.

Prohibition Cases At Summerside (Special to the Guardian) SUMMERSIDE, Jan. 19 - The Prohibition Magistrate held his first court at Summerside since Christmas in the Court House on Saturday. There were seven cases on the docket. In all cases the prosecution was conducted by Chief Inspector Hayward. The first case was against a Summerside man for illegal consumption of liquor. He was convicted and fined \$10 and costs. The next case was against Joseph Gallant, Summerside, charged with having liquor in his possession on the hockey special on the night of January 10th. The case was brought by prohibition officer Keir Mann. He was found guilty and fined \$300 or five months in jail. The next was a case against a Charlottetown man charged with illegal possession of liquor on the return journey of the hockey special to Charlottetown in the early morning of January 8th. After several witnesses had been examined for the defence the case was dismissed for lack of sufficient evidence to convict a case against a man from St. Eleanor's was adjourned to Charlottetown on Monday. The case against John R. McCormack of St. Eleanor's next came up. Customs Officer Platts gave evidence of finding three tiddies of rum concealed under straw on the barn floor at McCormack's farm. McCormack denied any knowledge or connection with the liquor. Clarence Arsenault swore that he bought the rum in Summerside and concealed the liquor in McCormack's barn unknown to the accused and without his permission. Another witness testified that he had been at McCormack's place on the day of the raid. He had assisted Arsenault to unload some machinery at the barn and Clarence had offered him a drink out of a bottle. McCormack was not present but was at that time in the house cellar. Clarence Arsenault was employed by O. B. McCormack the brother of the accused. The case was dismissed. After several witnesses had been examined the case against a party in connection with a disturbance on the hockey special on the night of January 10th was adjourned for judgment at Charlottetown on Saturday next. The last case on the docket did not come before the court, being adjourned for hearing on Saturday next. Counsel for the defence in the various cases were Messrs. Heath Strong, K. C., Ernest Strong, K. C., T. A. Campbell, and C. D. McCollum.
