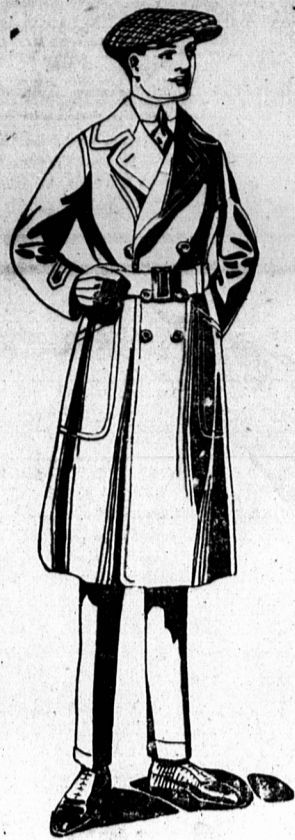

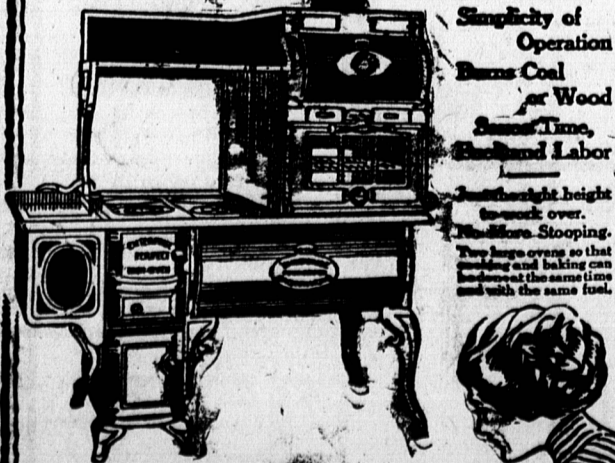

### END OF THE WAR MAY BE NEAR

There is one great day of rejoicing coming, the day on which Germany lays down her arms and the war is definitely over, the day when homes that have sat in anxiety and fear, many of them for over four years, may look for the return of their loved ones. When that day comes, be it soon or late, let there be one general, prolonged, continuous bell ringing, whistling blowing, parading, flagging and such demonstrations as may occur to people from whose heads and hearts the burden of a great anxiety has been lifted.

When definite word comes, the press will announce it to the civic authorities and by bulletins, the fire bell and church bells will be rung and this may be accepted by citizens as the end of the war.

### A GOOD EXAMPLE

The gentlemen at the head of the Victory Loan in this province have set a good example in subscribing liberally to the loan, thus showing that they do not ask others to do what they are not quite willing to do themselves. A list of their subscriptions was given in yesterday's Guardian.

While the subscriptions are generous the fact should not be overlooked that they are giving their services free.

Mr. C. H. B. Longworth, Chairman of the Provincial Executive and Mr. W. K. Rogers, Chairman and organizer for King's County, are serving their second term without any other compensation than the satisfaction derived from doing a patriotic duty, while Mr. Neil McLeod, K. C. of Summerside accepted the position of Chairman and Organizer for Prince County with the express stipulation that

he would be permitted to give his services free. The chairmen of the various other committees are doing likewise and although all are busy men they are cheerfully and freely giving their time and their valuable services in order to make the loan worthy of Prince Edward Island. It is gratifying to note that they are succeeding and present indications are that the allotment for the province will be oversubscribed. The people of the province, intending investors, will greatly facilitate the work of the canvassers and of the chairmen if they act promptly, give the application without unnecessary delay and otherwise give what assistance they can by directing the canvassers to prospective investors.

The loan offers a splendid opportunity for investment and every dollar that can be spared should be invested in it.

### CIVIL SERVANTS' PAY

The Civil Servants east of the Great Lakes are urging upon the government the necessity of increased pay and are presenting a petition to the government claiming their right to such increase. Up to April last the Civil Servants east of the Great Lakes were receiving \$180 each less than was paid to men in similar employ west of this point. Recently the government granted a temporary war bonus of \$250 to all Civil Servants east of the lakes and \$200 to those in the west. This still leaves the eastern members \$130 each less than their western brethren. The present demand is made in order to have the salaries east and west equalized. The ground upon which the western men at the out-

set received the higher wage was that the cost of living in the west was much higher than in the east. Since then conditions have changed and the cost of living is fully as high here as in the western provinces. In proof of this the Labour Gazette estimates the cost of food in the west at \$11.31 as compared with \$11.34 in the east.

The Civil Servants Association very properly consider the discrimination unfair and are appealing for adjustment, claiming their right to an increase of \$130. Their demand appears to be well founded and we have no doubt the government will give it favourable consideration.

### MILITARY SERVICE HARDSHIPS

A valued correspondent directs the attention of the Guardian to hardships caused in many cases by the uncertainties connected with the Military Service Act. A man, for instance, probably the only remaining son on the farm is called upon to report for service on a certain date. He may or may not be granted exemption. If he were sure that he would be drafted he would make his arrangements accordingly; if he were sure of exemption he would make his plans for next year's farming. As it is, owing to the uncertainty he can neither plan for continuing the work, engaging others to do it or to sell his property. This is our correspondent's complaint.

The conditions are hard doubtless in many cases and this is attributable wholly to the number of applications, many of them from slackers, for exemption.

All men in the 20 to 22 class had their exemption cancelled by an Order in Council on April 20, 1918. The Registrar has no option in the matter. He must call upon all of this class to report for duty on a certain date regardless whether they are the only remaining son or whether one, two or more brothers are serving at the front. These men on reporting are examined by the Medical Board. If found to be in a category lower than A they are granted leave of absence for thirty days subject to confirmation by the Registrar, who issues an exemption certificate with the condition attached "until the services of men in your category are required." When, if ever, the services of these men are required they must report for duty. If the man is in category A the only course open to him is to apply to the officer in charge of the depot for leave of absence. This application is forwarded to the Military authorities at Ottawa for

their decision. It may happen that the last son, even the son of a widow, having no brother or brothers at the front, may be taken, those in authority considering that the separation allowance is sufficient to offset the material loss to the farm or the home.

Men who have been exempted on physical grounds who were in categories lower than A, are not likely to be called upon to serve. Nor is it probable that the services of men in categories B, C and E will be required and these men are free to plan their farm work or accept any employment.

Men on farms of ages between 22 and 34 who have been exempted up to a certain date will be given a re-hearing this fall before the County Court Judges when consideration will be given to the different circumstances such as indispensability on the farm, the fact that other members of the family are on active service or any other circumstances that may bear upon the case.

Those men exempted as farmers are not required to reappear before the County Court Judge unless their case has been appealed by the public representation.

Permission to change occupation temporarily may be given to men who have been exempted as farmers or in other necessary occupations, on application to the Registrar.

There are doubtless uncertainties in the case of these conditional and temporary exemptions, doubtless certain cases of individual hardship but wherever possible these circumstances are taken into consideration. Bona fide farmers are reasonably sure of exemption when applied for and although it legally can only be granted temporarily, without incurring any risk, be regarded as permanent.
