TURKISH DESTROYER IN AEGEAN SEA

(Canadian Press) ATHENS July 5.—Athens papers publish despatches from Chios Island, in the Aegean sea, that a Turkish destroyer, on July 3rd, bombarded and captured a Greek sailing ship transporting refugees to Usion. The same destroyer proceeded to Gouli Island and bombarded and destroyed a monastery. According to despatches fishermen at Tchesme, a sea port of Asia Minor, opposite Chios, declared they saw the captured transport but without passengers whom they alleged the Turks drowned.

EMPEROR JOSEPH'S PROCLAMATION

(Canadian Press) VIENNA, July 5.—Emperor Francis Joseph in an official proclamation to the army and navy today says "we bow in our grief to the inscrutable will of the Almighty who has demanded an immeasurable sacrifice from me, my forces and the fatherland, nevertheless I do not abandon the hope of a prosperous future and am convinced that in every trial by which we may be visited the Monarchy will find a sure refuge in the devotion ever onto death of those Auto Hungarian forces whose loyalty cannot be shaken."

HUNDREDS FAREWELL DUKE OF CONNAUGHT

(Canadian Press) QUEBEC, July 5.—H. R. H. the Duke of Connaught, accompanied by Captain Farquhar left this afternoon for St. John's, Nfld., for Newfoundland, where he will spend nearly three weeks. Hundreds of people lined the Dufferin Terrace to see the farewell departure which was accompanied by much ceremony.

SUFFRAGETTES AT IT AGAIN

(Canadian Press) EDINBURGH July 6.—Suffragettes took advantage of the visit today of King George and Queen Mary to prepare its usual Suffragette demonstration in which the bombardment of the Royal couple with suffragette literature was a feature. The women obtained possession of a balcony in a house opposite the station. As the Royal carriage emerged they threw down the suffragette appeals. Two detectives seized them spoiling their aim. Some handbills fluttered into the street and the Royal carriage passed over them. The King looking up saw the women struggling in the arms of officers. They were removed to the Police Station. The crowd along the way was giving a mixed reception, cheers with hooting. Among the missiles was a paper ball containing a message to show King George that the women are being persecuted for defending their freedom.

AVIATOR FALLS TO TERRIBLE DEATH

(Canadian Press) LOS ANGELES, July 5.—Arthur Rylitsky, the San Francisco aviator was killed yesterday when his aeroplane was caught in an aerial above the canyon. The machine swept into a pine forest on the mountain side and the spectators could hear him crying out. He fell to the ground through the trees and was frightfully mangled.

SUPREME COURT IN CHARLOTTETOWN

The Supreme Court resumed at the Charlottetown Court House yesterday morning at eleven o'clock. The first case called was that of the King v. J. A. G. Ellis, who is charged with having intimidated detectives Elrod and Valade in connection with the prohibition cases in which he was concerned. The defendant did not appear in Court, and the Attorney-General, Hon. J. A. Mathieson, in moving that his bail be estreated, stated that there were special circumstances in connection with the case which he would like to bring to the attention of the Court. On June 9th, three convictions were obtained against the defendant before Stipendiary Magistrate, for violation of the Prohibition Act, one for a first offence, for which he was fined \$100, the other for treating on the premises, for which he was fined \$20 and costs, and the third for a second offence against the Act, in respect of which he was fined the sum of \$200. The Magistrate issued warrants of commitment in all three cases. One constable was deputed to execute the warrants in regard to the first two cases, while another constable was assigned the issue of the warrant in the other case. The defendant was arrested on the first two charges and paid \$120 under protest. On Saturday the constable served the paper for the second offence, calling for payment of a fine of \$200. Ellis refused to pay and was arrested. He was taken to King's County Jail. On the 19th, ten days after his conviction, the Magistrate was informed that it was the intention of the defendant to apply for a writ of certiorari. The application was made on Friday last. Mr. A. A. McLean, K. C., for the defendant, said he understood that when the convictions were made the fines were to run concurrently. He did not know until Saturday night that Ellis was in jail and would not be in Court yesterday. The man was in jail and in the custody of the Crown and he could be more secure than he was. In the circumstances his absence was fully justifiable and bail should not be estreated. The Attorney-General agreeing, the matter was held over until this morning, when the defendant will appear in Court.

THE DEEGAN CASE. When the Ellis case was postponed until this morning, the Chief Justice directed the Clerk to call the cases on the Civil Docket. The Clerk thereupon called the case of James Deegan and others against Michael Deegan—an action of debt to recover the sum of eight thousand dollars; Mr. Stewart, K. C., for the plaintiffs and Mr. Johnston, K. C., for the defendant. When this case was called Mr. Stewart, for the plaintiffs, rose and stated to the Court that this was the action on which the defendant, Deegan, had been arrested last December, and held to bail for eight thousand dollars and about which a certain newspaper published in Charlottetown had made some strong reflections on the plaintiffs and had intimated that the defendant would commence pro-

TELEPHONE COMMUNICATION WITH MAINLAND OPENED

Premier Mathieson at Charlottetown Converses With Premier Sir Robert Laird Borden at Halifax. Charlottetown Citizens Have a Chat With Halifax Friends. Line Formally Opened for Business and Cable Proves Splendid Success Conversation Being Carried on With Ease.

The new cable recently laid between Wood Island and Caribou was formally opened for business at nine o'clock last evening when Premier Mathieson called up Sir Robert Laird Borden, who is at present visiting in Halifax, and thanked him for what his government had done in placing this telephone service between the Island and the Mainland. Sir Robert replied in a few well chosen words and spoke of the good that must inevitably result from such communication, after which the line was declared formally opened. In the course of the conversation which followed, Premier Mathieson, on behalf of the Confederation Jubilee Committee, extended a hearty invitation to Sir Robert and Lady Borden to be present at the celebration to which Sir Robert replied that he would make every effort to come, but in the event of this being impossible he would see that some member or members of the cabinet would attend.

A SAD DROWNING CASE AT GEORGETOWN

Mrs. Harold Croucher, of Georgetown, met her death by drowning on Sunday afternoon in circumstances painfully sad. She was with her husband at the end of McDonald and Westaway's wharf, he sitting and she standing by his side. In some unaccountable manner she fell over: her husband heard a splash and to his horror saw his wife struggling in the water at his feet. He immediately jumped in to her aid and held her up for some minutes, but she seized him with a death grip around the neck and was taking him down when a man threw him a rope. This he grasped and by means of it was drawn to the wharf, completely exhausted, being an indifferent swimmer.

Further help arrived after a time, and Mr. Ewart Keeping, who could see the body of the woman lying in about ten feet of water, dived in an attempt to bring her up. This he failed to do. Eventually Rev. Mr. Smith, the Anglican minister, came up in a boat and the body was brought to the surface by means of grappling hooks. It is estimated that Mrs. Croucher was in the water for eight to twelve minutes. Artificial respiration was immediately commenced under the direction of Dr. G. L. Barnes who witnessed the accident from a distance. After three hours' hard labor, resuscitation was found to be impossible. Life was extinct. Mrs. Croucher was of a weak constitution or doubtless she would have recovered. It is thought that she fell overboard after taking a weak turn. An "inquest was held yesterday morning before Mr. Scobie Johnson, J. P. Mrs. Croucher was formerly Miss Bertha Arsenault, of Summerside, and she and her husband have been residing in Georgetown for only a comparatively short time. In fact, they were married only a year ago, and the deceased lady was only 21 years of age.

TRIP TO AMERICA AND EUROPE IN ONE DAY

WASHINGTON, July 4.—"Breakfast in America and dinner in Europe," is not only an aviation possibility but a probability, Dr. Alexander Graham Bell, telephone inventor, stated today. Through the National Geographic Society he predicted success of cross-Atlantic flights, without, however, commenting directly on the "American" project of Glenn Curtiss and Lt. Cyril Porte. "There can be little doubt that any ordinary machine, able to support itself in the air at an elevation of two miles, will attain a speed of 100 miles an hour in the direction of Europe in a single day," said Dr. Bell.

THE WEATHER THE TEMPERATURE TIDE MOON, ETC.

(Special to The Guardian.) TORONTO, July 7th.—Maritime: Fair and warm, followed by local showers in the southwest portion. THE WEATHER.—Yesterday was the warmest day experienced so far this summer. It was a perfectly fine day, continuing clear and beautiful all night. The highest temperature registered yesterday was 80 deg. above zero, the lowest the previous night being 57 deg. above. At 9 a. m. yesterday, it was 66 deg. above; at 9 p. m., 63 deg. above. The tide will be high this morning at 9.31 and tomorrow at 10.26; it will be high tonight at 11.29 and tomorrow at 12. The sun sets this evening at 7.53 and tomorrow at 7.52; it rises tomorrow morning at 4.18 and Thursday at 4.18. The moon rises tonight at 8.37. The last quarter of the new moon was on Tuesday, June 30th, at 3.25 p. m. The moon will be full on Tuesday July 7th at 3.32 a. m. The length of today will be fifteen hours and thirty-four minutes.

ANOTHER TURN IN HINDU QUESTION

(Canadian Press.) VANCOUVER, July 6.—The immigration authorities won before the Court of Appeal the Singh Tet Test Case, covering the Komagata Maru's passengers. The Court today unanimously upheld the validity of the Dominion Order in Council respecting the prohibition of entry of Aliens not direct from the land of their birth, not having \$200 and being laborers. The officials having acted under these Orders in Council can therefore proceed to deport the rest of the Komagata Maru passengers who fall in the same category. It is not known if Hindus will appeal. The Komagata Maru gang will not permit five marooned Hindus to get back on the vessel. The Japanese Consul on a rope-ladder today and the Consul gave him an ultimatum. It is proposed to play a steam jet on the Hindus from the neighboring vessel if they resist the efforts to place the five back on the boat.

MINISTER PRAISES P.E.I. MILITIA

The Hon. Col. Sam Hughes, Minister of Militia, who a few days ago visited and inspected the Militia camp in Charlottetown, in an interview with a Halifax Herald representative, spoke in the warmest terms of the camp at Sussex and of that at Charlottetown, from which he had just come. "Over in the Island," he said with evident pleasure, "they have formed a squadron of cavalry at Summerside. This was only two weeks ago, but it was present at the camp in Charlottetown in good force. (Canadian Press) BIRMINGHAM, July 5.—The body of the late James Chamberlain, arrived at Birmingham from London Sunday afternoon. A floral offering from Mrs. Chamberlain in the form of a cross was placed on the coffin. Tremendous crowds awaited the cortege at Highbury and deep emotion was manifested as the coffin containing the body of the great statesman passed.

GENERAL HUERTA FAVORITE CANDIDATE

MEXICO CITY, July 5.—Elections for President, Vice-President, Deputies and senators were held Saturday in that portion of the Republic controlled by the Huerta Government. In Mexico City there was also complete absence from voting and the utmost indifference as to the outcome. Huerta appeared to be the favorite candidate for President and General Blanquet the present War Minister for Vice-President.

GREAT BRITAIN DID NOT PRESS UNITED STATES

(Canadian Press.) LONDON, July 4.—A flat denial that Great Britain brought pressure to bear on the United States in the matter of the Panama Canal tolls issue was given at a banquet tonight of the American Society, by Viscount Bryce, former Lord Ambassador to Washington. Lord Bryce said he advised his Government, that if the President thinks it right, to appeal or to go to arbitration. He will do it. He said the United States always wanted to do what was right.

ANOTHER LOAD OF HINDUS COMING

VANCOUVER, July 4. From a semi-official source which has on other occasions been correct, was learned today that a second steamer Hindus aboard left Hong Kong yesterday. A cable which came through private sources of London was to this effect. The second steamer is bringing all her passengers from Calcutta so that they may fulfill the requirements that immigrants must come from the land of their origin. It will be more than three weeks before this party can reach Vancouver.

PASTORS DEPLORE FORCIBLE FEEDING

(Canadian Press.) LONDON, July 6.—Rev. Reginald J. Campbell, pastor of the City Temple; Rev. R. F. Horton, pastor of Lyndhurst road Church, Hampstead; Rev. J. H. Shakespeare, prominent non-conformist minister, sent a letter to Premier Asquith appealing to him to put a stop to the forcible feeding of suffragette prisoners. The writers declare the employment of forcible feeding as barbarous, cruel, disgusting, and that regarded as degrading it has proved futile. "We regard it as a dangerous and exasperating element if they continue and in the present deplorable state of affairs cannot stand silently by and see Parliament adjourn possibly over a period of many months while forcible feeding is going on in English prisons. We assure you the growth of public bitterness and resentment over it among otherwise peaceable, law-abiding women is the greatest social danger of our time."

BODY FOUND AT PORT HILL

On Saturday evening last, while Mr. Daniel McAuslin, Northam, was walking on the shore of the farm of Mr. David Ramsay, Port Hill, he came across the body of a man which had come ashore. Mr. McAuslin notified Mr. Ramsay and other neighbors and they decided not to remove the body until the coroner had been notified. On Sunday morning Dr. John Jardine, Coroner, Summerside, viewed the remains and decided that an inquest was unnecessary. The body was that of a man apparently about 45 years of age, was about 5 ft. 8 inches in height and weighed about 170 lbs. He was clean shaven and of a dark complexion. He was no doubt a fisherman, although not dressed as if engaged in fishing. He wore heavy underwear, a dark-blue shirt and dark trousers and vest, but no coat, and wore a pair of light work shoes. A pocket knife and comb were found in the pockets; also a piece of paper with writing on same, but which could not be made out. There was nothing else whatever to go towards identifying the body. The body was somewhat decomposed and was thought by the Coroner not to have been long in water but several days on shore. The Coroner gave a permit for burial and Mr. Hubert Phillips, Undertaker, took charge of the body and on Sunday evening the remains were interred in the cemetery of St. James' Episcopal Church, Port Hill.

WOMAN WITH REVOLVER ARRESTED

LONDON, July 4.—A well dressed woman with two revolvers in her pocket was arrested late last night at the gates of Buckingham Palace, where she demanded entrance, and insisted on seeing King George.
