Mrs Donald McQuarrie died this morning, after a two weeks' illness, at the home of her daughter, Mrs E. B. McIntyre, on Locust street. The deceased would have been 82 years of age February 2nd next, and death was due to the infirmities of old age, following a period of ill health extending back seven years. Miss Matilda Stuart was born at Prince Edward Island, Canada, and was the daughter of Donald Stuart, member of the Canadian Parliament, and a prominent citizen of the Island. Mr Stuart, who was a member of the famous and ancient Stuart family of Scotland, and was born in Glasgow, as was his wife. Their daughter Matilda, who was the last of her race, was given exceptional opportunities and was a graduate of Prince of Wales College, Charlottetown, Prince Edward Island. In the same city Miss Matilda Stuart became the bride of Donald McQuarrie, himself of Scotch descent. Twenty-five years ago Mr and Mrs McQuarrie went to Yankton to reside and here, thirteen years ago, Mr McQuarrie died. Mrs McQuarrie has always lived a quiet home life and was not much known outside of the circle in which she moved. Among her acquaintances, she was most highly esteemed, as a dear old lady of the old school, and of a type now so rare. Of great refinement and polish, most highly educated, and with the strictest yet kindest standards of living, Mrs McQuarrie was a treasure in the home. She retained her faculties almost to the last, and with a memory and hearing both remarkable, she was able to turn her abilities to account with those near and dear to her. Mrs McQuarrie had outlived all of her own generation and had buried her husband, as stated. She leaves a large family, as follows: Mrs E. B. McIntyre and Mrs Clarence Vanderhule, daughters of this city; Mrs Ed Anderson, and David, of Slouk City, sons. There are also three other daughters, Mrs M. Glover, of Longmont, Colo.; Mrs F. A. Inman, and Mrs M. Raynor, of Nine Mile Creek, P.E.I. The relatives will have the heartfelt sympathy of their many friends in this community in the loss of a mother very dear to them for her many good qualities, and years of devotion to her family, in a most beautiful life.

The funeral took place from the E. B. McIntyre home, Rev F. V. Stevens, officiating.—Yankton Press and Dakotan, Nov 29.

In Summerside yesterday dealers were paying twenty-five cents a dozen for eggs; eight dollars and fifty cents a ton for loose hay; four dollars and fifty cents for straw, twenty-five cents per bus for potatoes; forty to forty-one cents per bus for oats and eight to eight and three quarter cents per lb for pork.

The death occurred on December sixth at North River of Malcolm McKinnon, an aged and widely known resident of that place. The deceased was a gentleman had been in poor health for the past few years but nevertheless he exceeded the allotted three score and ten. Alberton dealers are paying thirty seven cents a bus for white oats and thirty-eight cents for black; twenty-one cents a doz for eggs, twenty cents a pound for butter; nineteen cents a bus for potatoes, ten cents a lb for hides; eight to ten and three-quarter cents a lb for pork; ten cents for turpicks and eight dollars a ton for loose hay.

The following are the city market prices:—Pork per lb, nine cents; potatoes per bus, twenty-five to twenty-eight cents; black oats per bus, forty-two cents and white per bus, forty-two cents and loose per cwt fifty to fifty-five; straw pressed per ton, fifty-five to six and loose per cwt thirty cents; butter per lb twenty-one to twenty-six cents and eggs per doz twenty-five to thirty.

McNeill has a nice bunch of pullets six months old, on his own raising, that are now laying lots of eggs. The Dr thinks they are hard to beat.

About ten days ago Augustine Blackier of Summerside was stricken with paralysis and continued in a very low condition until early yesterday morning, when he passed peacefully away at the age of fifty-two years. He leaves a widow and three small children. Mr Blackier spent some years in California. For the past ten years he has been employed by the P. E. I. Railway and was a good and faithful workman. The funeral will take place at nine a.m. today.

Among the shipments by the Empress Saturday night, which was delayed in Transit at Summerside till Monday, owing to the western train having left before the arrival of the Empress, was a handsome black fox, billed to M. R. Leard, Alberton. The Pioneer says: There was a new importation, in the "shape" of a black fox, passed through Summerside Monday. There have been quite a number of "real" foxes arrived in this province during the past year. Also quite a number have been exported. The fox business is not a new business in this Province.

The tide of the 30th was the highest ever known in the East. Little Harbor Beach was covered with many feet of water and the breakers rolled in on Andrew Morrison's field, some thirty never before seen. A fish house, some dories and many lobster traps were destroyed there. The south end of Red Point lobster factory is wrecked.—South Basin Bridge was covered with a foot of water, and the road round the Basin was covered to Joseph Ching's fence.—At North River two fish houses were carried away with their contents.—Priest Pond Bridge was also covered with water.

It seems probably that many years will pass before an author receives a higher price for his literary product than Commander Robert E. Peary receives from Hampton's Magazine for his own story of the discovery of the North Pole. This feature cost Hampton's a clean, cool \$50,000. No rate per word is specified in the contract, but it is generally estimated that Commander Peary is receiving \$1.18 cash for each word that he writes for Hampton's magazine. Ben B. Hampton, editor of the magazine, makes this statement: "If you have a desire to estimate the rate per word that will be earned by Peary with his North Pole story, you would be safer in placing it at \$2.50 per word than \$1.20. We have bought only American and Canadian magazine rights, and Stokes' book rights cover only these countries. That leaves all the foreign rights to sell. When they are figured up, the total should amount to \$100,000 or even \$150,000. "Peary is not a good business man. As a matter of fact, he is a poor man. Mrs Peary has been the business head of the family, and the Commander never loses an opportunity to praise her for the manner in which she had labored and borne the brunt of his quarter of a century of work in the Arctic. Peary and Mrs Peary have sacrificed their material comfort to this Arctic ideal. Every dollar they could spare from actual living expenses has been used to equip expeditions, so that when Peary returned a few months ago, there was mighty little money in the Peary bank account.

And, Whereas, certain preachers styling themselves, "Go-preachers," "No Church," "No Sect," "The Jesus Way," etc., have been holding forth in the rural districts throughout the province. And, Whereas, the said preachers are bringing the gospel ministry into ridicule by their criticisms and aspersions on clergymen in general, fermenting discord, strife and factionism among otherwise so much harm to our young people. Therefore, Resolved, that we consider it our bounden duty to warn all our people against entertaining and aiding in any way these so-called evangelists who are doing great harm to the cause of true religion among us.
