

RESULTS OF U.S. ELECTIONS

(Canadian Press) NEW YORK, Nov. 3.—The Evening Sun concedes the election of Mitchell for Mayor. It says Tammany suffered a severe setback if not routed. Sulzer, it concedes, has been elected as an assembly man from the sixth district. The Evening Mail claims the election of Mitchell by over 75,000.

THE STRUGGLE IN CHINA

(Canadian Press) PEKING, Nov. 4.—The struggle between the Chinese parliament and President Yuan Shi Kai was brought about by the drastic action of the President which, in the opinion of many, will have a serious effect on parliamentary government. Lengthy presidential proclamations were issued at midnight expelling the Kwo Ming Tang party, numbering more than three hundred members from parliament.

ENORMOUS GROWTH OF POSTAL REVENUE

(Canadian Press) OTTAWA, Nov. 4.—The postal revenue figures for the seven months of the fiscal year show an increase of over half a million as compared with returns for the corresponding period in 1912.

CHIEF WEIGHMASTER FOR THE DOMINION

(Canadian Press) OTTAWA, Nov. 4.—Jas. Graham, White, Winnipeg, has been appointed Chief Weighmaster for Canada with headquarters at Port William. The duties of his position are general supervision of grain weighing.

MICHAELMAS TERM OF SUPREME COURT

The Michaelmas Term of the Supreme Court for Queen's County was opened at the Court House, Charlottetown yesterday morning, with their Lordships Chief Justice Sullivan and Justices Fitzgerald and Haszard on the Bench.

COURT OF APPEAL AND EQUITY.

Arthur Gordon and others, appellants v. Henry Gordon and others, respondents—an appeal from the judgment of the Vice Chancellor, Justice Fitzgerald. The case arose in the course of the administration of the estate of James Gordon, decd., and with regard to which two bills were filed; in one bill Henry Gordon, the complainant was in his capacity as administrator of the estate as well as in his own right as one of the heirs at law and next of kin of the deceased, the defendants being also heirs at law and next of kin of the deceased.

PRINCE EDWARD ISLAND'S CASE As Represented At Interprovincial Conference.

Following is a précis of the special case on behalf of Prince Edward Island, presented to the Interprovincial Conference on the question of Representation in the House of Commons: When this Province entered Confederation, it was allowed six representatives, though on a basis of population solely it would only have obtained five.

FISHERY DEPARTMENT FOR NEW ZEALAND

(Canadian Press) OTTAWA, Nov. 4.—Prof. Prince the Fisheries expert of the Marine and Fisheries Department has postponed until spring his visit to New Zealand whither he goes at the request of the government of that country to advise with reference to the formation of a fisheries service. The desire is to have a department of fish protection and culture based upon that of Canada.

MR. HAVILAND MR. PALMER.

"Prince Edward Island would rather be out of the Confederation than consent to this motion. We would have no status, only five members out of one hundred and ninety-four would give the Island no position."

COLONEL GREY

"I am instructed by my co-delegate to say that the provision of five members is unsatisfactory." At the following session of the Legislature of Prince Edward Island held in 1865, the Quebec Resolutions were discussed. These Resolutions provided: "17. The basis of Representation in the House of Commons, shall be population, as determined by the Official Census every ten years; and the number of members at first shall be 194, distributed as follows: Upper Canada..... 82 Lower Canada..... 65 Nova Scotia..... 19 New Brunswick..... 15 Newfoundland..... 8 and Prince Edward Island..... 5"

HON. MR. HENSLEY

"The terms of the report before us are, in my opinion, very unfavorable to this Island. On the scale of representation proposed, we would be without the slightest influence in the United Parliament. It is true that, if we went into the proposed Union, we would have no right to expect as large a number of representatives as either of the Lower Provinces, but then why should we throw away the independence which we now enjoy?" (Debates P. E. I. Legislature, 1865, p. 50, et seq.)

MR. HOWLAN

"Representation by population might be very well for Canada herself, but in a general Union of the Colonies, it would operate injuriously for the Maritime Provinces, as they could not expect to protect their interests when they would have to content with 100 of a clear majority over their own representation. This principle would give the city of Montreal with its 101,000 inhabitants one representative more than this Island. Quite different is the representation of Great Britain, for while London has about the same population as Scotland, that city has only 16 members in the House of Commons, while Scotland has 53. But it may be argued that as our population increased our representation will increase. This is very doubtful. Indeed, under the operation of the 20th and 21st clauses of the Report it seems probable that we might lose our representation altogether. Lower Canada is always to have 65 members, and the representation of the other Colonies is to be arranged every ten years so as to give each the same ratio to population as she will then possess. Now should the population of Lower Canada increase more rapidly than that of this Island, which is almost certain to be the case, our representation would decrease, and we would be left perhaps without a member at all.

BISHOP FOLEY HAS JUBILEE

DETROIT, Mich., Nov. 4.—Twenty-five years ago today the Rev. John Samuel Foley was consecrated bishop of the Roman Catholic diocese of Detroit and the anniversary of from dignitaries of the church and laymen arrived in large number at the residence of the bishop, but owing to the advanced age of the distinguished prelate no public celebration was held. Tomorrow Bishop Foley will celebrate the eightieth anniversary of his birth in an equally unostentatious manner. Bishop Foley was born in Baltimore November 5, 1833, and graduated from St. Mary's College in that city in 1850. He continued his studies and three years later was admitted to the minor orders by Archbishop Kendrick. As he was too young for the priesthood, Archbishop Kendrick sent him to Rome for further studies and there young Foley was ordained priest by Cardinal Patrizi in 1856. In 1888 he was consecrated Bishop of Detroit.

LIBERAL MAJORITY IN BRUCE REDUCED

(Canadian Press) WALKERTON, Nov. 3.—The official count in the bye elections of South Bruce has reduced the majority of Truxar, Liberal, to 124. The Conservatives are considering protesting the election.

INOCULATING FOR TYPHOID

(Canadian Press) TRINIDAD, Col., Nov. 4.—A general order to inoculate every member of the Colorado National Guard to render them immune from Typhoid fever was put into effect today. Several companies were exposed to the disease at Ludlow Tent Colony where five cases developed among the strikers within the last few days.

The Presbytery of Prince Edward Island met at St. James Hall yesterday morning with a fair attendance. Rev. W. H. Spencer, was appointed Moderator pro tem, in the absence of the Moderator, Rev. D. B. McLeod.

At the afternoon session a scheme of visitation was submitted by Rev. H. J. Fraser, for the purpose of informing congregations throughout the province with reference to the growing financial demands, the success attending the various activities of the church compelling a growing expenditure.

In the absence of Rev. George Miller and Rev. G. A. Sutherland, who had been appointed to present the budget to the congregations of St. James and Zion, Rev. Dr. Fullerton addressed the meeting calling attention to the increased allocations for 1914. Each of these congregations is asked to contribute \$125 to the scheme of the church.

TO INVESTIGATE PRISON CONDITIONS

(Canadian Press) KINGSTON, Nov. 4.—G. M. MacDonald, Chairman, stated today that members of the Prison Reform commission will leave on the 13th of November to visit the prisons of the United States. They are going to Stillwater, Minn., Mansfield, Ohio, and Concord, N. H. The commission will be the end of the month or possibly early in December before the commission resumes session again. In addition to the evidence of more convicts the Commission will yet hear charges referred against H. Begg assistant overseer of the penitentiary hospital.
