De Valera May Not Push Bill

LONDON, April 26—(Canadian Press Cable)—The political correspondent of the London Morning Post today said members of parliament in close touch with the Irish situation believed President Eamon De Valera of the Irish Free State does not intend to force passage of his bill abolishing the Oath of Allegiance to the Crown through the Dail Eireann.

The newspaper said Mr. De Valera is anxious the Free State should not be excluded from the Ottawa Imperial Economic Conference, and added "notes he received recently from the Dominions indicate they might not be backward in formally expelling the Free State from the Empire if he, himself, made the first move in that direction. Therefore it is considered likely he will endeavour to delay the final stage of the bill till after the Ottawa conference."

Western Wheat Farmers Optimistic

WINNIPEG, April 26—Western wheat farmers smiled optimistically today and took new heart as spring rains across the prairies continued for the third successive day. Further precipitation was reported in Alberta, Southern Saskatchewan and parts of Manitoba.

Conditions in the Calgary area, hitherto wracked for three days, are gradually returning to normal. Extra gangs were busy at work today in an effort to straighten out the tangled mass of communication lines levelled by the storm.

Bill To Reduce N. S. Legislature Gets 2nd Reading

HALIFAX, N. S., April 26—(By The Canadian Press)—The Government redistribution bill, reducing the number of seats in the Nova Scotia Legislature to 30 from the 38 provided for in the 1929 measure, and the 40 presently constituting the House, was given second reading "on division" late tonight. Sixteen speakers, nine from the Opposition and seven from the government side of the chamber, made the bill the object of attack and defence through afternoon and night sessions. Premier Gordon S. Harrington closing the debate. The measure carried when Opposition Leader A. S. Macmillan's motion to give it the hoist was declared lost.

In the same breath, the Premier said, Opposition members had charged the government with "political expediency" in introducing the bill, and had declared it was defective in administration. This was strikingly inconsistent, he thought.

"Even if I knew this bill was going to defeat us, I would rather lead my Government to defeat than hold office by the Gerrymandering that was carried on here under former administrations," he declared. The bill was an honest attempt to give suitable representation. Under its provisions the Government lost five members and the Opposition three.

Housing Commission Of Nova Scotia Ready To Act

HALIFAX, N. S., April 26—(The Canadian Press)—Appointment of a commission of five members "to enquire fully into and concerning housing conditions in the province of Nova Scotia" is provided for in a bill introduced in the legislature today by Dr. G. H. Murphy, Minister of public health.
