Toronto Runner Wins Marathon From Big Field

Dave Komonen, Wins American Marathon Title From Field Of Best Distance Men In Eastern States.

WASHINGTON, June 18.—A lean, tireless runner from Toronto, tonight had maintained his reputation as the most consistent marathoner in the North American continent. Dave Komonen, former Canadian National champion, who came home with a \$40 automobile carrying with him the emblem of the United States Amateur Athletic Marathon championship he won Saturday.

Re-organization City Ball Loop

Same Teams Comprise League As Last Season, Falcons, Stars And Rovers — First Game Tuesday Night.

CORNWALL, Ont., June 18.—For the first time since the trophy was offered for competition in 1925, Captain J. R. Cornelius' Hamilton Central Collegiate track team was compelled yesterday to surrender the Sir Arthur Currie Cup, emblematic of the Dominion Intercollegiate Track and Field Championship, into the hands of their traditional rivals from Ottawa, Glebe Collegiate.

Claiming points in almost every track and field event on the senior card, Bob Campbell's Glebe stalwarts built an aggregate of 30 points, as compared to 23 collected by Hamilton Central. Ottawa Glebe were also awarded the Cornwall Legion Cup, offered to the school obtaining the highest aggregate in all classes.

They had 36 points, with Hamilton Central second with 28.

Asked by Counsel for defense, what condition the prisoner was in at the time, witness replied, he seemed as though he had been drinking.

Alex. McDonald, (sworn), corroborated the evidence of previous witness as regards the time and place of the death of deceased; also that he heard the prisoner say to the corpse "You dirty old — you will steal no more wood from me" and other like expressions.

Later prisoner was in the kitchen and made some remarks to Mrs. Reeves and he took him by the shoulder and took him outside.

This closed the case for the Crown. There was no evidence for the defense.

Mr. J. A. McDonald, K. C., then addressed the jury for the Crown.

In opening Mr. McDonald said: The law with all due foresight has provided a section in the Criminal Code which says that anyone is guilty of an indictable offense who "unproperly or indecently interferes with or offends any indignity to any dead human body or human remains, whether buried or not."

This is the charge in the case and is a most unusual one, in fact to my knowledge has never occurred in any province in Canada before, and the jury verdict will be of interest all over the Dominion.

Mr. Thane A. Campbell, K. C., Counsel for defense, in his address stressed the importance of the Crown establishing a guilty intent before a conviction can be made.

He also pleaded that the prisoner was so crazed with liquor that he was as a man insane and his mind so obscured with drink that his reason was dethroned so that he was incapable of forming any criminal intent.

Mr. J. A. McDonald, K. C., in rebuttal said that the fact that the prisoner has a grudge against the deceased showed criminal intent, and if he was so crazed with drink that he did not know what he was doing why did he return to apologize, furthermore being drunk was no excuse.

In his charge to the jury, His Lordship said this is a very important case. Counsel for the defense has pleaded that the man was intoxicated and therefore not responsible for the crime charged. How far one may be intoxicated so that he cannot commit a crime is not for the jury's consideration. Counsel had drifted away from the main elements of the case. His Lordship then read the evidence. "You are asked," he said, "to excuse conduct such as I have just read to you, because the man was so crazed with

Records Smashed In U. S. Inter-Collegiate Meet

Four New World Records Established By College Stars — Canadian Ties For First In High Jump

CHICAGO, June 18.—Four new world records, certified by the ruling bodies of international sport, tonight had been set up by college stars of the United States. Two others were tied and seven records for the 12-year-old meet were outmoded in the United States Intercollegiate Track and Field Championships held under flood lights at Soldier's Field Saturday night.

On the strength of a 14-foot pole vault in a pinch by tall Matthew Cordys, Louisiana State University defeated the University of Southern California for the American title.

The record-breaking was rushed into the background when the pole vault, last event, was called upon to determine whether the Trojans, champions of both coasts, or a gallant little band from Louisiana was to take the title.

Leading most of the way, Louisiana State sent Gordys into the pole vault with a lead of four points over Southern California, 49 to 45. Bill Graber, the world record holder, shot over the bar at 14 feet, and Gordy's mates implored him to match it. Gordy did, in perfect form, leaving the pair in a tie which defied their further efforts but protecting the southerner's lead and giving them victory, 58 to 54.

Charles Hornbostel of Indiana made record-book history with a 1:50.9 half-mile bettering the accepted mark.

Ralph Metcalfe, Marquette Negro, ran a faster furlong than any yet recorded in 20.4 seconds.

Glenn Hardin of Louisiana State, after running a 47-1 quarter-mile for a new meet record, dashed over the low hurdles for a mark of 22.9 which bettered the accepted world record.

Jack Torrance, another member of the winning team, added about two inches onto the world shot put record, heaving the ball 52 feet, 10 inches.

Metcalfe's century of 9.4 seconds and a blazing high hurdle race by Gus Meier of Stanford in 14.2 seconds equalled the existing best marks.

Duncan McNaughton, Canadian Olympic high jump champion of Vancouver, representing Southern California, tied for first place in the high jump with Vincent Murphy of Notre Dame, at six feet, four inches, which was not up to the best performance of either.

There have been no cases in Canada, that we can find, but an English case, as far back as 1788, was found. This case was not on the same lines as this; none can be found just like this. Putting the blow aside, to use such abusive language to a corpse is beyond all common decency. The case in England was where a body, guilty at this session.

a safe guard; when this fails, the law must step in, as in this case. The prisoner, Mr. Strong charged, had come into a house of mourning and offered insults to the corpse of Thomas McArthur. He was removed but returned again about noon. The daughter wanting to have things as decent as possible remonstrated with him but he continued his abusive language.

Annie Reeves, wife of Mr. Preston Reeves of Coleman, was the first witness. She testified that she was the daughter of the late Thomas McArthur, that he died on March 21st at his home in Port Hill. That he was 80 years of age at that time. He passed away at 6 a. m., March 21st. In the house at the time was Mr. McArthur, his widow, Mrs. Williams, a neighbor and others.

The prisoner came in some time during the morning. He came in a sleigh, unhitched the horse and came into the house.

He went in to see the corpse with Mrs. McArthur. The corpse was in the coffin in the parlour.

The undertaker, Hubert Phillips, Tyne Valley, sent the breast plate for the coffin and I (the witness) went in to put it on. The prisoner and Mrs. McArthur had returned to the kitchen.

"I placed the plate on the casket and was standing looking at father's remains, when I felt a hand on my shoulder. I looked round and saw it was the prisoner.

"I went to the other side of the coffin," Prisoner said, "old Thom looks great" I replied, "He looks pretty nice." The prisoner then slapped his face and called him "The dirty old black son of a —"

BIG FIELD READY FOR CH'SHIP MEET

(C. P. Cable)—With the greens lightning fast over weeks of dry weather, a big field of domestic and overseas stars are all set for the British Amateur Golf Championship's starting Monday over the famous Hoylake Links, lengthened to 6,853 yards for the title fray.

C. Ross "Sandy" Somerville of London, Ont., the United States Amateur Champion, leads a band of seven Canadians into the title tourney. Among the field are the present champion, Johnny de Forest, and the runner-up last year, Eric Fiddian; Br'g-General A. C. Critchley formerly of Calgary, who is French Amateur Champion; three from the United States including Walker Cup Player George Dunlap; Cyril Tolley, great British amateur who has twice been champion; Roger Wethered and Eric Martin-Smith, also former champions. Andre Vagino, four times French champion and a host of others who bring the total to 269 only two below 1930's record.

Somerville, one of the favorites to win the title first instituted in 1886, has been playing the Hoylake Links for nearly a week with a considerable measure of success. He shattered par by five strokes to go around the course brilliantly in 67 a few days ago. Friday he teamed with Br'g-Gen. Critchley to defeat that noted pair, Tolley and T. A. Torrance, last year's British Walker Cup Captain, two and one in a four-ball match.

Two rounds of 18-holes each will be played daily until the 36-hole final on Friday. Somerville and the bulk of the field however, go directly into the second round, only 28 players starting the first round. They include two of the Canadians, Jack Nash of London and W. F. Wiseman of Windsor, drawn against each other.

thing was satisfactory he took to the air again and flew for a short time to the east of the airport. While several hundred feet off the ground he banked steeply as if about to return.

Just as the turn was being completed the nose of the machine was seen to drop rapidly and it crashed in an open field about two miles south of the aerodrome. Martin had no chance to escape as the aeroplane burst into flames at once.

"Barney" Martin was well-known not only in Montreal but throughout Canada as the pilot of the auto-gyro machine which gave numerous exhibitions, as a member of the trans-Canada Air Pageant of 1931 and as an air mail pilot. He was only 33 years old and was born in Nottingham, England, where his father still lives.

Pilot Martin received his commission when he was 17 years of age, and saw service in the Royal Air Force in Italy during the War. At the conclusion of the war he became an instructor in the Nottingham Aero Club. Subsequently he came to Canada, and served as a pilot in the Canadian Airways on various routes. Three years ago he flew on the Montreal to Moncton mail route on the Trans-Canada service. He later served on the Toronto-Detroit run.
