McDonald Will Tell Of Conference With Dominions

(British United Press.)
LONDON, July 11.—Quite unexpectedly the Foreign Office issued a statement announcing the result of the consultation of the British Premier with the Dominion High Commissioners regarding representation of the Allied conference, Macdonald will announce the full nature of the arrangements in the Commons Monday.

The Premier is most anxious to avoid another Lausanne controversy and does not wish to give his parliamentary adversaries the opportunity to attack him for enlarging on the dominion participation in the foreign policy of the empire. He will probably suggest that representatives from the dominions active part in the discussion expressing their views through him. Where responsible dominion ministers are available of course the situation will be somewhat different.

Itself procuring teachers and in having catechism taught after school hours in places where it is forbidden to be taught during school hours, that representation on school boards by well qualified Catholic women, in numbers proportionate to the Catholic population, be secured.

She recommended that the League interest itself in seeing that school and district nurses are efficient, discreet and, where numbers justify it, Catholics be appointed. That Catholic parents and Catholic children are accorded equal privileges in regard to free attendance and medical inspection; that every local subdivision form a committee to procure for poor children necessary and decent clothing and books for attending schools; and that each branch establish a scholarship for domestic science and that the national league plan for national scholarship to be competed for during the coming year by Catholic women graduates of Canadian colleges.

which there were four young pups, the four were gone on a clean sweep. In pen No. 16, foxes belonging to Mr. Black, there were five young ones and two of them were gone. One, four and two, seven foxes in all, he says, that were in the ranch on Saturday night. The circumstances now link up one after another until they clearly, to your mind, fasten the accused to the crime. And no matter how long the chain of circumstances may be, if the links are unbroken, he is bound, and a Jury will convict him. But no matter how short the chain if a link is missing, then the absence of that link is fatal to a verdict of guilty. You are to keep that in mind, gentlemen, as your guide when you come to consider those circumstances.

We have reached this point; assuming that the goods were stolen; assuming that the stolen goods were in possession of the prisoner; the question is, has the prisoner given a reasonable account of how he got possession of them. That carries you into the Mermaid region, into the alleged den where those foxes were found. You gentlemen were there and you saw the ground, and you know vastly more than I do about it; I shall say nothing about the testimony of I will call your attention however to one strange circumstance that you will have to consider and deal with when coming to your final determination. You will have to consider it and you will have to deal with it; gentlemen, your oath will require that. Those foxes disappeared between Saturday night and Sunday morning, and about the same time the prisoner claims that he found those foxes at Mermaid; foxes about the same age and evidently young silver black foxes and he got them, he says, on Saturday night there was a telephone conversation between him and Mary McEachern who lives at Mermaid, a young girl to whom he is engaged, and the defence sought to bring out evidence of that conversation when the telephone and they were not allowed to do so, and frequent efforts were made to get at it as if it were a matter of importance and a matter of right, I will tell you this; not only was it not a matter of right, but clearly they had no right to attempt to ask a question. I think of what was proposed to be given, evidence of what the prisoner and Mary McEachern said to one another. It does not matter whether it was said by him or whether it was said by her, whether it was a hundred miles away and transmitted by a line. The rule of evidence is that no such conversation in such circumstances can ever be given in evidence. And you gentlemen will see the reason why, that it would be an open for Mary McEachern to come on the stand and in the defence say "the prisoner told me this and told me that, and told me all kinds of things," and it would open this road, that any person preparing to commit a crime and that one and all his friends and stories that he thought would be favorable to himself, and the next day he commits the crime and he brings before the Court all those people to whom he has told those tales—brings them in and puts them on the witness stand, each one to tell what he had said, and he harvests a whole crop of falsehoods that he himself has sown abroad among those witnesses. Don't you see gentlemen how utterly it would destroy the whole foundation of the administration of justice if it were allowed to be given in evidence? What that does not matter now. They had a conversation over the telephone and the evidence is that by reason of that conversation they both met at 6 o'clock the following morning, Sunday morning, at Solomon Mutch's. Now for that purpose? It was not open to disclose what their conversation was, but the joint purpose they had in going there was wide open to be explained. And was it explained? I am putting this before you, gentlemen as one of the problems that you will have to deal with in a way, and will not develop it as to its consequences. Gay left Charlottetown early in the morning, he says. He got out there opposite Solomon Mutch's about six o'clock and this young girl had gone in her light shoes on the road, on the 3rd of May, two miles at that most unusual hour in the morning to meet this man, Solomon Mutch's gate, and then to drive back home with him. I do not know that I can help you by any further reference to the evidence, but I will say this, gentlemen, that having gone through the case carefully, with that sense of

responsibility that every good man and true must have who finds himself upon the jury, bound by the jurymen's oath to apply the best intelligence he has; if you are able to come to a conclusion that satisfies your conscience, if you are satisfied that the evidence against the prisoner is entitled to the benefit of that doubt. Now a reasonable doubt is a hard thing to define, but perhaps it may help some by explaining what it is not. A reasonable doubt is not a mere guess. It is a conviction that means that with the very best application you can give, you are still uncertain; that there is something here that keeps you from coming to a satisfactory conclusion. Your conscience is the safest guide in such a case that you can have, but every doubt, based upon your reason and your conscience, and you cannot conquer that doubt, and it stands there in your mind; in such a case as that the prisoner is entitled to the benefit of that doubt.

You are gentlemen, in an difficult position as any man can stand, and I would like that every citizen of this country should realize that there is no harder service than the service of a jurymen who is conscientious and determined to do that which is right to the best of his ability. If you are free his mind of all former impressions he must purge his mind of all reports and of every attempt at influence; he must free himself so far as he possibly can, from the consideration of everything except what is brought before him in Court on oath, and that to reach his determination of now gentlemen there may be other matters to which I should draw attention but I feel that it is not necessary to wait for any further consideration on my part. I think you are prepared to deal with the case and do what is right and seeing the attention that you have given, the sincere and constant attention, I am sure that whatever verdict you may bring in will be the best of which you are capable and will be the best which not only the jury as a whole, but every individual jurymen has been able to contribute toward the final result. If it should happen, I don't think it will in this case, but if it should happen that you require any further instruction upon points of law, or there is a question as to what the evidence was, and you desire to have that evidence read to you, you can have it done. It will be necessary for the foreman to send word and then for the jury to come in, to receive the instruction or have the evidence read whichever it may be; that you may do and you may do it just as often as you think it necessary in order to enable you to reach a true verdict.

Many believe that the Dominion government has promised to reimburse the losers. Otherwise P.E.I. would suffer from bad advertising and deceptive land schemes and agents under government sanction.
