THREE MEN INJURED YESTERDAY

was not satisfactory; it should be under government supervision. At the same time prices were low. But the companies said the price was as high as could be paid.

The net earnings of the fishermen employed by the five "high-line" or high-earning companies in Lockport for seven months, Sept. 1, 1933 to April 1, 1934 was \$190, said Captain Knickle.

Most of the South Shore fishermen were on relief, paid by the towns.

"Where do the towns get the money?" asked Mr. Young.

"They borrow money that'll never be paid back," said Captain Knickle.

Lunenburg town council had voted to borrow \$40,000 last year to assist a quarter of the citizens who were on relief.

There were still four firms buying fish and they continued to pay taxes.

"I see," said Mr. Young. "You get back your money in taxes."

"Yes," said Captain Knickle. "Would it be possible to have statutory grades for fish products?" asked Mark Senn (Cons. Haldimand).

"I think so."

"Would it be feasible?"

"I don't see why it shouldn't," was the reply.

"Have you evidence to show that fish bought here are sold for other purposes?" asked Mr. Senn.

"Yes," was the reply, that was commonly known.

"What do you think a fisherman's income ought to be to give him a decent standard of living?" asked D. M. Kennedy (U. F. A. Peace River).

"I think \$80 a month would satisfy him."

But that depended on the size of the fisherman's family. The children of fishermen had a right to an education. At present they left school and went fishing at the age of 12.

The merchants to whom the fishermen sold their fish were prosperous, Capt. Knickle said answering a question by the chairman.

If the merchants in the fishing business were prosperous why were there not more merchants in the industry? questioned chairman Kennedy.

All the available sites had been taken up, and it was well nigh impossible to get these dockage sites, replied witness.

On the complaint of low prices, Capt. Knickle filed petitions from the Lockport and Lunenburg areas signed by 500 captains, officers and crews.

The petition from the Lunenburg area asked for: abolition of the beam trawler; continuation of investigation on price spreads; appointment of a Dominion minister of fisheries who would give full time to the industry; appointment of a board under a minister of fisheries to see that the price of haddock would not fall below three cents per pound and maintain a comparatively reasonable price for other fish. The petition from Lockport alleged there was a combine among buyers; big buyers paid a smaller price than the smaller buyers; fishermen had to pay too high a price for herring bait and a board should be appointed to maintain a minimum price for fish.

Answering committee counsel, Capt. Knickle said complaint was made of no competition in the prices offered to fishermen who had to take the prices set by the buyers in the district.

Replying to Sam Factor (Lib. Toronto Northwest) witness said he had sold fish at 1 3/4 cents per pound, in the morning and it had cost him 18 cents on the afternoon of the same day buying from a retailer.

Capt. Knickle presented a petition by primary producers urging the setting up of a central board of control for the purpose of removing the hardships being suffered by the fishermen. This body should give the fullest consideration to the maintenance of minimum prices.

President A. Hanlon of the United Maritime Fishermen residing at Canso, N. S., was the next witness.

The organization had a membership of 2,000 and covered the area from the banks of the Maritime Provinces to the Magdalen Islands.

Mr. Hanlon gave the commission a historical review of the fishing industry in Canso. Twenty-five years ago there were 40 vessels operating out of that port and selling their catch to five small companies. Gradually, however, these companies

became merged until only two of the Maritime Fish Corporation and Leonard Fisheries had remained.

These companies employed beam trawlers which had operated in the North Bay—west of Cape Breton—for about nine years. At the end of that period, however, the haddock had disappeared from that fishing ground. Mr. Hanlon blamed the trawlers for the disappearance of the fish.

This had necessitated the trawlers seeking other grounds. Other trawlers from the United States, France and Great Britain operated in the same waters now as the Canadian ships.

He urged the abolition of the Canadian trawler in the hope that other countries might be prevailed upon to follow suit.

"Has the question of the beam trawler been taken up with the League of Nations?" asked Mr. Factor.
