him 20 or 30 cases of canned lobsters in October or November of the same year, with permits.

The first witness to give evidence yesterday afternoon was Major D. H. Sutherland, Halifax, chief fisheries supervisor for the Maritimes, who explained in detail the protection department on Prince Edward Island. He said the province was divided into five districts, under five inspectors with J. J. Larabee of Charlottetown serving in the capacity of acting supervisor.

District one is in charge of Inspector C. R. Palmer, Roseville; district two is under the direction of Inspector P. C. Martin, Summerside; district three under Inspector O. C. Shaw, Charlottetown; district four under P. A. McLellan, Souris; and district five under Inspector L. C. Johnston, Murray River.

Patrol Activities

Major Sutherland explained that there were 7 boats engaged in patrol work in 1936, two boats owned by the Department, the F. D. B. 1 and the F. D. B. 2, while five boats were chartered for patrol work and the "Gilbert", another Department owned boat was on duty for a time as was the Department cruiser "Arlex."

The chartered boats were the "Langholm", owned by Howard Clark, as captain; the "Tracadie", owned by J. H. Watt, with John J. McIntyre captain; the "Velo", owned by Reuben Betts, with Reuben Betts as captain; the "Seaview", owned by Keir Mann, with Keir Mann as captain; and the "No", owned by T. H. Allen, with Hector Campbell as captain.

In addition to the inspectors and the patrol boats, three temporary guardians, Wilfred Shea, Waterford; Fulton Cook, Cape Wolfe; and R. W. Squirebriggs, Miscouche, were on lobster protection duty last fall.

A detailed report of prosecutions on Prince Edward Island for last year as well as previous years was also submitted by Major Sutherland and showed that in 1936 there were 30 prosecutions for violations of the lobster regulations in 1936, 12 prosecutions in 1935, 38 in 1934 and 33 in 1933. While there were no prosecutions for violations of the smelt regulations in 1936, there were 19 in 1935, 5 in 1934 and none in 1933.

Another detailed report of confiscations of lobster equipment from 1933 to 1936, was also presented by the witness and revealed that in 1936 there were 8,456 traps seized and destroyed, 3 illegal canning plants seized as well as 323 cans of lobsters. In 1935 there were 5,394 traps destroyed, 1 car and 3 illegal canning plants seized as well as 72 tins of canned lobsters, while in 1933 there were 9,258 traps seized, 3 illegal plants located and seized, as well as 14 cans of lobsters, 3 boats and 1 sealer and in 1933 there were 7,966 traps seized, 4 plants located, 1 boat seized and 1 case of empty cans.

With legislative action completed, Finance Minister Auriol announced the law will be published in the official journal Friday. Bonds for the loan then may be issued.

The government also announced the interest rate on two-year national defence bonds already outstanding will be lowered tomorrow from 4-1/2 to four per cent.

Children's Aid Society Holds Monthly Meeting

The regular monthly meeting of the board of management of the Children's Aid Society of Prince County was held in the Town Hall on Tuesday evening, the president, Dr. J. A. McPhee, presiding. The report of Louis R. Wedge, agent and truant officer, showed that nine children ranging in ages from eight to ten years had been up before the juvenile court charged with petty thefts during past month. In some cases, the goods had been sold by the children and it was felt by the Society that the receivers should be prosecuted by the town authorities. An effort is being made to have two of these children sent to an Industrial School, and one other to live with a farmer in the country as a ward of the Society.

The truant officer also reported that he had received some second-hand clothing from citizens which he used to good advantage, but called for same if notice is left at the Town Office. The community chest had supplied twelve pairs of boots and rubbers to enable children to attend school last month, and altogether the sum of \$91.43 had been expended by the community chest for footwear for children during the winter. The officer also found during the past month forty-one absentees from school. Of these, seventeen were home on excuses of various kinds, twelve from sickness, nine from lack of clothing and three were truants. He complained that children leaving the school used the sidewalk which was a dangerous practice, and some effort should be made to educate the children to use the sidewalks and avoid accidents.—S.

(C.P. by Guardian's Special Wire) OTTAWA, March 10.—From two of its independent minds the House of Commons today heard an attack on the United Kingdom trade agreement and a proposal for an immediate attempt to solve Canada's railway problem.

William H. Moore, Liberal member for Ontario, who jumped over party trades yesterday and voted with the opposition against the budget, and Hon. H. H. Stevens, member for Kootenay East, who two years ago resigned from the Conservative Government to found and lead the Reconstruction party, were the star performers in the budget debate today.

Mr. Stevens' Complaint

"We play the game of politics but don't play the game of the people," said Mr. Stevens as he charged the House was neglecting to settle the country's problems.

"Public confidence in parliament has waned," Mr. Stevens declared. "Scarcely a problem is brought here but it is met with the stock answer that it was not within the ambit of the Dominion's jurisdiction under the British North America Act.

"Parliament is becoming a mere collecting agency for postoffice and custom returns, and payment of some pensions.

If the year of war was totally removed there would be a great decrease in the trade for which the Government was claiming credit. There were numerous decreases in exports, which Mr. Stevens listed.

A feeling of unrest was prevalent throughout the Dominion, Mr. Stevens declared. Plight of the fishermen gave rise to feeling of unrest in the Maritime Provinces, and the same feeling persisted across Canada.

On the railway problem Mr. Stevens proposed appointment of three joint committees of the Senate and the House of Commons, one to consider co-ordination of railways, one the rights of labor and the third elimination of politics. Next he would have a special session of parliament in the autumn to receive reports of the committee and deal exclusively and fearlessly with the problem.

Mr. Moore said he was opposed to the Empire Trade Pact on principle and also on practical grounds. It was a bad bargain for Canada and Conservative Leader Bennett had been wrongly accused of driving a hard bargain with England in 1932.

His fundamental objections, however, were to economic imperialism as represented in the agreement and to making tariffs by treaty without opportunity for proper study by a tariff board or by members of parliament representing the people who would be affected.

Such a practice was a departure from Liberalism, he said.

Since the empire agreements were made Japan had reached out for an Asiatic empire, said Mr. Moore. The Japanese were seeking expansion and the closing of a wall around the British Empire did not help deter them from expansion by force.

Mr. Moore mentioned three mandates he considered the Liberal party assumed when it won the

in fact he said he never knowingly purchased illegal goods.

He said that he was not suspicious of any fisheries officers issuing permits for illegally canned lobsters.

The witness said that several years ago, his firm had some trouble with lobsters exported, and he felt that these might have been illegally packed, but that after that they had always bought any of any they were suspicious of.

Mr. Fisher said that in 1932 the pack of lobsters was decreasing each year and said that in 1932 around 40,000 cases were packed on Prince Edward Island, while last year there was only about 24,000 cases packed.

"Are you of the opinion that the illegally packed lobsters have an effect on the price of legally packed lobsters?"

"Yes. Most certainly."

"Would you pay the same price for illegally packed lobsters as you would for legally packed lobsters?"

"No; they are an obstruction to fair business."

He was of the opinion that the permit system for the transportation of canned lobsters was of considerable assistance to the buyers.

Questioned as to how long illegal fishing and illegal packing had been carried on throughout Prince Edward Island, the witness replied "I am only about 50 years of age, so I couldn't tell you."

"In other words, you are not old enough to express an opinion?"

"No; I don't think so."

Mr. Fisher said he did not think the moving of the line separating districts 7 and 8 from Chockfish in New Brunswick and Carey Point River in Prince Edward Island would be of much assistance in stopping the "poaching" of lobsters, but added that he felt a spring season all over the two districts would be the remedy.

Mr. Hornby's Evidence

The final witness of the afternoon was J. J. Hornby, also of Charlottetown, who said that he was engaged in the buying and exporting of canned lobsters for about forty years. He said that he never purchased lobsters without a permit for their transportation since the permit system was established, but that he had bought cases of canned lobsters in practically every month of the year. The witness said that he had persons come to him offering him canned lobsters without a permit which he refused to buy. Some of them later returned with a permit, but he said "Once I refused that ended it, I did not buy them."

"Do you feel that the illegal fishing and canning of lobsters in this province is getting better or worse?" asked Hon. Mr. Bridges.

"It is getting worse, from what I have heard."

He said that years ago he had considerable trouble with canned lobsters, in that he had purchased and exported the goods to Europe and they turned out to be cans of mutton and beef, and said that this was one of the reasons he wished to avoid handling any illegally packed lobsters.

"Do you think that some illegally packed lobsters have been transported within this province under legal permit?"

"Yes, I think that is possible."

"Why?"

"Well, when you see a man's warehouse practically empty at the end of the season and later have him offer you a quantity of canned lobsters, that is grounds of suspicion."

"You know that for a fact?"

"Yes, sir, I purchased the lobsters in October or November he offered me."

"Who was the man you refer to?"

"After a bit of hesitation, Mr. Hornby said 'Chester McCarthy of Tignish.'"

"What year was that?" asked the Commissioner.

"It was in 1935 or 1936."

"How many cases did you buy?"

"Twenty or thirty cases."

"How did you know his warehouse was practically empty at the end of the spring season?"

"I was at the warehouse and could see for myself."

If the year of war was totally removed there would be a great decrease in the trade for which the Government was claiming credit. There were numerous decreases in exports, which Mr. Stevens listed.

A feeling of unrest was prevalent throughout the Dominion, Mr. Stevens declared. Plight of the fishermen gave rise to feeling of unrest in the Maritime Provinces, and the same feeling persisted across Canada.

On the railway problem Mr. Stevens proposed appointment of three joint committees of the Senate and the House of Commons, one to consider co-ordination of railways, one the rights of labor and the third elimination of politics. Next he would have a special session of parliament in the autumn to receive reports of the committee and deal exclusively and fearlessly with the problem.

Mr. Moore said he was opposed to the Empire Trade Pact on principle and also on practical grounds. It was a bad bargain for Canada and Conservative Leader Bennett had been wrongly accused of driving a hard bargain with England in 1932.

His fundamental objections, however, were to economic imperialism as represented in the agreement and to making tariffs by treaty without opportunity for proper study by a tariff board or by members of parliament representing the people who would be affected.

Such a practice was a departure from Liberalism, he said.

Since the empire agreements were made Japan had reached out for an Asiatic empire, said Mr. Moore. The Japanese were seeking expansion and the closing of a wall around the British Empire did not help deter them from expansion by force.

Mr. Moore mentioned three mandates he considered the Liberal party assumed when it won the

Lobster Fishery Inquiry Opens

in fact he said he never knowingly purchased illegal goods.

He said that he was not suspicious of any fisheries officers issuing permits for illegally canned lobsters.

The witness said that several years ago, his firm had some trouble with lobsters exported, and he felt that these might have been illegally packed, but that after that they had always bought any of any they were suspicious of.

Mr. Fisher said that in 1932 the pack of lobsters was decreasing each year and said that in 1932 around 40,000 cases were packed on Prince Edward Island, while last year there was only about 24,000 cases packed.

"Are you of the opinion that the illegally packed lobsters have an effect on the price of legally packed lobsters?"

"Yes. Most certainly."

"Would you pay the same price for illegally packed lobsters as you would for legally packed lobsters?"

"No; they are an obstruction to fair business."

He was of the opinion that the permit system for the transportation of canned lobsters was of considerable assistance to the buyers.

Questioned as to how long illegal fishing and illegal packing had been carried on throughout Prince Edward Island, the witness replied "I am only about 50 years of age, so I couldn't tell you."

"In other words, you are not old enough to express an opinion?"

"No; I don't think so."

Mr. Fisher said he did not think the moving of the line separating districts 7 and 8 from Chockfish in New Brunswick and Carey Point River in Prince Edward Island would be of much assistance in stopping the "poaching" of lobsters, but added that he felt a spring season all over the two districts would be the remedy.

Mr. Hornby's Evidence

The final witness of the afternoon was J. J. Hornby, also of Charlottetown, who said that he was engaged in the buying and exporting of canned lobsters for about forty years. He said that he never purchased lobsters without a permit for their transportation since the permit system was established, but that he had bought cases of canned lobsters in practically every month of the year. The witness said that he had persons come to him offering him canned lobsters without a permit which he refused to buy. Some of them later returned with a permit, but he said "Once I refused that ended it, I did not buy them."

"Do you feel that the illegal fishing and canning of lobsters in this province is getting better or worse?" asked Hon. Mr. Bridges.

"It is getting worse, from what I have heard."

He said that years ago he had considerable trouble with canned lobsters, in that he had purchased and exported the goods to Europe and they turned out to be cans of mutton and beef, and said that this was one of the reasons he wished to avoid handling any illegally packed lobsters.

"Do you think that some illegally packed lobsters have been transported within this province under legal permit?"

"Yes, I think that is possible."

"Why?"

"Well, when you see a man's warehouse practically empty at the end of the season and later have him offer you a quantity of canned lobsters, that is grounds of suspicion."

"You know that for a fact?"

"Yes, sir, I purchased the lobsters in October or November he offered me."

"Who was the man you refer to?"

"After a bit of hesitation, Mr. Hornby said 'Chester McCarthy of Tignish.'"

"What year was that?" asked the Commissioner.

"It was in 1935 or 1936."

"How many cases did you buy?"

"Twenty or thirty cases."

"How did you know his warehouse was practically empty at the end of the spring season?"

"I was at the warehouse and could see for myself."

Patrol Activities

Major Sutherland explained that there were 7 boats engaged in patrol work in 1936, two boats owned by the Department, the F. D. B. 1 and the F. D. B. 2, while five boats were chartered for patrol work and the "Gilbert", another Department owned boat was on duty for a time as was the Department cruiser "Arlex."

The chartered boats were the "Langholm", owned by Howard Clark, as captain; the "Tracadie", owned by J. H. Watt, with John J. McIntyre captain; the "Velo", owned by Reuben Betts, with Reuben Betts as captain; the "Seaview", owned by Keir Mann, with Keir Mann as captain; and the "No", owned by T. H. Allen, with Hector Campbell as captain.

In addition to the inspectors and the patrol boats, three temporary guardians, Wilfred Shea, Waterford; Fulton Cook, Cape Wolfe; and R. W. Squirebriggs, Miscouche, were on lobster protection duty last fall.

A detailed report of prosecutions on Prince Edward Island for last year as well as previous years was also submitted by Major Sutherland and showed that in 1936 there were 30 prosecutions for violations of the lobster regulations in 1936, 12 prosecutions in 1935, 38 in 1934 and 33 in 1933. While there were no prosecutions for violations of the smelt regulations in 1936, there were 19 in 1935, 5 in 1934 and none in 1933.

Another detailed report of confiscations of lobster equipment from 1933 to 1936, was also presented by the witness and revealed that in 1936 there were 8,456 traps seized and destroyed, 3 illegal canning plants seized as well as 323 cans of lobsters. In 1935 there were 5,394 traps destroyed, 1 car and 3 illegal canning plants seized as well as 72 tins of canned lobsters, while in 1933 there were 9,258 traps seized, 3 illegal plants located and seized, as well as 14 cans of lobsters, 3 boats and 1 sealer and in 1933 there were 7,966 traps seized, 4 plants located, 1 boat seized and 1 case of empty cans.

manufactures which Australia required. On the other hand principal Australian exports, such as butter and cheese, were competitive with Canadian products and there was no scope of any increased quota for Australia was limited.

Children's Aid Society Holds Monthly Meeting

The regular monthly meeting of the board of management of the Children's Aid Society of Prince County was held in the Town Hall on Tuesday evening, the president, Dr. J. A. McPhee, presiding. The report of Louis R. Wedge, agent and truant officer, showed that nine children ranging in ages from eight to ten years had been up before the juvenile court charged with petty thefts during past month. In some cases, the goods had been sold by the children and it was felt by the Society that the receivers should be prosecuted by the town authorities. An effort is being made to have two of these children sent to an Industrial School, and one other to live with a farmer in the country as a ward of the Society.

The truant officer also reported that he had received some second-hand clothing from citizens which he used to good advantage, but called for same if notice is left at the Town Office. The community chest had supplied twelve pairs of boots and rubbers to enable children to attend school last month, and altogether the sum of \$91.43 had been expended by the community chest for footwear for children during the winter. The officer also found during the past month forty-one absentees from school. Of these, seventeen were home on excuses of various kinds, twelve from sickness, nine from lack of clothing and three were truants. He complained that children leaving the school used the sidewalk which was a dangerous practice, and some effort should be made to educate the children to use the sidewalks and avoid accidents.—S.
