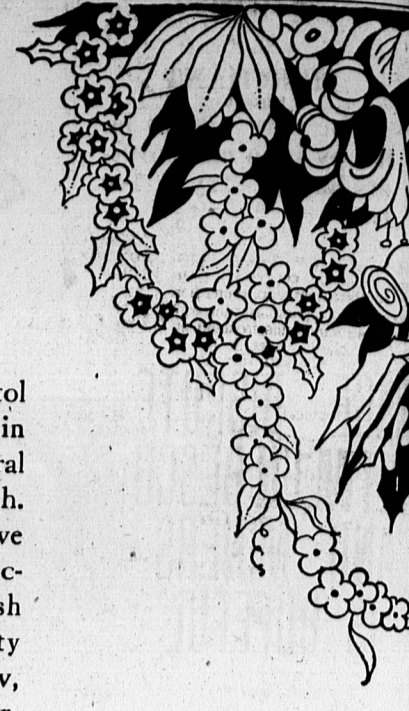

LONDON, Feb. 2.—A strange story of a rich girl's thefts while being entertained at the home of a friend has recently been told at Wealdstone.

In the dock was Catherine Barnes, aged 24, a smartly dressed girl of prepossessing appearance. She admitted stealing a diamond ring worth \$600 and a lady's woollen dress value \$12.

The girl's father is manager of a large mine near Johannesburg, and she came to England two years ago to study at the Royal Academy of Music.

She passed her final examination there on a Monday, after being in custody at Wembley since the previous Saturday.

At the Academy she became friendly with a fellow-student, and stayed at the house of her friend. Later the dress and ring were missed. To a detective Miss Barnes said, "I can't think what made me do it."

The prisoner, did not lack money, for she had an allowance of \$125 a month from her father, and received additional sums from him but from some sudden temptation, she took the ring and the dress.

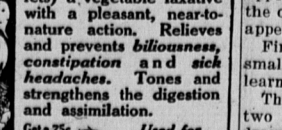
