NEGOTIATIONS IN BRITISH MINERS STRIKE ARE ENDED

Demand for Settlement of the Dispute is Spreading. Summer-like Weather Minimizes the Physical Inconveniences of Coal Scarcity.

LONDON, April 29.—Negotiations are at an end, announced Sir Robert Horne, in the House of Commons today in reporting on the mining dispute. As to the future, no useful predictions can be made. He continued, we can only hope that the stoppage which is now disclosed to the public for a political object may soon be terminated. This conclusion of Sir Robert's remarks came amidst cries of nonsense from representatives of the miners among the members. Meanwhile the demand for the settlement of the dispute is spreading. The summer-like weather is minimizing the physical inconvenience of the coal scarcity but the public seeing the theatres owing to slack business, the railway and street cars running on skeletonized schedules and the lighting services cut to the minimum, is becoming apprehensive.

An Airplane Found Loaded With Booze

ISAVANNAH, G. A. April 29.—A commercial airplane, loaded with slightly quarts of liquor but minus a crew was found peacefully resting on the municipal landing field, yesterday. Nobody knows where it came from or when it arrived, and state officials were puzzled what to do with it, though they promptly seized its cargo. The state Prohibition Act does not cover confiscation of bootlegging aircraft. Probably the machine had come from Cuba, officials said, and finally they decided to dismantle it and store it in the police barracks pending determination of its ownership.

PROCEEDINGS IN THE PROVINCIAL LEGISLATURE

MORNING SESSION, April 26th

The Commissioner of Public Works tabled answers to questions asked by Mr. McNeill with respect to road projects. Mr. Butler presented the report of the committee on printing and binding Journals. Two tenders for this work had been received, one from Mr. C. B. Murley, the other from the Patriot Publishing Company. Some delay having arisen with previous reports published by Mr. Murley, the tender was given to the Patriot Publishing Company though in this case Mr. Murley's tender was the lowest.

HON. MR. JOHNSTON moved the adjournment of the House in order to bring up an important matter with reference to the Light and Power Company Bill. The incorporation fee of \$490 asked for had been paid but there was some doubt whether the Company would desire to operate under the Act as amended. Provided the charter was not accepted he thought it reasonable that the House should refund the fee money. The partners of the Company not being present while the bill was put through, it was impossible to say whether in its altered form they would accept it.

HON. MR. ARSENAULT maintained that had the bill been withdrawn at any stage of its reading because of unsatisfactory amendments or alterations in it, the Company would certainly be entitled to a refund of the amount of the incorporation fee. But when a bill has passed its final reading and has received the Lieut. Governor's assent the House has not the right to do with it. A number of fox companies have taken out charters which were never used, but in no case has the request been made that the incorporation fee be refunded for this reason.

MR. D. C. MCDONALD thought the point raised by the Attorney General a reasonable one. He urged that a bill might be amended to such an extent that it could not be accepted by its promoters, and that in such a case they were entitled to a refund. MR. HIGGS quoted Bourinot to prove that the Attorney General's contention was not supported by precedent. He pointed out a danger in refunding the fee under the existing circumstances. Once the Lieut. Governor has given his assent to a bill, that charter has a salable value. The promoters could go on the market with it and sell stock—if the stock sold, well and good, if not, they could come back and receive the amount of their fee. He made no insinuations against the promoters of the Light and Power bill, but he merely wished to point out how dangerous a precedent the House would establish in refunding this money.

MR. LEPAGE pointed out that the bill had been brought in by suspending a rule of the House. It had been sent back to committee to be reconsidered and they had decided upon an incorporation fee of \$490 which was correct according to schedule. The bill had taken up a lot of the time of the House in travelling through committee; it was practically intact, with one notable increase in the amount of capitalization, which the House had altered from \$2,000,000 to \$3,000,000 without raising the incorporation fee.

HON. MR. NASH argued that this bill was in a class by itself, and was not to be proceeded with according to precedents established for less important measures. In order to get over the point at issue he suggested that a clause be added to the bill (as it was still in committee, having been kept standing over until the fee had been paid) providing that if the Government should go out of its way to make a position for a party neerer. "Haunted" To Death

Little Girl Dies From Meningitis After Manifestations

LONDON, April 29.—Mariel Frost, the five-year-old daughter of the occupier of Hornsey's "haunted house" in Frostone road, has died after a short illness. Death is said to have been accelerated by the strain of the manifestations reported to have occurred at her home.

For some time the child took no notice of the happenings. Then one day a chair fell over near her, and she bit her tongue. She had showed signs of extreme nervousness since.

"Since the return of my two boys the manifestations have resumed," the father said, "and so the vicar Mr. Gardiner, has taken them to the vicarage until after the funeral."

"Many people," he said, "do not believe what has been taking place in this house, but I only wish it was a dream."

Murder Penalty Paid With Life

HUSBAND EXECUTED, WIFE SERVING LIFE SENTENCE FOR CRIME, AND BABY BORN IN JAIL

OSNING, N. Y., April 29.—James L. O'Dell, 24, of Rochester, N. Y., was put to death in the electric chair at Sing Sing prison tonight, for the murder of Edward H. Knelp on January 7, 1920. O'Dell's wife, Pearl, who also was convicted of the crime is now serving a life sentence in Auburn prison. A daughter was born shortly after she began her sentence. When told that governor Miller had declined to interfere, the condemned man said: "I had a part in the crime, but I am innocent of murder. We only took Knelp out there to punish him for what he had said about my wife. We never had any intention of killing him."

ALLIED ADVANCE INTO RUHR PROBABLE NEXT WEEK

Premier Lloyd George Favors Giving Germany a Time Limit. Plans of Occupation to be Discussed by Supreme Council Today

PARIS, April 29.—Mr. Lloyd George would consent to the occupation of the Ruhr district only after an ultimatum granting a certain amount of delay had been sent to Germany, says the London correspondent of the Matin. It is declared he takes this attitude in order to appease those inclined against penalties.

Premier Bland left for London early today to attend the meeting of the Supreme Council on Saturday. He will appear before the body with the support of the French parliament, public and press which is unanimous in demanding direct action in enforcing penalties against Germany.

Scientific Research April Heat Wave

OTTAWA, April 29.—A slack House last night discussed the permanent court of International Justice to be created under Aegis of the League of Nations. For a large part of the day there had been a debate on the second reading of the Bill to authorize to create a national institute for scientific research. Sir George Foster who had the Bill in hand laid emphasis on the importance of scientific research in development of industry. It, exclaimed Sir George, Canada is to compete with other countries, more attention must be devoted to scientific and industrial research.

At the evening sitting Mr. Doherty, Minister of Justice outlined the purport of the International Court of Justice and that method of its appointment. "International Justice," Mr. Doherty declared, "is of greatest importance if peace is to be secured. Justice must be the foundation of any lasting peace. The highest interests of humanity added Mr. Rowell were furthered by men who drew up the Constitution of this court. Some opposition came from the Liberals' ranks. Suppose the court sat for months on an Asiatic dispute, queried Mr. Lucien Cannon (Dorchester), who would foot the bill. Canada did not have means for such a project.

ATTENTION OF THE POSTMASTER-GENERAL DRAWN TO LITERATURE NOW FLOODING CANADA.

OTTAWA, April 29.—An invitation which accuses the ire of both David Loughnan, editor of the Yearan, and C. Grant McNeill, Dominion Secretary of the G. W. V. A. was received by mail today. It was signed by Otto T. Schmidt and contained the suggestion that the G. W. V. A. and the Veteran should invest some money in the German state lottery. The commission pointed out that an investment of eight dollars might win a million marks, translated into Canadian money with exchange added might amount to two hundred thousand dollars. Mr. Loughnan saw the postmaster general about the matter and suggested that these advertisements for German state lotteries should not be allowed in the Canadian mails. As a result communications will be carefully sought out and barred.
