Barrel Pusher To Arrive In City Today. Burnest Heard, 23-year-old man who has rolled a gasoline barrel from Vancouver will arrive in Charlottetown sometime today, pushing his unusual contraption, it was learned last night. He has spent one year and three months on the road, leaving the western Canadian city on the 1st day of June, 1937. Since then he had travelled 4,817 miles and worn out 17 pairs of shoes, he said. His 18th pair of shoes would be purchased in Charlottetown where he plans to remain until Tuesday before returning to the mainland to continue his "barrel pushing" tour. He expects to arrive late this month, after visiting principal centres in the "Bluenose" Province.

Technical Papers Read At Convention

Delegates to the four-day, 14th annual convention of the Telephone Association of Canada were assigned yesterday by Premier Thomas A. Campbell on behalf of the province of Prince Edward Island and by Mayor E. A. Foster of the city, as they opened their convention sessions at the Canadian National Hotel.

Mr. W. A. Winfield, Halifax, replied to the speeches of welcome.

Premier Campbell smilingly told the delegates he had two pet aversions, one of them Tories, and the other telephones, for he said, the telephone very often becomes a nuisance to a man in public life.

Urges Co-operation In Labor Problems

WASHINGTON, Sept. 2—(AP)—President Roosevelt called on United States workers and their employers today to develop the same spirit of mutual confidence and co-operation which had helped solve British labor problems.

Name-calling should have no place in labor relations in the United States, Mr. Roosevelt said, nor in efforts to work out a federal law which would serve as a guide for the peaceful solution of disagreements.

The President made these statements in reply to a press conference question as to how the report of a special commission he sent to Great Britain to study employer-employee relationships could be applied to legislation in the United States.

Testimony the 61-year-old democratic ward boss accepted "mob money" in his role as alleged court fixer for the gambling syndicate came from Mrs. Rose Wendroff, 31, soft-spoken sister of J. Richard (Dixie) Davis, fallen "Kid mouthpiece" of the Schultz gang, just a few minutes before court adjourned until Tuesday.

The witness said she personally handed money to Hines—usually about \$500—four or five times between 1935 and 1935, and that June 22, 1935, her brother called her from out of town and told her: "Rose get \$500 and take it down to the old man on the 30th floor."

Both Davis and George Weinberg another Schultz hoodlum, have testified during the three-week-old trial that they referred to Hines as "the old man."

Davis at that time maintained a lavish set of law offices in the same building as Joseph Shallock, Hines' attorney.

The bank cheque was payable to "cash" and was endorsed by "J. Hines" and "Ed Holly," District Attorney Thomas E. Dewey conceded the signature of the back of the cheque apparently was not the defendant's handwriting.

Mrs. Wendroff testified she telephoned Milton Bernard, an accountant employed by Schultz, after receiving her brother's order to pay "the old man" \$500 and Bernard sent her a cheque signed by Harry Albert, an attorney.

The cheque was dated June 22, 1935, and was introduced by Mrs. Wendroff in her brother's name, J. R. Davis, before being given to Hines, she testified.

Dewey notified the court that "the people's case is rapidly drawing to a conclusion." He added, "I expect to close with a very few witnesses."

With that, the prosecution followed up testimony by Max D. Steuer, Tammany legal strategist and a friend of Hines for 30 years, that Hines was in intimate with Schultz that he sought legal aid for "the Dutchman" in his 1933 income tax troubles.

Steuer corroborated Dixie Davis' testimony that Hines tried to have Steuer intercede with United States Attorney George Z. Medalle for Schultz.

OTTAWA, Sept. 2—(CP)—W. T. Burford, secretary-treasurer of the Canadian Federation of Labor, said in a Labor Day message issued today that "there is ground for hope that out of the turmoil which foreign intrusions have visited upon the Canadian workers' organizations there will emerge a united movement."

Such a movement will be one which will be "able to play a constructive part in the solution of the problems of a great industrial movement free of entanglements and inhibitions which might hamper the strong right arm of labor in a national emergency," he said.

"No mixed allegiance to Canada, through a hybrid organization of hyphenated nationality, is worthy of Canadians. This Labor Day we workers can make no better resolution than to stand together to build and defend Canadian institutions."
