MARKETING SCHEME SUBMITTED TO DOMINION BOARD

Shipping Problem Major Question At Opening Of Maritime Board Of Trade

ROOSEVELT ASKS BANKS TO EXTEND CREDIT
Calls For Alliance Of Forces Intent Upon Business Recovery.

WASHINGTON, Oct. 24—President Roosevelt addressed to the bankers of the United States to-night something of a challenge, assuring that he expects them to supply the credit need of the country and to begin supplying it at once.

Talking to the annual convention of the American Bankers Association, he held out the promise that as quickly as the banks are able to assume their task of lending money to industry, just as soon will governmental lending activities be curtailed.

"In March 1933, I asked the people of this country to renew their confidence in the banks," he said. "They took me at my word. To-night I ask the bankers of the country to renew their confidence in the people of this country. I hope you will take me at my word."

Many who had expected Mr. Roosevelt to give some hint of his future monetary or other plans found few. He confined his talk mostly to the past and present but did look forward to a future reduction of the relief burden and to a revival of business activity.

PRICE SPREADS COMMISSION TO REOPEN PROBE

Marketing of Fish Will Be The First Subject To Receive Attention.

OTTAWA, Oct. 24—Fish, livestock marketing and packing, canning, milling and baking, textile and agricultural implement industries will be investigated by the price spreads and mass buying commission Minister of Trade and Commerce H. H. Stevens announced tonight.

Further evidence, in addition, will be submitted on the effect of mass buying by large-scale merchandising establishments. Government auditors will submit their report relative to chain store merchandising in Canada and evidence will be submitted as to the position of the consumer in relation to various questions that have arisen.

Hearings To Re-open
Public hearings of the commission will commence in Tuesday, although there will be an executive session on Monday afternoon.

In an official statement issued tonight, the Minister stated: The Price Spreads Commission will assemble on Monday next, Oct. 29, to continue the investigation of the commission of the House of Commons of last session on price spreads and mass buying.

On Monday afternoon the commission will go into its executive session and the public hearings will commence on Tuesday.

Fitzmaurice Flight Again Postponed

PORTSMOUTH, Eng., Oct. 24—A jinx dogging Col. James C. Fitzmaurice, Irish flyer, since Saturday overtook him again today, forcing another postponement of his take-off over the trail to Melbourne, blazed by the air race flyers.

Scales at the airport here, where Fitzmaurice was testing his plane preparatory to starting his flight failed to hold up under the loaded weight of his ship, and the full landing test required before United States authorities certify its airworthiness was delayed until tomorrow.

If his ship passes the test, Fitzmaurice plans to take off Friday from Lympne in an effort to better the record of 70 hours, 50 minutes and 50 seconds set by C. W. A. Scott, and Campbell Black, the British winners of the \$50,000 race.

DUBLIN, Oct. 24—An official of the Hospitals Trust, backers of Col. James C. Fitzmaurice's proposed England-to-Australia flight left Dublin today by plane with sealed orders for the flyer.

NAVAL POWERS FACE KNOTTY PROBLEM

Japanese Representatives Firm On Stand Of Equality At Opening Meeting.

LONDON, Oct. 24—The Japanese today presented their claim for naval equality to representatives of the United States, as they had done in meetings with the British yesterday.

No action was taken and no official statements were issued, but it seemed obvious that a long and knotty discussion faced the representatives of the world's three leading naval powers.

Both the British and the Americans are distinctly cool towards the sweeping Japanese proposals, so far as could be seen. They feel that the existing treaties already contain sufficient guarantees for equality in security. Japan would sweep away the existing treaties and replace them with an entirely new structure.

Unofficially both British and United States conferees intimated they were far from pleased with the Japanese proposal to divide naval armaments into offensive and defensive classes. She labels battleships and aircraft carriers offensive; cruisers large and small, destroyers and submarines as defensive. She demands recognition of the principle of equality in defensive armaments, and abolition or considerable reduction in the offensive classes.

Far From Pleased
In a nutshell, Japan is firm in determination to remove the existing ratio basis, on which naval categories of British, the United States and Japan are fixed on a 5-5-3 ratio respectively. If the other powers do not join her in abrogating the Washington Treaty, then she will arrogate it unilaterally—independently.

Board To Seek Extension Of Tuber Markets

Good Progress Made In Working Out Solution Of Potato Marketing Problem—New Grading Regulations Suggested.

OTTAWA, Oct. 24—New regulations covering the grading of potatoes are being threshed out at the conference of growers and dealers from five provinces meeting here. The regulations will likely be brought into effect under a marketing scheme and enforced by a marketing board of 11 members.

Today the delegates to the conference met the Dominion Marketing Board and submitted their proposed marketing scheme. The Board suggested a few changes mostly in the nature of the addition of certain details and the delegates met again to alter the scheme in accordance with the suggestions.

Considerable progress has been made in working out a solution of the potato marketing problem but the emergent character of the situation is causing the delegates some concern. With potato prices now at levels considerably below the cost of production they want some speedy action to secure the farmer a better return.

Potatoes in number two and number three grades would be practically barred from the market under the proposed new grading regulations. Number two potatoes would not be permitted to move in interprovincial trade nor in intraprovincial trade for sale in cities and towns. Number three potatoes would be completely barred from the markets.

The proposed potato marketing board would consist of two members from each of the five Eastern Provinces with the secretary of the Horticultural Council of Canada as chairman.

Two Minutes Silence Will Be Observed

OTTAWA, Oct. 24—The "great silence" between 11 a. m. and 11:04 a. m. on November 11 will be observed in Canada, and the Government has issued instructions to provincial and municipal authorities to arrange for suspension of all vehicular traffic during these two minutes. Railway and water transport will not be suspended.

An announcement by Secretary of State C. H. Cahan tonight declared that the King had approved of Canada's arrangements for observing the two minutes silence.

Judgment Reserved In P.E.I. Case

OTTAWA, Oct. 24—Involving an action for personal injury resulting from an automobile collision, the Supreme Court of Canada today reserved judgment on the appeal of Poole & Thompson Ltd., Charlottetown, versus Wilfred McNally, Borden, P. E. I.

The appeal heard today is against a judgment of Mr. Justice Saunders of the supreme court of Prince Edward Island, and a jury awarding \$1,500 damages to McNally.

DENIES NAZI NATIONAL CHURCH AIM

BERLIN, Oct. 24—Dr. August Jaeger, Nazi commissioner for Prussia's Protestant Churches, today roundly denied he is trying to force all Germany's faithful into one national church.

"This claim," he said emphatically, "is 100 percent untrue. Personally, I have never used the term 'national church.' The fight within the church is solely one of external order."

His denial, ostensibly meant to all the waters troubled by the Reich's newest religious storm, was in direct contradiction, however, of previous Nazi statements as to the government's intentions.

Mueller urged state intervention to unite all churches under the Reich. A similar demand had been voiced at Stuttgart by Jaeger four days before.

Flyers Held In Prison In Iraq

MELBOURNE, Oct. 25—Anxiety over the fate of John H. Wright and John Poland, United States flyers feared lost in the race to Australia, ended here today as word came from Baqra, Iraq, that they landed near the Turco-Persian border, to be shipped into prison and held overnight.

A roaring welcome to the first three arrivals in the derby had given place to fear for the two Americans, flying the smallest ship in the race, when hour after hour passed without reports from them following their takeoff from Baghdad at 10:10 a. m., G. M. T. Tuesday.
