### Deanna Durbin In "Mad About Music"

For the third time in her short career, 15-year-old Deanna Durbin triumphs.  
Less than two years ago, Deanna was an unknown Los Angeles school-girl, not even dreaming of a screen career. Her first picture established her as a child of promise, her second confirmed the promise. Her third, "Mad About Music," seen last night in the Capitol Theatre proves beyond doubt that little Miss Durbin is a genuine star, firmly established in her niche of screen fame.

"Mad About Music" is a delightful picture. It presents Deanna in a different characterization from those of her previous pictures, and in a mood and tempo entirely different. "Mad About Music" is a comedy drama. Only a few years ago she was in the most effective manner—intrude into the story of the little girl with the make-believe father and whose dreams come true.

### Italian Wins Speedboat Race Classic

DETROIT, Sept. 5 (AP)—Count Theo. Rossi of Turin, Italy, today became the first foreigner to win the 35-year-old Gold Cup that symbolizes the speedboat championship of North America when he drove his hydroplane Alagi, a small speed demon, to a three-heat victory on the Detroit River course.

Accidents, the mechanical and otherwise reduced the field of eight original nominees in the race to two in the first heat, three in the second and two again in the final. In each heat Rossi had to compete with a pair of youngsters from Oakland, Calif., Dan Arena, pilot, and Dan Foster, mechanic, of Miss Golden Gate.

Rossi clicked off the first 30-mile lap at an average speed of 63.15 miles an hour. The Californians were second, averaging 56.19 in the second heat. Rossi turned the course at an average of 66.89 miles an hour, while his two youthful opponents were reeling off 61.89. In this heat Harold Wilcox's Miss Canada III, of Ingersoll, Ont., finished with an average speed of 57.582 miles an hour. Alagi's speed for the third heat was 63.786 against the California boat's 52.420.

### Prison Warden Is Strongly Rebuked

(By BILL BELL Associated Press Staff Writer)

PHILADELPHIA, Sept. 1 (AP)—Rebuked for "ridiculous" management of the Philadelphia County Prison, Warden William B. Mills today blamed subordinates for the "baking to death" of four convicts in "sweat-box" punishment cells.

He named Guard Sergeant James Hart as responsible for turning on the killing heat and said Deputy Warden Frank Craven, knowing of conditions, should have ordered the steam shut off in the battery of radiators that lined a corridor of the "kondike" isolated building where the men were confined.

He denied all personal responsibility, Hart acted, he said without his knowledge or permission.

The Warden was the chief witness at an inquest punctuated by a spectators' demonstration when Coroner Charles H. Hensch interrupted Mills' testimony and scolded.

"You don't know how to run that prison. This is the lowest, most supported by his own party. "Aianza popular libertadora" Nazis and a dissident group of Socialists. He also has enjoyed considerable popularity among army officers.

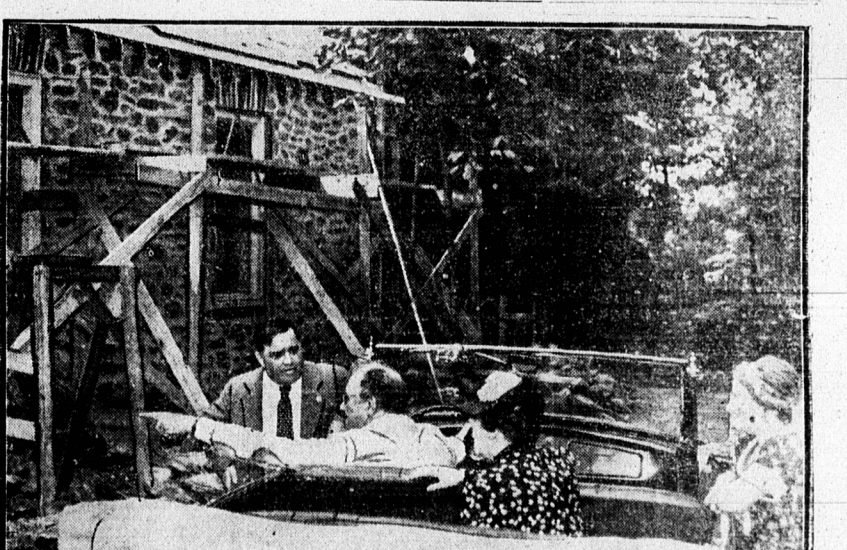
