MONDAY

Miss Wilson, head of the Red Cross in Charlottetown, who had been attending the crippled children's clinic at Summerside, remained over for a day or two. She was the guest of Miss Holman and Miss Hunt during her visit. S.

BUSY COURT—Mr. G. M. Matthews, Magistrate for Prince County, held Court at Summerside on Friday. There were a large number of cases, the sequel to some Hallowe'en doings in Miscouche and Wellington, which overstepped the boundary of mere pranks. Twenty-three cases from Miscouche and eight from Wellington were heard. The charge was for creating a disturbance. Each culprit was fined one dollar and costs. A prohibition case from Borden was heard, when a party was fined \$10 and costs for the illegal consumption of liquor. S.

FUNERAL OF MRS. JOHN MCKENZIE—The funeral of the late Mrs. John McKenzie was held on Friday. There was a short service for the family at the home in the morning and a public service in St. Mary's Church at two o'clock. Ven. Archdeacon C. de W. White officiated at both services. A large number of friends attended. "Lead Kindly Light" and "Abide With Me" were very feelingly rendered by the choir. The pallbearers were Mayor Manson, Dr. John P. McNeill, M.L.A., Mr. L. R. Allen, M.L.A., Mr. George McCullum, Mr. Peter G. Clark and Mr. Lee Horne. Interment was in the People's Cemetery. S.

The schooner Victor W. T. 75 tons, owned by Captain Dan Ferguson of Hampton, foundered off the mouth of the harbor about 8 o'clock Friday evening. The schooner was loaded with 50 tons of coal from Little Bras d'Or. She sprang a leak Friday about two p.m. and although pumps kept working they could not keep down the water. In attempting to make the harbor, she foundered in about three fathoms of water about three-quarters of a mile south of Blackpoint, about three miles from the wharves.

The captain and the other member of the crew put off in a dory and rowed into Charlottetown.

It is more than likely that the vessel and cargo will be a total loss as salvage operations are not considered advisable. The vessel was not insured, but the coal had been insured for an unascertainable amount.

Investigations will be carried on this afternoon to find out whether or not the vessel is a menace to navigation. A buoy will be placed over the spot where she went down.

On Saturday morning the C. G. S. Brant located the sunken schooner, the masts of which are above water. It was found that the craft in its present location would not endanger shipping, as she is some distance from the channel.

News of the death of Sergeant Peter Bradley will be heard with regret in the City, and throughout the whole Province. The deceased was born at South Melville, Kelly's Cross Parish, in 1845, the son of the late James Brady and Margaret McKenna, immigrants from Ireland. Sergeant Bradley spent his early life on the farm, and came to Charlottetown in 1874. He was appointed to the City Police force in 1875, and was in continuous connection with the force till 1922, a period of 47 years. In 1922, while on his way to the police office, he was thrown from a sleigh and broke a hip. Although he suffered considerably afterwards, he was able to do special police duty for several years. In 1925 he was retired on pension.

For many years Sergeant Bradley was very successful in detective work in which he was frequently engaged in various parts of the Province. Several years ago the following paragraph regarding Sergeant Bradley appeared in The Guardian:

"In his charge to the jury at the trial Thursday morning His Lordship the Chief Justice referred to 'that splendid old officer, Sergeant Bradley.' The Attorney General also referred in complimentary terms to Sgt. Bradley who has a splendid record of over forty years continuous service on the police force of this city. It is fitting that such faithful service should be recognized. The Guardian wishes Sgt. Bradley many more years of active service."

There are left to mourn five children, Mr. William Bradley and Miss Angie Bradley of this City, and three married daughters in Western Canada.

The funeral will be held on Tuesday morning at 8.45 from the Church of the Most Holy Redeemer to the R. C. Cemetery.

Informed last evening of the nature of the report of the Macmillan Commission on Banking and Currency, Premier MacMillan expressed his satisfaction, particularly with regard to the recommendations for a Central Bank and extension of short term credit to farmers. These recommendations are in line with the presentations jointly made before the Commission on behalf of the Provincial Government, Boards of Trade and farm organizations of the Province.

"The exhaustive nature of the report," added Premier MacMillan, "dealing as it does with every phase of the banking situation, should prove of inestimable value to Parliament. It is what Canada expected of the brilliant and experienced men who composed the personnel of the Commission."

In the death of Mr. John S. MacLellan of Indian River, which occurred Saturday, the 11th, the community mourns the passing of a very highly respected resident who was a loyal friend and kind neighbor. His wife, nee Monica McKinnon, predeceased him four years ago. He leaves to mourn besides a wide circle of friends throughout the province, the following sons and daughters: Albert in Indian River; Hamilton, Roxbury, Mass.; Herbert, Seattle, Washington; Dr. William L. West Roxbury, Mass.; Mrs. J. Austin Trainor, Charlottetown; Mrs. Frederick Campbell, Atlantic, Mass.; and Mrs. William Ready, Atlantic, Mass. The funeral takes place this morning at 9.30 a.m. to St. Mary's Church, Indian River. To the bereaved the Guardian extends deepest sympathy.

There was a very large turnout of returned men and citizens at the Remembrance Day service at the War Monument in Charlottetown on Saturday morning. Headed by the Legion Band and marshalled by Major F. B. Conrad, President of the Charlottetown Branch of the Canadian Legion, the returned men paraded from the Legion rooms to the monument, where the service began promptly at 11 o'clock with the observance of the two minutes silence. From 10.45 till 11, the fire bell tolled at intervals of twenty seconds, and as the hour struck a round of gunfire from Victoria Park marked the beginning of the interval during which all heads were bowed in a lent prayer. The assembly, led by the Charlottetown Male Chorus, and Legion Band, then sang "O Canada," followed by Kipling's "Recessional." The Lenten "The Flowers of the Forest," was played on the bagpipes and the Last Post sounded by Trumpeter Ben Dolron. Following this impressive ceremony the assembly sang "O Valiant Hearts" and "O God Our Help in Ages Past." Revellie was then sounded, and the National Anthem sung.

TUESDAY

The regular monthly meeting of the Summerside Town Council was held last night in the Council Chamber, Mayor Manson presiding. Town bills were passed as follows: Paid bills, \$4,241.40. Unpaid bills, \$1,766.64. Electric light paid bills, \$833.88. Unpaid bills, \$1,040.24. An application from E. J. Hallet, Scout Master, asking that the Scouts of Summerside be allowed to sell apples on Apple Day was granted. A letter was read from T. L. Compton, barrister, asking that ex-Chief Kane's salary be paid until the end of the civic year. On motion of Coun. Phillips the letter was received and will be handed to the recorder.

The appointment of a chief of police was laid over until an adjourned meeting. The matter of a municipally owned airport was also laid over.

WILL ATTEND ROYAL WINTER FAIR—The Misses Mary Monaghan, daughter of Mr. William Monaghan, Hazelbrook, and Elsie Lund, daughter of Mr. Ernest Lund, Bethel, representing the Mount Herbert Ayrshire Calf Club, leave on Saturday for Toronto, where they will participate in the five-days program of events under the direction of the Canadian Council of Women's and Girls' Club Work, at the Royal Winter Fair.

There was keen competition among the clubs this year for the honour of upholding Prince Edward Island's reputation at the Fair, and the Mount Herbert Calf Club is to be congratulated on the splendid showing made in this connection. The young ladies selected for their meritorious work will join groups from other parts of the Maritime at Moncton, where they will be met by Mr. E. F. Pineau, of the Federal Livestock Branch, who will accompany them to Toronto, take charge of the Maritime party during their stay at the Fair, and return with them to Moncton. Every province in Canada will be represented in the Boys' and Girls' Club competitions.

Arrangements have been made to give the visiting representatives a trip to Niagara Falls and other points of interest during their stay in Ontario.

The Prince Edward Island Library Demonstration was the subject of an interesting address at Rotary luncheon yesterday by Miss Nora Bateson, M. A., library director. Miss Bateson suggested that a number of Rotarians be added to the present library committee. In British Columbia, for instance, the service clubs run a successful regional library.

TO ROYAL WINTER FAIR—Herds of the prize cattle of Ings and Son, and of Mr. J. Walter Jones leave this morning for the Royal Winter Fair. The herd of Ings and Son consists of eleven head of Ayrshires and are in charge of Messrs. Earl Ings and Irvine MacKee. Mr. Jones' herd of Holsteins will be in charge of Messrs. SADLY BEREAVED—Mr. and Mrs. Nell McDougall, 129 Upper Prince Street, leave this morning for Milo, Lot 9, called there by the unexpected death of Mrs. McDougall's father, Mr. Nell J. McNevin, who died suddenly after only a few days' illness. A prominent and active resident of the community, he was revered and respected by young and old. To the family is extended sincerest sympathy.

SCHOOL BOARD—The regular monthly meeting of the School Board was held last evening. The chairman, Mr. C. H. B. Longworth, on behalf of the Board extended congratulations to Hon. Dr. MacMillan on his elevation to the Premiership and to Hon. H. P. MacPhee on his appointment as Attorney General. Members of the board extended sympathy to the chairman on the death recently of his sister.

POTATO STEAMERS IN PORT—The S. S. Jakob Mearsk, arrived from Summerside yesterday morning where she was loaded a part cargo by the Associated Shippers and is completing her cargo here with 20,000 bags. This steamer is docked on the east side of the railway wharf. The S. S. Nidarod arrived from Souris yesterday morning where she loaded a part cargo by the Potato Growers Association. The S. S. Dampfire, arrived from Victoria where she loaded a part cargo and yesterday was anchored in the stream.

PUT OUT TO SEA—Due to the heavy wind which was blowing yesterday H. M. C. S. Saguenay which arrived in port on Tuesday was obliged to put out to sea. Yesterday morning it was found that the ship which was anchored in the stream was dragging her anchors, and it was thought best to leave the harbour until the wind died down. Commander Murray will visit His Honour Lieutenant Governor Dalton when the Saguenay returns.

The Guardian has been informed that is not correct. The little girl was coasting with her sled and ran under a horse's feet. The little girl escaped with a few bruises and a bad skin on her head, but was able to go to school on Monday; at the same time she had a miraculous escape from being kicked by the horse.—S.

Mr. Harry Leard, Crapaud, died at 3.45 yesterday afternoon in the Prince County Hospital from severe injuries about the head and chest received in the electric light plant at Crapaud of which he was manager. Mr. Leard was found by his son, John, about 11.45 yesterday morning in an unconscious condition with his clothing caught up in the line shaft of the power plant. It is not exactly known what happened but it would appear that he reached over to oil the shaft and his clothing must have got tangled up in the spindle. The terrible condition of his injuries especially his feet, would indicate that he was revolving with the spindle or at least ten minutes before his son found him. One foot was almost severed and the other badly mangled as each time his body went round his feet struck the stone wall of the building. Owing to his struggles the engine belt came off which brought the machinery to a standstill.

The funeral of the late Howard Ferguson took place from Knights of Pythias Hall, Rossland, British Columbia, Saturday, Nov. 4, the large hall being crowded to capacity. Members of Trail Lodge No. 21, Knights of Pythias, Rossland Lodge No. 23, Knights of Pythias, L.O.L. No. 1708, Golden City Lodge No. 786, L.O.A.B. Maple Leaf Temple No. 4, Pythian Sisters, and the Rossland Old Timers' Association attended en masse. The religious service at the hall and the graveside was conducted by Mr. Ferguson's pastor, Rev. C. H. Daly, and the Pythian services by the officers of Trail Lodge, No. 23, Knights of Pythias, of which Mr. Ferguson became a member in 1901. Interment was in Sunnyside cemetery, the pall bearers being J. A. MacKinnon, supreme representative, Harry Balfour, grand officer, guard, Harry White, deputy grand chancellor, all of Trail, and William T. Trembath past chancellor, Walter Sanderson past chancellor, and Nicholas Michael, past chancellor, of Rossland.

Born in Perth, near Montague, P.E.I. the son of Dugald Ferguson, and Mary Wood, Mr. Ferguson spent his young manhood in Massachusetts and went to Portland, Oregon in 1884 and later to Seattle. He engaged in contracting and built many depots and bridges on the last lap of the Northern Pacific Railway. In 1897 he went to Trail, British Columbia and in 1922 took up residence in Rossland. A member of the Baptist Church, his Christianity was not something kept for state occasions, but stood the wear and tear of every day life. He was a past chancellor of Trail Lodge, No. 23, Knights of Pythias. He is survived by his widow, two nieces, Mrs. W. R. Cook of New

Bedford, Massachusetts, and Mrs. Verne Higgs of Napan, Nova Scotia, and four nephews, Benjamin Farquharson of P.E.I., Dr. G. H. Farquharson of Gleichen, Alberta, Chester Johnson of New Bedford and Guy Fletcher of Boston.

PASSED AWAY—There passed away at his home in Montague on Saturday, November 3rd, Daniel MacGregor at the age of 78 years.

Mr. MacGregor was born at Lot 48, the son of Daniel and Ann MacGregor, and was one of the leading merchants at Montague. He was a highly respected and honoured citizen. In partnership with Mr. Alex MacLeod (now of Charlottetown) he began business at Montague twenty-two years ago and the store is still running under the management of his son, Harry. In 1885 he married Miss Lavinia Leman, sister of Mr. Frank Leman, Montague. Funeral service was held from his late residence, Rev. C. E. Armstrong officiating. Two favorite hymns of the deceased were sung: "Jesus Lover of my Soul," and "Abide With Me." Mr. Armstrong took his text from James 6:14 "For what is your life?" Deceased was in failing health for some time and was tenderly cared for by his loving wife who is left to mourn. The following children share her bereavement: Irene (Mrs. A. McQuarrie, Westville, N.S.); Harry and Russel at Montague and Lee in Winnipeg. The surviving brothers and sisters are Joseph at Montague; James, at Union Road, and Bessie, in the West. The pall bearers were: Messrs. N. J. Nicholson, H. McLean, L. B. Mellish, C. Robertson, J. Rourke, H. McLean. Interment was in Montague Cemetery.—H.

In Supreme Court yesterday before Mr. Justice Arsenault evidence in the case of the Provincial Sanatorium Commission vs. Senator Creelman McArthur was heard, the witnesses being for the plaintiff, Dr. P. A. Creelman, and for the defence Charles M. Williams and the defendant.

Plaintiff's claim is for \$200, being the amount of a subscription made by the defendant for the purpose of building and equipping a Provincial Tuberculosis Sanatorium.

The defendant claimed that the subscription was not a promise to pay, but an offer to pay, which offer would have to be accepted either formally or by the plaintiff proceeding to execute the work; that if it was not so accepted it was revocable, and that the defendant did revoke it and informed the campaign committee that he would not pay the subscription.

In his evidence the defendant said The Guardian newspaper had published an editorial criticising the campaign; that this criticism had incensed him and he had taken the ground that the campaign committee in Charlottetown should take steps to have The Guardian withdraw its objections. This he said the committee had failed to do and he had therefore refused to participate further in the campaign committee work in Summerside and had withdrawn his subscription.

Counsel appearing in the case were Mr. Gilbert Gaudet, K. C. for the plaintiff and Messrs. T. A. and J. O. C. Campbell for the defendant. Argument on the case, which is being heard in Chambers, will take place today.

News of the death yesterday of Mr. John Lockery Thompson of this city was heard with expressions of widespread regret throughout the Province. The late Mr. Thompson, who was a prominent and much respected citizen, was one of the oldest railwaymen in the Province, and was formerly agent in the station of this city. Until the time of his final illness which began about seven weeks ago, the deceased enjoyed the best of health. Born in Annan, Dumfriesshire, Scotland, on April 17, 1850, Mr. Thompson came to Prince Edward Island, and shortly after his arrival, entered the employ of the Prince Edward Island Railway in May 1875. From the position of brakeman, he advanced to that of baggage master, and later conductor. In 1897 he became agent of the station in this city, and held that position until the time of his retirement about twelve years ago. As his advancement in the service would indicate he was conscientious and scrupulous in his work, and a model of integrity in all his associations.

The late Mr. Thompson was an elder of St. James Church, a Past Grand Master in the Masonic Lodge, and was one of the oldest Shriners in the Province.

He was twice married. His first wife was Miss Anne Thompson, daughter of the late Isaac Thompson, Suffolk. From this union were born three children, two daughters and one son, Anne, Mrs. A. G. Campbell, Alice, Mrs. H. T. Prowse, and William, all of this city, and all of whom survive. Mr. Thompson is also survived by his second wife, who was Miss Elizabeth MacDonald, daughter of the late Donald MacDonald, Marshfield. To the bereaved The Guardian extends sincere sympathy.

DIRECTORS MEETING—A meeting of the directors of the C. N. S. F. B. A., was held on Friday last at their head office in Summerside, the president, George E. Callbeck presiding. Directors from other provinces were, Mr. Onaries Fremont, K. C., of Quebec City; F. H. Copp, Port Eglon, N. B.; L. D. McKenzie, Truro, N. S. Mr. L. Bellcourt of Quebec and Mr. J. E. MacTague of Allison, Ontario, prominent fox breeders were present. It was decided to hold the annual meeting in Quebec City at the Chateau Frontenac.—S.

RECOMMITTED TO PENITENTIARY—Benjamin Sonier, Summerside, on ticket of leave from Dorchester penitentiary, was taken back this week to serve the balance of his term. Since his release on good behaviour Sonier was convicted and served a jail term for a prohibition offence.

PROBATE JUDGMENT—In the matter of the estate of the late Monsignor D. J. Gillis, Indian River, a case of probating a will in solemn form, judgment was given on Wednesday by Judge H. L. Palmer in the Probate Court. By the judgment, the will was sustained, and judgment previously granted to the executors in common form was confirmed. The executors, Urban Gillis, Rev.
