# Liberal Stronghold Successfully Assailed

## Mr. J. Frank Arnett Again Received With Warm Enthusiasm. Makes Splendid Impression At Wellington.

In Mr. A. E. McLean's own constituency, the Conservative party received a great ovation on Tuesday evening in the community hall at Wellington. The hall was packed to the doors and so great was the crowd that the candidates spoke outside after delivering their speech inside so that the hundreds who could not get in the hall would not be disappointed.

Mr. Marin Gallant, president for East Prince Liberal Association was in the chair and handled a difficult situation with credit.

Mr. Arnett opened the campaign and made an excellent speech which was listened to with no interruption except for applause. In his opening remarks Mr. Arnett said he was pleased to see so many ladies present. It had a deep significance as it denoted that the people wanted to learn all they could of the issues which are facing the country at the present day. In speaking on the record of the King Government, on which they were asking the people to vote he pointed out many things which his opponent had neglected to tell the people, (loud applause.)

In speaking of the gifts that had been received from the Conservative administration he reminded them of the high offices, which had been awarded to the Acadians right here in their own district. But where Mr. King had a position of importance to offer he gave it, not to McLean, but to an outsider, a professor in a university in Montreal. The bitter issue was fully dealt with by Mr. Arnett and his remarks showing the loss in money, \$20,000 to the farmers monthly, on account of the New Zealand Treaty was greeted with applause.

The old age pensions was another subject which the popular candidate for the Conservatives dealt with pointing out the defects in the King policy on this matter which was received with a round of applause from the many deeply interested people a good many of them past the prime of life. In his closing remarks Mr. Arnett asked the people to consider who they should vote for, a government which advocated a policy they had denounced all the years that they had been in power, or a government which had had the same policy since the time of Sir John A. McDonald, (loud applause.)

**LIBERAL CANDIDATE**

Mr. A. E. McLean's followers from Lot 16, the place of his birth were there in large numbers to support him and he was given a great reception but in spite of this fact the tone of the meeting was three-parts Conservative. Mr. McLean was in good form and pleaded his cause in eloquently. When he touched on the subject of fishermen's rights, however, there was a decided feeling of antagonism among the people who had looked to Mr. McLean for something worth while in this matter. He claimed that it was his party that had got the 40 per cent for highways and that a delegation from Charlottetown consisting of Messrs. Sinclair, McKinnon and Hughes had waited on him at Ottawa and he had got this thing through the fishermen were being instructed in the curing of their fish and he was proud to say that the tender for the wharf at Skippers Pond had been accepted and even if the wharf at Egmont Bay had been a failure this one was not going to be! The general issues of the campaign were reviewed by Mr. McLean from the Liberal standpoint.

**MR. A. F. ARSENAULT**

Mr. A. F. Arsenault, M. L. A., who spoke on behalf of Mr. Arnett, was received with deafening applause and made the greatest speech that he has been heard to make for some years.

He asked the people to consider the record of the King administration and when they went to the polls to remember that it was their opportunity to dictate to the leaders of either party whether they would return again to power a party, who changed their policy within a few weeks of an election or whether they would have the party who had given them the policy of Sir John A. McDonald. He brought out in a convincing manner the way in which Mackenzie King had seen fit to treat the Maritimes. How he was a prisoner in the hands of the Progressive Party in the West. McLean who had been to Ottawa, said Mr. Arsenault, had not told the people of Prince County that Mr. King had had given the Western farmers, 35 per cent American, a preference over the Maritimes in as much as they only have to pay 7 1-2 per cent duty on their farm machinery for their extensive wheat growing, while the farmer in the east has to pay 10 per cent for his potato diggers, etc. and 28-30 per cent on his gasoline engines and the farmers in the West only 10 per cent on their tractors, that is the quality of "justice" Mr. King is handing out because he is afraid to come out and stand firm for the Canadian people, like his grandfather Sir Wilfrid Laurier. "These are the things you should know," said the speaker.

In speaking of old age pensions Mr. Arsenault said, it was more important that your children should find homes in Canada and build up this great country God had given to you than you should receive the pensions given to the need for the

Mr. Shelton Sharpe, was the second speaker in support of Mr. Arnett and was given a good hearing.

Mr. H. A. Darby, M. L. A., and Mr. J. A. Matheson supported Mr. McLean but were frequently interrupted with cries of "bitter." "Old stuff," and such-like remarks which made it difficult for them to obtain a hearing at times.

The meeting waxed hotter and hotter towards the close showing the strong feeling of dissatisfaction with existing conditions that a rift among the people.

Mr. Arnett in a ten minutes speech at the close answered with satisfaction many points brought up during the meeting.

A vote of thanks was tendered to the chairman by Mr. Arnett, seconded by Mr. McLean.—S.

charge of all stores on the ship. There were no fire arms allowed on board. The witness with the chief officer and a member of the crew about 9.40 a. m. had seen the Spaniard lying on the deck after the latter had been injured. After the boat was taken to the hospital, the Stevedores identified Anti and Posselt, without hesitation. They were immediately put under arrest. The Captain had asked Anti where he had got the gun. Anti replied that he had got it up town. When asked what he had done with it, he answered, "threw it overboard." On the way to the jail the prisoners indicated the house of Mrs. Stewart as the place where they had procured the gun. This was verified by Mrs. Stewart. A few slight cuts on the body of Anti were examined by the Captain. A plan of the deck opening which was drawn by A. A. Surter, able seaman, was produced. Owing to the noise of the winches, it would be impossible to hear a shot on the forecastle head. The witness had noticed the Boatswain's gloves, a marlin spike about a foot from the ladder, and the Boatswain's cap against the bulkhead.

Cross examined, Capt. Johnston stated that he first saw the Spaniard lying outside the Forecastle head. Also was holding the Boatswain's head.

The ship would have a draft of 13 feet unloaded on that particular morning, the captain stated. He could not give any estimate of the ship's draft, nor could he give any information on the tides. The character of the deceased, was, in the opinion of the witness, excellent.

Sometime previous to 9.35 the first officer gave the Captain information that, Anti desired attention for some cuts on his face. A marlin spike a chipping hammer, a meat cleaver, the boatswain's knife and a number of articles of clothing belonging to Anti were exhibited. The wound on Anti's buttock might, witness thought, be caused by the point of a knife. When caused on deck, chief officer reported to him that there had been a quarrel.

Dr. R. F. Seaman, sworn, testified that Roderiques was brought to the hospital at 12.30 p. m. unconscious and in a dying condition, with a wound in the right side of the back of his head. His hair was matted with blood and brain substance. The man died at 6.45 p. m. X ray pictures were taken, but witness admitted that he could not take such pictures himself.

Counsel for defense objected on the grounds that witness did not know whether the pictures were properly taken or not. The wound penetrated to almost the length of the probe used, about eight inches witness declared.

Kenneth MacDonald, sworn, testified that he saw the prisoner on the deck between 9 and 10 a. m. striking Roderiques over the legs. They were running toward the galley deck. The boatswain chased Anti over the side of the ship, brandishing a cleaver. The spike followed him to the wharf. Witness described the fight. Anti and his buddy went up town, returned, first went aft and later went forward. Witness described situation in detail with reference to plan of the ship.

Cross examined witness thought that height from railing to wharf would be 20 or 25 feet. It was the opinion of the witness that the hole in the belt had been prodded. Witness saw a junk of something thrown from the ship, but could not tell who threw it.

Mrs. Myrtle Jenkins, sworn, stated that while in her store, Anti and Posselt entered and asked for a gun, but she told them that they had none. Cross examined, Mrs. Jenkins stated that he did not know which man asked for the weapon.

Mr. Reginald Batchelder, sworn, testified that he was in Jenkins' store when one of the men asked for a gun. They stated that they wished to shoot a mad German police dog on board the ship. Witness stated that he took them to the home of Mrs. Stewart, where a gun was procured. Later he saw both men aft on the ship.

William J. McLeod, able seaman, sworn, testified that he saw the prisoners in Jenkins' store where they asked for a gun.

The jury men will remain in the courthouse till the end of the trial.

### Three Thousand See Great Racing

Upwards of 3,000 people attended the St. Peters Bay horse races yesterday afternoon. A more perfect day could hardly be. The sun was shining brightly yet the afternoon was not too hot. The rain of the day before had settled the dust making it a pleasure to drive over our roads, which had been nearly all dragged and were therefore at their best. The sport was good and everybody seemed to be in holiday mood and thoroughly enjoying themselves. The races were keenly contested with the exception of the 2 1/4 Class Mixed which was rather easy for Lucky Lindy, who won off by himself in each heat.

The first class called was the 2 1/2 Class Trot and Pace. This had eight starters, some of them a little difficult to get away, with the result that there was considerable scoring. When they finally got off Dixie Marque took the lead with The Great Village Belle, Edith Aubrey and Dame Dillon all closely bunched. Three-quarters of the way around the second trip Dame Dillon shot in front but made a break entering the home stretch and was passed by Dixie Marque who finished with a splendid burst of speed. Dame Dillon recovering was a close second. The Great Village Belle a nice third and Edith Aubrey fourth, the others strung out. Time, 2:18.

In the second heat Dame Dillon outtrots Dixie Marque, while Edith Aubrey scored third place from the Great Village Belle in a dandy finish. May Cromwell fifth. This heat was close between all four horses.
