Returns After 15 Years In Northland

MONCTON, N. B., March 12.—Nearing the end of a 4000 mile trail from the Great Bear Lake district, Urie Arsenault, a native of Summerside, P. E. I. climbed aboard the Canadian National Railway train leaving here this morning for his home in Summerside. For fifteen years the prospector searched for radium and silver in Great Bear Lake district and recounted his experiences in travelling in this north country where he went immediately following the great war.

He enlisted with the 106th P. E. I. Battalion with which he proceeded to France, later transferring to the famous fighting 26th Battalion of New Brunswick, with which he served until the Armistice. Returning to his native province the northern adventurer turned his steps to the Arctic circle where he has since been located. There is a great contrast, he said, in travel facilities when he went into the far north in comparison with today. When he first went to Fort McMurray headquarters for exploration parties and prospectors, it took many days to reach there. Today, he said, the airplane does the trip in a day or two. While money can be made at prospecting, Mr. Arsenault stated, trapping is still a big money maker in the north, some trappers making as high as \$20,000 in one season, which lasts for eight months.

The thermometer during the winter drops to 70 degrees below zero, he continued, but it is a dry cold and everyone is clothed to suit the climate. There is great fishing, the lakes being full of trout with fifty pounders often caught, while large herds of caribou, about Moose are plentiful, also bears, with numerous timber wolves, he added. Vegetables, he said, were the only articles a prospector missed but he has grown potatoes, lettuce and radishes successfully. The radio, according to Mr. Arsenault, has been of great service in the far north both in the matter of entertainment and in keeping people living there in touch with civilization.

Mr. Arsenault intends to spend about three weeks in Summerside when he will return to Great Bear Lake.

Kents Prolong Jamaica Visit

 KINGSTON, Jamaica, March 12.—Giving no reason for their sudden change of plans, Britain's royal honeymooning couple, the Duke and Duchess of Kent, announced today they would remain at Montego Bay until Thursday before leaving for King's House here and taking an aeroplane Friday morning for Nassau, Bahamas.

Until today everybody thought they would leave Jamaica this morning. No explanations were given for the extension of their visit. Evidently they liked Montego Bay, quiet north shore tourist resort, so well they were loathe to leave. On Sunday the royal couple entertained the Duke of Gloucester, Prince George's elder brother, now visiting Jamaica on his homeward voyage from Australia and New Zealand.

Indian Princes Approve Bill

 BOMBAY, India, March 12.—The Indian princes will accept the India Constitution Bill, it was reliably understood here today following a conference between the influential Maharajah of Patiala and the Earl of Willingdon, Viceroy of India.

The British government is said to be willing to accept the essential safeguards formulated at the recent meeting of the chamber of princes, which the princes declared would be necessary before the bill was acceptable to them.

Patmos to be included with all her complement. Formerly the cruiser Helia was abandoned.

An official announcement said the toll of both sides in the land operations in Macedonia was only 10 dead and 91 wounded, indicating to observers here that the rebel resistance collapsed like a pricked balloon once General Kondylis, loyal generalissimo, got his weather-bound offensive under way. Previous unofficial reports had the figures much higher.

Cost of Revolt Uncertain

A long expensive struggle lay before the Greek Government to rehabilitate itself after the insurrection. There was no official estimate as to the monetary cost of the 12 days revolt and its consequent economic effect.

The flight of the 71-year-old Venizelos, whose solitary appearance marked years of rough-and-tumble participation in the turbulent struggles of Greek politics, completed the debacle that began with the surrender and rout of the Macedonian land forces.

Crete, which reports said Venizelos had declared an independent state, came back quickly to the loyal side, government representatives taking possession of all posts of authority on the island.

Also back under the rule of Athens were the islands of Mytilene, Chios and Samos, which fell to the rebel warships last week, and jubilant crowds cheered posters announcing their recapture and Venizelos' flight.

Papagos Arrested

As Gen. Papoulas, generalissimo of Greek forces in Asia Minor during the war with Turkey, was arrested in an Athens suburb, the Government took steps to extradite from Bulgaria Gen. Demetrius Kalmancos, leader of the Macedonian rebels, and other chiefs who had escaped with him across the border.

Already under arrest were hundreds of persons suspected of rebel sympathies, together with 3,000 insurgent troops who surrendered during the push that brought recapture of the rebel strongholds of Seres, Orama and Kavalla.

(A despatch from Rome said Government shells struck the Italian consulate at Kavalla, for which the Greek Government apologized.)

"Legal authority has been re-established throughout Macedonia and Thrace," Premier Tsaldaris said.

"Having tried vainly political tolerance, I am now compelled to take severe enough steps to prevent any repetition of seditious movements."

Athens business houses reported normal trading conditions re-established with Crete.

Interviewed Venizelos

A woman journalist representing the Paris Soir reached Athens and asserted she interviewed Venizelos at Crete yesterday, the former Premier declaring himself forever out of politics.

President Alexander Zaimis issued a statement thanking the nation for its loyalty during the revolt.

Later this afternoon thousands of persons thronged the streets of the capital in a demonstration of loyalty to the Government, marching past Tsaldaris' home in a tribute to the Premier.

Answering the cheering throng, the Premier appeared at a window and made a brief address.

FLIGHT TO MAGDALENS

The air mail plane made a trip to the Magdalene Islands Sunday leaving here with 800 lbs. mail and three passengers. Mrs. Fred Arsenault, Grindstone, who was taken to the City Hospital early in February for an operation and was accompanied by her physician, Dr. Alphonse Chaisson of House Harbor, the former being fully recovered. The other passenger was Mr. Turbide of Grindstone. Another trip to have been made but, owing to reports from the Magdalenes as to weather conditions, it was cancelled. A trip will be made as soon as flying conditions are favorable.

BILLS IN LEGISLATURE

A bill authorizing the Maritime Trust Company to carry on business in Prince Edward Island was introduced in the Legislature by Mr. W. A. Stewart. He explained that the company was already doing business in New Brunswick. The bill was given its first reading. In the absence of the Attorney General, Premier MacMillan introduced bills to amend the Electrical Inspection Act 1932 and the Insurance Act. They were given first reading. The House then proceeded with the discussion on the Draft Address. Adjournment was made until 3 p. m. today.

JUDGMENT DELIVERED

In the Supreme Court yesterday judgment was delivered in the appeal case, heard at the January term, of the King vs. William Munn being an appeal from a conviction for driving to the common danger. Justice A. E. Arsenault delivered judgment allowing the appeal with costs in the appeal and in the court below. Mr. Alban Farmer appeared for the Crown and Mr. J. O. C. Campbell for the appellant. The appeal was dismissed with costs in the case, Wong Fong vs. Corporal Frederick Cortwell of the R.C.M.P. The appeal was given a verdict and judgment for the defendant, the case being heard at the June term last year. Mr. Justice A. C. Saunders delivered judgment. Mr. Justice Arsenault concurring. Mr. J. J. Johnston, K.C., and Mr. J. O. C. Campbell for the appellant and Mr. Alban Farmer for the respondent. In another appeal case, the King vs. Ethel Doyle, Mr. Justice Arsenault delivered judgment allowing costs. The appeal was from a conviction under the Prohibition Act. Mr. Alban Farmer for the Crown and Mr. J. Johnston, K.C., for the appellant.

Approves U. S. Canada Lumber Trade Scheme

 HALIFAX, March 12.—James Lane of Armdale explained in magistrate's court today why he was not sending his nine children to school this year. Unemployed for three years and unable to obtain relief, he could not buy them clothes, and they were practically naked, he said. His case was adjourned until March 19.

Meanwhile the children will be omitted by Councillor R. D. Guildford, also of Armdale, who was present at the hearing. Backed by the councillor's weighty signature, an appeal for relief from the Red Cross will also be forwarded.

Seek Aid For Destitutes N. S. Family

 COPENHAGEN, March 12.—A theory that grips spread infantile paralysis was advanced today by Dr. Hjalmar Wenneberg, chief of the Gothenburg, Sweden, hospital for epidemic illnesses. Referring to last year's outbreak he said in several instances "it was possible to prove there was no contagion through other persons or food."

Danish scientists disagreed, claiming that infantile paralysis contagion was due to impure food. They said it would be impossible to have paralysis epidemics in mid-winter in Russia and Greenland if the germ theory were sound.

Will Enforce Rigidly Govt. Reform Policies

OTTAWA, March 12.—Rigid enforcement of the penal sentences of the government's reform measures was promised today by Minister of Labor Wesley Gordon. He was addressing a delegation of the Confederation of Catholic Laborers of Canada. "If there is to be any laxity on behalf of persons or firms which break these laws, the effectiveness of these measures would not only be imperilled they would be destroyed," he said.

The unemployment insurance, day-of-rest and the eight-hour-day bills all have penalty provisions. The question was raised when the delegation asked that companies which break labor laws lose their charters after two offences and that dismissal of a workman because he had joined a union should be considered as a misdemeanor.

The minister said the complaint applied more to provincial than Dominion laws, but the reform statutes now before Parliament would be vigorously enforced.

The government was asked to forbid commercial publicity over the Canadian Radio Commission stations or other Canadian stations on Sundays. Minister of Marine Alfred Durand promised to urge the delegation's recommendation on the Radio Commission.

Term "Cowardly" Precipitates Near Battle

WASHINGTON, March 12.—Fists clenched, William G. Shearer, vociferous big navy advocate, today brought an abrupt end to a turbulent United States munitions committee hearing by advancing upon a committee member who had called him "cowardly."
