SAYS AMERICAN ARMY WOULD HAVE TROUBLE IN MEXICO.

MONTREAL, November 12.—"The wealth, the common sense, and the army are behind General Huerta in his effort to bring order out of chaos in Mexico, and if the United States sends its soldiers into our country, they may win the battles, but it will be twenty years before they can get back across the border."

This statement was made by Francisco K. Cuno, who is stopping at the Queen's Hotel, to a representative of The Daily Mail last night. Mr. Cuno is a wealthy merchant of Vera Cruz and is here to establish a trade in fruits with Montreal merchants.

"Conditions are not as bad in Mexico as the world is led to believe by the United States newspapers, and we have no reason to complain of the state of trade down there, in fact it is money and trade that is at the bottom of the present intervention by the Americans."

"Huerta is painted as a very bad man, but this is far from being right. I am not a politician, nor am I interested in any way with the fortunes of any political party. I am a business man and view matters from a business man's point of view."

HUERTA IS NOT AMBITIOUS.

"Huerta is not ambitious. Under former President Diaz he served as a soldier, and he was a good one, as well as faithful. He is above all things a soldier, and by hard work advanced to the post of general in the army. When Francis I. Madero, who by the way gained the presidency through American influence, gained the supreme power, Huerta with true soldierly instinct acknowledged him as his superior and helped him carry out his program as far as the army was concerned."

When Felix Diaz started the rebellion against Madero, Huerta was again loyal to his chief and took the field in Madero's behalf. But, finding that the Diaz party was exceptionally strong, and that if the war was allowed to go on there would be frightful bloodshed in Mexico, as well as loss of money and business, he tried to bring the opposing parties together, and used his influence with the army to do this. He sent his assistant to Madero, asking under what conditions the latter would consent to meet the other party, but the assistant never returned to Huerta, he was shot down by Madero himself in the Parliament buildings. This aroused Huerta, who turned against Madero, and the latter was obliged to resign the presidency. When he had done this Huerta ordered the president's arrest, and it was while transferring him from the Parliamentary prison to another place of confinement that an effort was made to rescue Madero. In the melee that followed Madero was shot. It was not murder by Huerta."

"While there are other strong men in Mexico Huerta is at present in power, and he will stay there until the elections are finished. It must be remembered that it takes a long time to hold the elections in Mexico, as throughout the country they take place on various dates, and then if the man receiving the highest number of votes has not two-thirds of the whole vote cast, the Mexican Parliament will elect the president. Once this work is over, Huerta will bow to the will of the country, but he is a strong military man, and no threats or cajoling will divert him from the course on which he has embarked, that is sure."
