amounted to \$3,000. The Dominion is prepared to immediately supply some of these devices in quantity.

Washington was so upset Saturday by the suddenness of the British action that one official hastily announced countervailing provisions of the Smoot-Hawley Tariff Act would be invoked against Great Britain. In fact countervailing provisions do not apply on the articles made dutiable and even if they did, United States imports on the "manufactured and partly manufactured" list turned over to the board of trade amount to only \$12,000,000, whereas a re-check of United States exports on the same basis shows an annual value of \$275,000,000.

While the anti-dumping duties strike perhaps heavily against European exports as against those in the United States, experts believe France and Germany are in a better position to make tariff reciprocations than is the United States. Washington spent Sunday worrying not so much about the general British tariff which is expected in the long run, as about the possibility of whether immediate action will be taken by the Board of Trade in extending prohibitive duties on the list under its control.

King Continues His Political Speech Making

MONTREAL, Que., Nov. 22—

Traversing the whole range of Canada's financial situation, roundly condemning Premier R. B. Bennett's retention of several cabinet portfolios, the duties of which had resulted in the impairment of Mr. Bennett's health, directing shafts of biting satire at the "indiscretions" of Hon. G. Howard Ferguson, Canadian High Commissioner to London, and scoffing at the "cant and hypocrisy so characteristic of the present administration," Rt. Hon. W. L. Mackenzie King, leader of the Liberal party, delivered an address here yesterday to the Montreal Reform Club. The speech rounded off Mr. King's recent tour of the Atlantic provinces. He was attended by several of his former cabinet colleagues, Liberal members of Parliament from Quebec, and a large number of government members of the provincial house.

Mr. King had some caustic comment to make upon the counsel of the Canadian Bankers Association to the provinces and municipalities, wherein that organization had warned them to cut their expenditures, and renege. Why, he asked, was the same advice not given to the Dominion administration? That was where it was needed most. Why had not the Bankers Association intimated to the Prime Minister that the one had come for Canada to have a Minister of Finance? Mr. Bennett was in England, Senator Robertson, Minister of Labor, was ill, presumably from overwork in having to shoulder the tremendous responsibilities which the present situation imposed on him, and Hon. E. B. Ryckman, Minister of National Revenue, had long been in indifferent health.

He had been represented as adversely criticising the new "national service loan," Mr. King said. Actually, the contrary was the case. He hoped the loan would be a huge success, and strongly advised his hearers to invest their money in it. No sounder security existed than the Dominion of Canada; and the investors would have this additional assurance, he declared, that when the loan fell due it would be redeemed by a Liberal government.

"But I criticise the cant and hypocrisy of the present administration," he said. "In calling this a 'National Service Loan' why not be content to call it 'The Dominion of Canada Loan, 1931.' You don't need to introduce this 'By the Grace of God,' and 'National Service' and all the rest of it.

as a model to the younger generation. Born in this Province, he entered the wholesale boot and shoe business in Charlottetown as a young man, later taking over the business of J. N. MacLeod & Company and specializing in the retail trade with outstanding success. His genial personality, his consistent though unassuming practice of the highest business principles, were known to all with whom he came in contact.

His active interest in everything tending to community welfare was expressed in generous donations which seldom found their way into public press notices. Time as well as money he freely devoted to these causes, which he regarded as essential responsibilities of citizenship. He preferred always, however, to work actively in the background. Nothing embarrassed him more than to receive notoriety as a philanthropist, though indeed there are many throughout the City and Province who know Mr. Alley to have been one in the truest sense of the word.

Keenly interested in politics, Mr. Alley was a consistent supporter and worker in the interests of the Conservative party, and for several years past was president of the Provincial Conservative Association. In that capacity he rendered services of incalculable benefit. His advice and experience were held in the highest regard by his co-workers, among whom his loss will be felt very keenly. As in his business life, so in his political activities, Mr. Alley sought neither place nor publicity for services which he considered in the light of a public duty. He was content that these services were performed thoroughly and conscientiously, and rejoiced disinterestedly when success crowned his efforts.

The late Mr. Alley was a great enthusiast for the beautifying of Queen Square Gardens, and the fine appearance of these gardens every summer is a monument to his efforts in this regard. He was also a keen sportsman, and delighted particularly in getting away from the routine business for a day's quiet fishing.

A relative of Mr. Alley's was the late Hon. Franklin K. Lane, a former Islander who achieved fame in the United States as a statesman and member of the Wilson Cabinet.

Mr. Alley's wife predeceased him by several years. He is survived by a half sister, Miss Laura Young, librarian at McGill University, to whom deep sympathy will be extended at the present time. Miss Young is expected to arrive in Charlottetown in time for the funeral, which will be held privately on Saturday from the home of Mr. and Mrs. J. O. Hyndman.

to their maturity dates in 1936 and 1941. Such a yield is regarded in financial circles as highly attractive and it is believed a warm reception awaits the loan. Reports from various sections of the country, as received at Ottawa and here, are stated to be distinctly encouraging. Not since 1923 has a Dominion bond been issued with such a high yield. In that year a five year bond was issued with a yield of 5.33 and a 20 year bond with a yield of 5.15.

The central committee of the loan has received applications for allotments from insurance companies and trusts totalling approximately \$17,000,000, these before the price of the issue was definitely announced or the lists opened. The Great West Life has applied for three million dollars worth; the Manufacturers' Life, Canada Life, Mutual Life, two million each; New York Life, Imperial Life, Confederation Life, London Life, Royal-Liverpool-London Globe Bond, one million each; Metropolitan Life, half a million and smaller amounts have been requested by the Crown Life, Ontario Loan and Debenture, Canadian Order of Foresters; National Life; Northern Life; Union of Canton; Trust and Guarantee; Toronto Mortgage; London and Western Trust; London and Lancashire and Canadian Security.

A glance at the yields of Canadian Government bonds during the last decade reveals that the yield rate was at its highest just after the last depression, 1923, and has steadily dwindled until 1930.

With the consensus of informed opinion favoring the theory that the bottom of the present economic depression has been reached, it may be assumed that more attractive terms are unlikely to be made available in the near future on a government loan than those being offered by this latest internal issue.

Financial circles believe that the huge increase in bank deposits on July 31, 1931, as compared with the year previous, means that the earnings of Canadians are being set aside awaiting a favorable investment outlet. It is believed holders of this vast reservoir will not overlook the 5-per cent bonds now being issued. Savings deposits at July 31, 1931, were \$1,500,000,000, an increase of \$49,000,000 over the previous year. The success this year of the conversion loan showed that Canada placed great confidence in her bond issues. The conversion loan did not involve new money.

The new National Service Loan is a Canadian issue, payable as to principle and interest in Canadian funds and the intention is to sell all possible to Canadians. Signs are not lacking, however, that considerable United States interest has developed particularly among those whose study of exchange leads them to the belief that the Canadian dollar will appreciate with a consequent automatic increase to the investor who buys at the present discount of Canadian funds.
