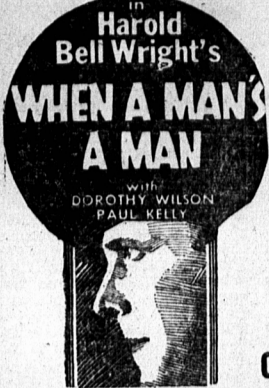

Aberhart said today he expected an interim report on finances in two or three days although it would be three weeks before an audited report would be completed. He took office with the prospect of facing \$15,000,000 in obligations before the fiscal year ends next March. This was exclusive of \$18,000,000 already owing to the Dominion and \$3,800,000 in demand savings certificates, redemption of which was suspended some days ago by the Reid administration as a result of a run by depositors.

Before March 31, Aberhart must face bond maturities of \$5,200,000; interest charges of about \$2,800,000 and the provincial share of relief, heretofore capitalized, \$1,215,000. In addition, bank losses have been estimated at \$3,700,000 which brings the total obligations to \$14,915,000. These figures are estimates and only time will tell the exact position of the treasury. Not until he has an interim report will Aberhart know how much money he must secure from Ottawa. In the meantime, he has the promise of Premier Bennett to give him every assistance.

Exploration Party Touches Here In Plane

Hopping from St. Mary's Harbor, Labrador, in a fast seaplane, an exploration party headed by Canadian Airways survey manager F. T. Jenkins, dropped into Charlottetown harbor last night, announcing merely that they had been on "secret exploration work in Labrador for private interests." The party had been as far north as North-west River, and had spent considerable time shooting pictures. The plane left Montreal Aug. 7 and will hop off on the return flight tomorrow morning. "We took a lot of pictures and did some mighty fine fishing" laughed Pilot W. H. Irvine who had little more information to offer on the exploration trip than did Assistant General Manager Jenkins of the airways company. "It would be unfair to our principal to disclose any further information," said Mr. Jenkins. They made the jump from St. Mary's Harbor in quick time. They touched at Curling, Nfld., at three o'clock and arrived here at seven. Included in the party was Charles Falaisy, engineer.

Local Cyclists Pass Through Nelson B. C.

The following despatch taken from a Nelson, B. C., newspaper reveals the progress made to date by two local cyclists on a trans-Canada tour. Out to see Canada from a bicycle saddle, rather than sit at home and "watch the world go by," two cyclists, Jack McDonald and Hugh Campbell, arrived in Nelson about 4 o'clock Tuesday afternoon from Charlottetown, P. E. I., bound for Vancouver. They left Charlottetown June 5 and put Lethbridge behind them last Thursday. Tuesday morning they left Creston and at 4 p. m. were in Nelson. After overhauling their bikes tomorrow, they will start out tomorrow or the next day on another lap of the journey. While in Nelson they are guests of Mr. and Mrs. P. H. Long, Silica Street. Lectures On Bible Baptism

"Bible Baptism" is sprinkling, dipping, pouring or immersion was the topic of the lecture delivered by Evangelist F. W. Johnston at the Forum last night. He said that although this was a much controverted theme yet he considered that the Bible was sufficiently clear and free from any ambiguity on the subject. Infant baptism so Mr. Johnston said was nowhere taught in the Bible. This is clear so he said from the conditions prerequisite to baptism. These conditions so he read from Acts 2:38, March 15:15, and Acts 2:41 were to repent first, then believe in Christ and thirdly to gladly accept the teachings of the word of God. This being true he said that it would be absurd to talk of baptizing infants for they could not fulfill the conditions required before baptism. Nor did he regard it necessary to baptise infants for the simple reason that infants are not sinners. They are innocent and undefiled, and the Lord so he said held them up as an example of purity for Christians when He said, "Except ye be converted and become as little children ye shall in no wise enter into the kingdom of Heaven." It is therefore evident so Mr. Johnston said that only adults are fit candidates for baptism and not only that but that only that class of adults who have repented of sin, accepted of Christ, and received the word of God in their hearts.

But why he enquired is baptism urged upon us in the Bible? He said it was not only the memorial of the burial and resurrection of Christ according to Rom. 6:3-5 but was also a symbol of the individual's death to sin and resurrection to a new life in Christ. Furthermore he said that water as well as the blood was shed from the side of Christ for the remission of sins and was therefore on an equality with the blood. He referred to the experience of Christ on the cross when the soldiers with a spear pierced the side of the Saviour and forthwith there came both blood and water. John 19:34. He also read 1 John 5:6-8. "This is he that came by water and blood." Now Mr. Johnston said that while it is true that the water alone does not save us, yet as Peter in his epistle says in 1 Peter 3:21, "The like figure wherunto baptism doth also now save us." The word "also" he said shows that there is salvation in the water alone. The Pharisees he said rejected the counsel of God by not being baptised. Luke 7:29-30. Mr. Johnston then attacked the methods of baptism. He said that the word rendered baptism was from the Greek "Baptizo" which always meant to immerse or bury. The word for sprinkle is "Rhanizo" which he said used the word "Rhanizo" which shows that he meant for people to be immersed and not sprinkled. Even the King James version which we all have, he said, warrants the idea of burial in baptism and read Col. 1:12 also Rom. 6:4-5 in support of it. Furthermore Mr. Johnston said that baptism was the only door into the church. We are all baptised into one body he read from 1 Cor. 12:13. In fact he read from Gal. 3:27 that it is only as we are baptised into Christ that we put on Christ. He regarded it as a

marriage ceremony where the Christian becomes officially united to Christ as a member of his body, the church. We must not therefore underestimate the importance of Baptism he said; for if it were not only for the reason that Christ requires it, the alone would be sufficient to show that it must be important. "Repent therefore and be baptised every one of you for the remission of sins," he read from Acts 2:38.

Scout News and Notices

The 2nd World Rover Moot, held in Sweden in July, was attended by Rover Scouts from 24 different countries. Neighbourly donations of food for the summer's camp of an Alberta Boy Scout troop included a whole sheep, which it was hoped "would last the boys a couple of days." Another troop was loaned a cow. Six Cambridge University Rover Sea Scouts sailed in a small schooner to attend the World Rover Scout Moot in Sweden. They were given a most friendly reception during their passage through the German Kiel Canal. 500 boys, non-Scouts, from the distressed areas of Monmouthshire and South Wales, were given a free ten days' Scout camping out at Dawlish, South Devon, through the co-operation of the King George Jubilee Trust, Major Ralph Raynor, and district Scouters. The boys came in two batches of 250.

Further news from the earthquake disaster at Quetta, India, emphasizes the splendid work done by Indian Boy Scouts following the catastrophe. A party of 50 Rovers came up from Lahore, to offer their services, and in gas masks, were used to recover bodies of the dead. When exhausted they were relieved by a second 50. This was the tribute paid the native Boy Scouts of Sierra Leone, East Africa, by a woman round-the-world tourist: "I don't think I shall ever forget their jolly chocolate-coloured faces or the way they looked after us. At other places we had been pestered by people who wanted to sell us things or act as guides. At Sierra Leone a party of Scouts met the boat, kept off troublesome people, showed us around, and refused to take a tip. We were two women traveling alone, and my sister was an invalid. You can imagine how thankful we were for those Scouts."

Holland made a bid at the International Scout Conference for the World Scout Jamboree to be held in 1937. Decision will be announced early in November. Selected Boy Scouts of Blackpool, England, are being trained for the Scout Fireman's Badge by the Superintendent of the Blackpool Fire Brigade. They will serve as an emergency section of the department. Similar training is given Canadian Boy Scouts by many local fire chiefs. Addressing a Scout gathering at Kenton, England, Magistrate Charles declared that if there were more Scouts in the country there would be less need for reformatories and fewer cases in the juvenile courts, the number of which at present was very disturbing.

Delegates from twenty-four nations attended the 8th Biennial International Conference of Scout Leaders held in the Parliament buildings at Stockholm in August. The assembly was opened by H.R.H. Prince Gustaf Adolf, President of the Swedish Scout Union, and was addressed by Lord Baden-Powell.

So impressed were the officers of the troop ship Nevada with the bearing of the 1200 British Rover Scouts carried to and from the World Rover Moot in Sweden this summer that it was decided to form a Deep Sea Scout unit among the officers aboard. One of the officers was invested as leader.

An interesting comparison of two types of discipline--military, and that of Boy Scouting, which is self-imposed, as part of the Scout code,--was provided officers of the troop ship Nevada, chartered to carry some 1200 British Rover Scouts to the World Rover Moot in Sweden. The comments were distinctly in favour of the Scouts. Other comments were that the Scouts "settled down" much more quickly than the soldiers, and that they ate "half as much again."

(Continued from Page 1) ed to agree in its first attempt at Scheveningen, the Netherlands; then tried again after an extraordinary session of the League Council and selection of Dr. Nicholas Socrates Politis of Greece as a fifth arbiter, to break any deadlock in which the two Italian and two Ethiopian representatives might find themselves. These deadlocks developed, Politics entered the discussions and the decision was reached at a final secret session in Paris which ended at noon today. The unanimous decision of the commission reached gave both nations a clean bill of health, awarded no damages and decided neither nation was responsible for subsequent developments growing out of the incident.

WASHINGTON, Sept. 3--(A.P.)--Secretary of State Hull announced tonight that as a result of discussions he had with Socony-Vacuum Oil Company officials, he had informed him they would withdraw from the concessions secured from Emperor Haile Selassie to develop more than half his Ethiopian kingdom. Hull said that H. Dundas, vice president, and George S. Walden, chairman of the board of the Vacuum Company, had informed the State Department this morning that their corporation owned the concession granted by the Emperor to the African Exploration and Development Company.

Serious Peace Obstacle

After discussing the question with Wallace Murray, chief of the Near Eastern Division, the two officials conferred with Hull. He informed them, he told newsmen, that the granting of the concession, at this time was a serious obstacle to the maintenance of peace and might have extremely serious repercussions. Dundas and Walden returned to New York and late today informed Hull that, after consultation with their associates, they were prepared to terminate their part of the concession and that their representatives would inform the Emperor that they did not desire to go forward with the concession. Hull said his first knowledge that the Vacuum Company was owner of the concession came this morning when Dundas and Murray conferred with him.

Issues Statement

Immediately after making his announcement to the press, Secretary Hull issued the following statement: Mr. George S. Walden and Mr. H. Dundas, chairman of the board and vice president respectively of the Standard Vacuum Oil Company, called on Sept. 3, to make known that their company is the owner of an extensive oil concession granted by the Emperor of Ethiopia on Aug. 29 last to the African Exploration and Development Company, a subsidiary of the Standard Vacuum Oil Company, and to seek the department's advice on the situation created by the grant. The officials of the above men-

tioned company were informed that the granting of this concession had been the cause of great embarrassment not only to this Government but to other governments who are making strenuous and sincere efforts for the preservation of peace. In the circumstances, the company officials were informed of the views of this government that it was highly desirable that the necessary steps should be taken at the earliest possible moment to terminate the present concession. The Secretary of State was later informed by the above officials of the company that the company has decided to withdraw from the concession and is notifying the Emperor to that effect, and giving the following statement to the press:

Issues Explanation "G. S. Walden, chairman of the board of the Standard Vacuum Oil Company, jointly owned by the Socony-Vacuum Oil Company and Standard Oil Company of New Jersey, who has just returned from Europe, today issued the following explanation of his company's position in the negotiations with the Ethiopian Government relating to the oil concession reported as having been granted to the African Exploration and Development Corporation. "For more than 20 years the Standard Vacuum Oil Company and its predecessor have been engaged in the petroleum business in Ethiopia and interested in the possibilities of crude petroleum production in Ethiopia as well as in other countries in which it is doing business. "Early this year, Mr. Francis W. Rickett of London approached us on the possibilities of negotiating on our behalf a petroleum exploration and development agreement with the Kingdom of Ethiopia. "After considerable discussion with Mr. Rickett it seemed probable that he might be able to secure a concession whereupon the Standard Vacuum Oil Company organized a corporation in Delaware known as the African Exploration and Development Corporation as a wholly owned subsidiary to acquire such concession when granted. "On Friday last I was informed that an agreement had been signed with the Kingdom of Ethiopia, though I have not seen a copy of it as executed. The agreement which Mr. Rickett was authorized to negotiate relates to the development of crude petroleum production and provides for no payment or loan of money nor has any been made. "The agreement calls for a geological survey within one year. If this survey indicates the presence of petroleum in such quantities as the African Exploration and Development Corporation should desire to continue to hold the concession, then it must begin drilling in five years. Thereafter, in the event petroleum is discovered in commercial quantities the operation of the properties is to be in accordance with customary development practice. Ethiopia then would receive a royalty on all petroleum produced. "This matter was handed in the regular course of business as a private transaction with Ethiopia, but without consultation with any other government. "In view of the misleading nature of the news comments in Saturday morning papers, I felt it necessary to give all the facts to our state department before issuing any public statement.

(Continued from Page 1) It was a very informal affair. Amid the customary gloss missing from the ceremony were policemen, soldiers, morning coats, canes, high hats, women in evening gowns. Even the Lieutenant-Governor, who once grubbed for gold in the Yukon, sported a gray suit and blue shirt. Scattered through the crowd were men in sweaters. Some advertised membership in the Alberta Social Credit League by little white buttons. The crowd, the largest ever to attend an inauguration in Edmonton, was so big the ceremony had to be transferred from the council room to the Legislative Chamber. A few minutes after the ceremony, the cabinet held its first meeting when financial matters were discussed. The new government took office with a treasury almost bare of money and pressing obligations had to be met in the next six or seven months. Investigation of the treasury's present position is being rushed through and Aberhart plans to leave for Ottawa early next week to arrange a loan with Premier Bennett ranging from \$10,000,000 to \$15,000,000. Two Social Credit members will resign to permit Premier Aberhart and C. Ross, minister of mines, to take their seats. Although it was not settled definitely, it was expected Rev. William Morrison would
