It was erected by Mrs. Sheehan, daughter of the late Mr. Pope, and was presented in dedication by Mr. George DeBolis. The dedicatory prayer was offered by Rev. H. D. Raymond. Following was the address by Mr. DeBolis:

In Loving Memory of Percy Pope 1856-1930 Who served for many years as Church Warden and Vestryman of this Parish. Until the day break and the shadows flee away."

On July 24, 1856, Miss Catherine MacIntyre, who passed away Friday last at the home of her nephew, Mr. Peter MacIntyre, New Glasgow, was probably the oldest inhabitant of Prince Edward Island. She deceased who was 106 years and seven months of age, was born at Clementon.

During the last few years, Miss MacIntyre spent much of her time in her bed, but she still retained much of her mental acumen, and was able to converse with her friends and exchange reminiscences. Her eyesight and hearing were very good. She was a very interesting conversationalist and could relate many stories of the life of the early settlers. Throughout her life, and even in her latter years, Miss MacIntyre took an active interest in affairs of the community and of the world in general.

The deceased was born near her present home. Her father emigrated from Scotland, as a young man, and married a lady from near the present where he settled. Miss MacIntyre's receipt for attaining a certain age was to practice moderation in all things, to take an active interest in many subjects, to have plenty of work, and some recreation.

FUNERAL OF MISS MCINTYRE—All that was mortal of Miss Catherine MacIntyre, was laid to rest in Indian River Cemetery on Monday morning. The funeral services were held in the Roman Catholic Church at Indian River, many friends being present to pay their last respects to an old and dear friend. Rev. A BUSY PORT—In spite of the depression and the falling away of the sailing schooners, Montague was busy port this fall. According to information gathered during the week, twenty-four vessels entered the harbor from foreign ports. Thirty were cleared for foreign ports. Exported to Newfoundland and Labrador ports farm produce of all kinds amounting to the value of \$46,000. Eighty-two vessels inwards, and seventy-one vessels cleared outwards coastwise, and in vessels outwards coastwise, was exported to Canadian ports principally in Nova Scotia, farm produce of all kinds to the value of about \$18,700. This is the largest number of vessels to enter inwards and outwards for some time.—H.

B. MacMillan, Deputy Minister of the department. The discovery was in the nature of papers relating to the purchase of a safe from the firm of Tilton-MacFarlane, Boston, Mass. The safe duly arrived on the brig Fleetwood and was paid for on Feb. 17, 1874. The cost price in Boston was \$690.85 plus the freight, which was twenty-five dollars in gold, payable on delivery. The Prince Edward Island Government paid in full for the safe with \$635.50 in Canadian money.

CIVIC ELECTION—The civic election for three Councillors and a Mayor for the town of Summerside is drawing near and as yet there is no talk of any new men in the field. Mayor Manson and Councillors McNeill, Kelly and Bell have all signified their intention of offering for re-election. With a surplus of \$716.65 to their credit it would appear as if the Mayor and Councillors have taken good care of the citizens money and used it to the best advantage. During the past year Granville Street was paved, besides various sidewalks laid down and repaired and the west end abutment and approach repaired. The extension to the High School was built, \$25,000 being voted by the town for this purpose.—S.

FURTHER PARTICULARS—The new Electric Power Plant dam at Valleyfield broke away at 1.15 a. m. on Wednesday and together with tons of ice and water went crashing down stream. Huge cakes of ice propelled by rushing water, snapped off large trees, tore away bridges and did considerable damage. The dam, which was built in 1927 by the Montague Electric Co., was concrete faced with earth and rock filling. It was 58 feet thick at the bottom, tapering to 10 ft. thickness at top (water line). The structure gave way at each end and a width of about one hundred feet of dam went down stream. This might have ended in a terrible tragedy, as a large number of young people spent the evening skating on the ice just above the dam, and although they were warned several times during the evening by the caretaker, they stayed until about 11:30 o'clock. The concrete bridge above the dam and the fine concrete and steel bridge built last summer at Sutherland's dam by Mr. Martin MacKinnon are badly damaged. Frost is claimed to have caused the disaster. The Power Plant was taken over by the Associated Gas and Electric System in 1932.—H.
