to vote salaries of \$25,000 for members of the Cabinet and \$50,000 for the Prime Minister, a year. The Prime Minister of Canada should be paid a higher salary than the head of any private organization in Canada. But under present conditions members of the Cabinet should not receive an allowance for automobiles. A taxi could be obtained for 25 cents.

Much of what Mr. Pouliot had said would have been much better said on the hustings, remarked Hon. E. N. Rhodes, Minister of Finance. He (Mr. Pouliot), had stated that the government had loaned money to Newfoundland. This was not true. Not one cent had been loaned by the government to Newfoundland. But when Canada found that Newfoundland, the oldest Dominion under the British flag, was in need Canada had come to her assistance. It was a proud boast that the British people had never defaulted on their debts, and he thought that Canada had done right in helping Newfoundland.

Not a dollar of Canadian money had been sent to Tokio to build a legation in that city, continued Mr. Rhodes. The matter brought up by Mr. Pouliot would probably be discussed on the estimates, and he thought that then it would be shown that Canada was fortunate to have such a public-spirited man as her representative in Japan.

The member for Temiscouata had referred to the fact that \$1,300,000 had been loaned to the C. P. R. The money had not been given to that railway because it was the C. P. R. proceeded the Finance Minister. It had been loaned in order that the C. P. R. shops should be opened and employment given to people who would otherwise go to relief.

William Duff, (Lib., Antigonish-Guysboro), renewed the protests against the reduction. He suggested that the Japanese legation at Tokio and the office of Canadian Minister to Washington be abandoned for the present with a saving of some \$180,000 a year, and that similar savings would soon make it unnecessary for the salary reduction.

Mr. Rhodes observed that the member for Antigonish-Guysboro had been consistent in his opposition to this measure since it was first brought down a year ago, and he was not quarrelling with Mr. Duff's point of view that as a member of Parliament his services were worth \$4,000.

"If times were good I would say that a Member of Parliament should get \$5,000 indemnity," he proceeded.

"Or \$6,000," suggested a voice from the Opposition.

"Yes—even \$6,000," Mr. Rhodes agreed. He thought it better that a member be overpaid than underpaid.

As for the "golden era" which Mr. Duff had intimated prevailed when the Liberals were in power, he would be glad to discuss that at another time, Mr. Rhodes said.

"Let us arrange a special debate," suggested Hon. Ernest Lapointe.

"We would meet in Arichat (the Finance Minister's riding) Mr. Duff interposed.

"I would agree to that," the Finance Minister replied, "but if my honorable friend is not more fortunate in his remarks at Arichat than he has been before this committee, then he will be very unfortunate indeed."

Mr. Duff had left in the minds of the committee the impression that the Finance Minister had been responsible for the dismissal of a light keeper in his constituency, Mr. Rhodes proceeded.

A sharp interchange involving points of order and heated interruptions ensued until it was established that Mr. Duff had meant only that the dismissal had been made by the government of which Mr. Rhodes was a member.

Repeated interruptions from Mr. Duff prompted the Finance Minister to remind him that "we are not dis-

Hon. Fernand Rinfret (Lib., St. James) favored the resolution of the government. Montreal city had cut the salaries of its employees.

Dr. J. J. Denis (Lib., St. Denis) said the government should ask a greater contribution from the rich. He was against a 10 per cent cut on small salaries.

JIM CORBETT
IS DYING

NEW YORK, Feb. 7.—James J. Corbett, exhibiting the same type of courage that sent him into the ring against the great John L. Sullivan and brought him the heavy-weight boxing championship, tonight was waging what appeared to be a losing fight with death.

Since last Tuesday he has been confined to his bed in his suburban home on Long Island, above Little Neck Bay, with a diseased heart which has bothered him for several years and lately had been overburdened by activities incident to his return to the boxing world as a promoter. He is in his 67th year.

Despite all the remarkable feats of defensive brilliancy that are exhibited regularly in the National Hockey League, it is doubtful whether the record for scant number of goals compiled against George Hainsworth in the Canadian nets in the season of 1928-29 will ever be excelled.

Canadiens played 44 games in that season, and only 43 goals were scored against them. As can be readily seen, this is just under a goal a game. Hainsworth on 22 occasions turned back the opposing forces without a single goal. In thirteen games only one goal got past him. The highest total against him in any one match was five goals, and that happened only once. Canadiens scored 71 goals in the season and compiled some amazing records for winning and unbeaten sequences, but they didn't get far in the finals, Boston Bruins defeating them three straight in the preliminary play-offs, and going on to the world's title.

Hainsworth first tended goal in 1912 for Kitchener Juniors, which lost in the play-offs to Toronto Canoe Club. He has played continuously through O. H. A. Junior intermediate and senior ranks, on to Saskatoon in the Prairie League, then to Canadiens. He didn't keep track of his amateur shut-outs, but figures he has had 150 at least in his hockey life-time and that 18,500 pucks have been flung at him in various parts of the country. He rates Charlie Conacher the hardest shot of all. Bill Cook was the trickiest, Jimmy Ward the most deceptive because he has a dropping shot. He is 35 years old, has an 11-year-old son who is also a goaler, and has starred in baseball as a catcher and short-stop. Hainsworth is a little bit of a fellow and only once suffered serious injury. His nose was shattered by a pre-game testing shot from Aurel Joliat's stick a few seasons back, but despite the injury Hainsworth manned the nets with his nose puffed and plastered, blood oozing down his face, and Canadiens beat Americans with Hainsworth letting in only one goal.

UNITED CHURCH
PRESBYTERY

The regular quarterly meeting of the P. E. I. Presbytery of the United Church of Canada met in Hertz Hall, Charlottetown, on Tuesday, Feb. 7th, at 11 a. m., with the Chairman, Rev. D. K. Ross presiding. The Secretary presented a lengthy agenda of business for the consideration of the Court. On the recommendation of the official board of Orwell-Vernon Pastoral Charge, Mr. Lewis Murray was received as a candidate for the ministry and his name was referred to the committee on students. At twelve noon, the hour for the devotional period having arrived, Rev. G. A. Christie spoke on the Oxford Group Movement. Mr. Christie emphasized the two main teachings of the Group, sharing and guidance. His criticism of the movement was directed against its attitude of indifference toward the social problems of today.

At the afternoon session, Dr. J. W. MacConnell addressed the Court on Home Missions. There are at present in the colleges across Canada five hundred students preparing themselves for the ministry of the United Church. Despite the deficits we have, the United Church is in the best financial position of any church institution of its size in America or elsewhere.

Rev. F. E. Boothroyd submitted the following requests for grants from the Home Mission Board: Belfast, 500; Bideford, 50; Bradalbane, 450; Covehead, 700; Georgetown, 400; Hampton, 350; Montrose, 200; Richmond Bay East, 500; Winsloe, 400; West Cape, 300.

The report on Religious Education was given by Rev. G. A. Elliott. A resolution was passed regarding temperance teaching in the day schools, commending the action of the Department of Education in placing Miss MacKordindale's book on Temperance on the curriculum of the schools, and also urging upon school inspectors to give due place to the study of the book. Rev. L. J. Leard, of Winsloe and Rev. M. K. Charman, of Stewart, made application for a change of pastoral relations. These applications were received by Presbytery and ordered to be transmitted to the Settlement Committee. The Secretary was given authority to transmit any names that may come in later.

Rev. D. M. Sinclair reported briefly for the Statistical Committee. As all the charges had not sent in their reports, the report was not complete. The following charges raised as much or more than last year for the Missionary and Maintenance Fund: Bedeque North, Kensington, Montrose, Pownall, Souris and Winsloe. A full statistical report will be given at the next meeting.

Presbytery replied in the affirmative to the remit sent down by the General Council concerning the establishment of a Judicial Committee to hear appeals and to consider and report on all matters of law and jurisdiction which may be submitted to it by the General Council. The remit with regard to the duties of the Moderator was referred to a committee to report at next meeting.

The appointments late today were authorized under the measure enacted on August 3, 1931, for the establishment of a Tariff Board. The previous board—established by order-in-council and not by Parliament in 1926, and which had functioned under the chairmanship of Rt. Hon. George P. Graham and later by William H. Moore, now Liberal member for Ontario—had been abolished by the administration of Prime Minister R. B. Bennett shortly after its accession to office in 1930.

The 1931 statute authorized payment of a salary of \$12,000 per annum to the chairman. The two other Commissioners are to receive \$10,000 yearly. Office in each instance is to be for a term of 10 years.

Duties of Board Many
The duties of the Board are many. In respect of goods produced or imported into Canada the Board shall, at the request of the Minister of Finance, (Hon. E. N. Rhodes), make enquiry as to—

(a) The price and cost of raw materials in Canada and elsewhere, and the cost of transportation thereof from the place of production

(b) The cost of efficient production in Canada and elsewhere, and what increases or decreases in rates of duty are required to equalize differences in the cost of efficient production;

(c) The cost, efficiency and conditions of labor, including health of employees, in Canada and elsewhere;

(d) The prices received by producers, manufacturers, wholesale dealers, retailers and other distributors in Canada and elsewhere;

(e) All conditions and factors which affect or enter into the cost of production and the price to the consumers in Canada;

(f) Generally, all the conditions affecting production, manufacture, cost and price in Canada as compared with other countries.

Reports on tariff matters under these headings are to be made to the Minister of Finance (Hon. E. N. Rhodes).

Hearings to be Public
Hearings—public in character—are to be held in Ottawa. Sitings outside of the capital also are authorized.
