Canada's Tourist Trade Picks Up
OTTAWA, Jan. 5.—(CP)—Canada's tourist trade may have been a minor casualty in the first few months of the war but the pattern now is clear and it is recovering. Officials of the Canadian Travel Bureau, said today after compiling statistics.
Entries into the Dominion of United States tourists and their cars definitely decreased during the 1939 autumn season, as compared to the previous year but by November American tourists apparently were learning that Canada at war was as hospitable as in peacetime.
Figures for last September showed 469,608 cars from the United States entered Canada and 1,599,950 persons a decline of 22,403 cars and 107,000 persons as compared with October, 1938, showed a decrease of 590,040 cars and 286,689 persons.

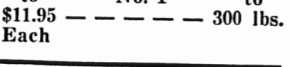

Parent-balked Romance Has Wedding Sequel

N. H. Jan. 5.—(AP)—The turbulent, parent-balked romance of pretty Eileen (Juliet) Herrick of the social register and George (Romeo) Lowther, 3rd, rocketed into a long-delayed rendezvous in a preacher in this White Mountain ski centre today.

The wedding, enabled by a waiver of the state five-day law, climaxed two months of frenzied and frustrated courtship during which Lowther twice brought legal action against his parents' consent.

With ski instructor James Schneider as best man, the New York post-debutante, 20, and the handsome insurance salesman, 30, were married by Rev. Raymond Phelps of the Congregational Church.

They arrived suddenly by plane from Portland, Me., where they flew from New York last night accompanied by newspapers, an unidentified maid of honor, and Eileen's Terrier Gypsy, whose evening walk provided the pretext on which Eileen ducked out of her Manhattan home last night.

They also bought ski outfits. Eileen left home in a simple house dress and polo coat, and equipped only with a tooth brush and a comb. Her parents remain tearfully but adamantly opposed to the match, and say Eileen would always be welcome home—but not Lowther.

FOOD, IN SMALL QUANTITIES

OTTAWA, Jan. 5.—(CP)—Canadians may send food in small quantities to relatives or friends in the United Kingdom as gifts without having to pay duties. They may take it over, officials of the trade and commerce department said today.

However, if food is sent in large quantities it won't get by the ministry.

Canadians may send five pounds of butter or a like amount of sugar, tea, bacon, or other commodity, two or three cans of canned meats, fruits and vegetables.

Traffic Up But Ship Owners Wringing Hands

BOSTON, Jan. 5.—(CP)—The usual spectacle of ship owners wringing their hands while traffic through the port shows a tremendous increase may be seen in Boston today.

United States customs figures show an approximate increase of \$32,000,000 in the value of foreign products brought here in 1939. Exports through the port advanced about \$2,000,000.

Shipping interests, however, are forced to watch one of the greatest commerce booms in the history of the port of Boston while their own ships lie idly by unable to carry goods either to or from Europe's danger zones under the neutrality act.

With all indications pointing to a record-breaking amount of traffic through the port for 1940, shipping men say, however, their outlook for the year is dim. They say ships coming from South America, Far East ports and Africa are loaded to capacity with cargo that normally would be carried by United States vessels. In their opinion, these foreign ships are making inroads into what before the war was a rapidly improving American merchant marine.

Gains close to 100 per cent in some cases have been noted in the foreign ship trade from such distant places as South Africa and Dutch East Indies, although not in the forbidden zone.

Alberta Debt Adjustment Ultra Vires

CALGARY, Jan. 5.—(CP)—

Sections of the Alberta debt adjustment act restricting collection of money owing on promissory notes or bills of exchange were declared ultra vires in a judgment given by Mr. Justice A. F. Ewing in Alberta Supreme Court here today.

The sections declared invalid provided no court action could be begun to recover money owing under a promissory note without special permission from the debt adjustment board if the debt were incurred prior to July 1, 1936.

Mr. Justice Ewing quoted a judgment of the late Mr. Justice Taschereau in the Supreme Court of Canada declaring the dominion parliament under the British North America Act could alter the jurisdiction of the provincial civil courts.

The judgment said the sections referring to promissory notes and bills of exchange came under jurisdiction of the provincial courts and not provincial governments.

Who's Who In British Cabinet Shuffle

Leslie Hore-Belisha, who steps down as secretary of state for war, a post in which he brought about sweeping changes in the British army and saw introduction of compulsory military service during the reign of King George VI, was once described by his mother as a man who would "make a good dictator."

But he has not been regarded as a dictator in his department, and he has been as popular, if not more popular, in this ministry than he was when he reorganized British traffic, and cut down road accidents, during his terms of office in the transport ministry.

Lord MacMillan is said the war secretary resigned as a result of differences with Viscount Gort, commander-in-chief of the British forces in the field, whom he raised over the heads of senior men to his high post a year ago.

In the comparatively short time he spent at the war office, Mr. Hore-Belisha left a lasting imprint on army life, even as he left his name on the "Belisha beacons"—the traffic standards he introduced when minister of transport.

In the army he emphasized mechanization, went after recruits, built better barracks, increased pay, developed the territorial army, introduced better clothing and lighter equipment.

AUSTRALIA TO AID TURKS
MELBOURNE, Jan. 5.—Prime Minister R. G. Menzies announced today that the Australian war cabinet had approved a grant of £10,000 (\$35,000) for relief of devastation wrought by the recent Turkish earthquake.

The cabinet also granted the Finnish consul permission to appeal to the public for the Finnish Red Cross. The Australian Government subscribed £10,000 as the first contribution.
