Herbert Bashford's Successful Comedy Drama

"THE WOMAN HE MARRIED"

As Played by Miss Virginia Harned At the Prince Edward Tonight at 8.30

A young wife, who has been an artist's model, marries the son of a millionaire, an easily recognizable type, the dominant and successful American father. When she finds she is not welcomed into the family and that she is unjustly suspected of being mercenary in her devotion, she shows her character by telling that father just what she thinks of him and by insisting that she and her young husband take care of themselves. The young people go out in the world and fall into dire straits. The wife thinks of her earning capacity as a model. The husband has prejudices. But work she must. There is of course the alternative of going into a department store and earning meagre wages. Her talent for the stage she cannot very well utilize, those prejudices blocking the way. But she can pose in secret and she can offer her husband the money by pretending that she has been borrowing it from a woman friend. Inevitably she finds herself landed in complications, one of the most serious being that the artist she is posing for falls in love with her. At the close of the third act we find her involved in a scene of tense emotion, which carries the piece to the climax. The last act being devoted to unravelling the threads and to bringing the young people into well ordered and permanent happiness. In this work the author quietly and deftly turns over some of our more peculiar and accepted social prejudices and makes them look somewhat absurd. Though he doesn't try to send propaganda over the footlights, he gets in many a shrewd thrust at economic injustices, particularly at the injustice that puts girls and women at so hideous a disadvantage. "The Woman He Married" will open the W. S. Harkins Players engagement at the Prince Edward tonight at 8.30 sharp. Seats now on sale.

Supreme Court

The criminal case against Hiram Woodside of Kensington charged with committing an offence against a young girl, came up at the Supreme Court in Summerside yesterday before the Chief Justice and jury. The Attorney General appeared for the Crown and Mr. A. C. Saunders, K. C. for the prisoner. Application was made by the Attorney General to have another count added to the indictment covering a similar offence alleged to have been committed in February, 1922. The jury returned a verdict of not guilty on the initial count but guilty on the last count.

There are a number of jury and non-jury civil cases to come up next week. It is likely the sitting of the Court will continue throughout the week.

The Jury Charge

Following was the jury charge delivered by the Chief Justice in the Hughes case:—

Gentlemen of the Jury, the case which you have to try is upon a true bill brought in by the Grand Jury of this County. This bill of indictment contains two counts which I shall read to you. The first count is that at Kensington, in Prince County between the 25th day of May 1923 and the 7th day of June 1923, the prisoner, John Hughes did receive and have one live silver black fox of the value of \$75 and upwards belonging to the Matchless Silver Black Fox Company, Limited and Myra G. Profit and between them the said Matchless Silver Black Fox Company and Myra G. Profit kept in captivity in a fox ranch at Kensington in the said County for breeding and commercial purposes, and were therefrom stolen, he said John Hughes then well knowing the silver black fox to have been stolen. Then there was another count between the 25th day of May 1923 and the 7th day of June, 1923 that the accused, John Hughes did receive and have one live silver black fox of the value of \$100 and upwards belonging to the Matchless Silver Black Fox Company, Limited kept in captivity in a fox ranch at Kensington in the said County for breeding and commercial purposes, and therefrom stolen, he, the said John Hughes then well knowing the said silver black fox to have been stolen.

It is upon that bill of indictment that you are now trying the prisoner. You will recall from the evidence that there were two foxes in question, one from pen No. 17 and the other from pen No. 13 and the separate counts are in relation to each one of those foxes separately, so that when you come to your verdict your verdict will have to do with two counts. The Prothonotary will give you the bill of indictment which I have just read, and it is open to you to find a verdict of not guilty on the two counts generally, or of guilty on the two counts generally; or you may find him guilty of one count and not guilty on the other. If you have any doubt in regard to this you are to apply to the Court after you go to your room.

Now the accused is not on his trial for theft; nor for stealing, but for receiving goods alleged to have been stolen knowing them to have been stolen; and the duty is upon the Crown in presenting to you the evidence in relation to each one of the different steps that the Crown would require to establish. First of all there must be that there can be no receiving of stolen goods unless the goods were stolen. And in the next place, to prove that certain goods were stolen would be of no avail unless it was shown that those were the same goods found in the hands of the accused. So you will direct your attention to the evidence intended to disclose whether or not those were the same foxes as had been in the ranch of the Matchless Company.

The Prisoner's Evidence

Next, consider that when the Constables went to the prisoner's home on the 6th of June, they found two foxes there and the prisoner makes no attempt to explain the presence of one of them. He says he did not know it was there at all. As for the other, I wish you to note this explanation: he says he was on the road at night on Irishtown road as he had picked up a little fox two or three weeks old and took it home, and it was running about the house. The evidence is that it was a brownish colored fox and smaller than the two found in his loft. The evidence of his daughter is that its back was hurt so that it could not get around very quickly. That fox was there from May 3rd until along toward the latter part of the month—the 30 or 31st when it was taken away by this man McDonald, in a manner not at all satisfactory. However, the prisoner was not aware of that. He heard a fox under his barn and you remember his explanation that he dug a hole by which it could get out and that later on when he was at dinner he saw the fox in the yard and went out and caught it; that he thought it was a very little fox and he had previously picked up and under this impression placed it in this cage in the loft. Now you are to measure the value of that statement. Are you able to credit it? He put it in the cage, he says, and left it there and went away to work in Summerside and never knew anything about the arrival of his second fox until after the constables had come and found it in the same cage. I am not going to go any further into the evidence; I do not think I could help you. You have all heard it; you have listened, I know, with exceptional care and you have had the privilege of an exceptionally complete and satisfying review presenting each side of the case. Now, after deliberating, you will arrive at a conclusion. I trust you will be governed in your consideration of the whole case by the principle of British justice and, if, having considered both sides, you have still a doubt as to how the verdict should go, the prisoner is entitled to the benefit of that doubt. But in all such cases a doubt does not mean a guess or a faint

impression. It must be a reasonable doubt, a doubt such as a reasonable man would entertain so that it makes him certain as to the truth. If you have such a doubt and if, after having applied your reasoning powers to the full, you cannot come to a conclusion with reasonable certainty then the prisoner is entitled to the benefit of the doubt.
