Orangemen turned out in force yesterday to mark the annual anniversary of the twelfth of July. The parade in the forenoon was a large one, representatives from every lodge in the Province being present, while hundreds of citizens viewed the parade as it proceeded through the streets.

DIED IN VANCOUVER.—Mrs. Eliza Sarah Mann died recently in Vancouver. She was born at Murray Harbor, P. E. I., ninety-five years ago. A brother, George, now resides at Murray Harbor. She left Prince Edward Island in 1893, and was one of the three oldest Mrs. De Beck, a native of St. John, aged 106, being the oldest.

SUPREME COURT.—The Supreme Court resumed yesterday morning at 11 o'clock, when a verdict was given for defendant in the non-jury case of Joseph P. Doucette vs. Felix Gallant, an action of ejectment to recover possession of eight acres of land in South Rustico. The court then took up the non-jury appeal case against Russell C. Clarke for having straddled illegally in his possession.

ISLANDER'S DEATH.—The death occurred at Blackville, near Newcastle, N. B., recently of John Corney, aged 65, a native of Charlottetown, after a brief illness. He was an active worker in the Baptist Church and Sunday School and for many years had been active in work connected with the Foresters and Orange Lodge. He leaves to mourn a widow of three years and two daughters and two brothers George of Summerside and Joseph of Charlottetown and one sister, Mrs. Hannah Ross of Charlottetown.

ACCIDENT.—While watching the Orangemen parading on Fitzroy Street near the Arena Bank Monday morning Master Keith Acorn of the seven-year-old son of Mr. and Mrs. Edwin Acorn, was run into by an automobile and had a very narrow escape from being killed. The child was knocked down and received two very bad cuts on the back of the head and another on the knee, all of which require stitching. The little fellow was rushed to the P. E. Island Hospital immediately after the accident and at last reports his condition was quite reassuring.

HAD ENGINE TROUBLE.—One of two men who claimed to belong to a circus which that day performed in Summerside, asked for the loan of a motor boat from Mr. D. A. Pickering, saying that as they had the day to themselves they would like to go for a spin. Mr. Pickering let them have the boat. They seemed to have taken a liking to it for it never turned up that evening. On Saturday afternoon by diligent searching and enquiries the boat was found anchored off McCallum Point, with the motor torn half to pieces. It is supposed the borrowers had engine trouble and in trying to make repairs failed, with the results stated, and finally decided to anchor the boat where it was found.

Mr. Martin was in his usual health and at work within a few yards of his home when the call came and his unexpected death was a shock to the community. SOLD CITIZEN DEAD.—The death occurred suddenly at his home in Georgetown, on Saturday afternoon, of a peaceful and well advanced in years, and although in failing health for some time past, yet previous to his death seemed in his usual state of health, so that his sudden death comes as a shock to his friends. He was of a quiet unassuming nature, and was a most energetic and respected citizen, and was highly respected by those who knew him best.

SUPREME COURT.—In the case of Joseph F. Doucette vs. Felix Gallant an action of ejectment to recover eight acres of land in South Rustico the court gave a verdict for the plaintiff for all the lands claimed and not for defendant as stated by mistake in yesterday's issue. G. Gaudet for plaintiff and Donald McKinnon for defendant. In the case of the King vs. R. C. Clark the court heard argument and reserved decision. The next case was that of Robt. S. Douglas vs. Hartle C. Bowness, action for assault in which the judge had found a verdict for plaintiff. The application now was to set aside the verdict and grant a new trial. The court reserved judgment. In the case of Sullivan vs. Tidmarsh, action tried some time ago for the recovery of a deposit paid on foxes the jury found a verdict for defendant, the judges being divided each way. The case now before the court is that of Lord Yorston vs. R. J. McNeil action for repairs to a ship; verdict being found for plaintiff. Application is now for a non-suit to set aside this verdict and grant a new trial. Johnston, Attorney-General for plaintiff, Bentley and Saunders for defendant.

News of a very sad accident accompanied by fatal consequences reached the city yesterday from Cape Traverse.

Two boys, Otto Doull and Earl Howatt, of that place were riding a bicycle in what opposite Mr. John Campbell's place. It was about 9 o'clock on Tuesday night and dark at the time.

Young Doull was driving the bicycle and the other boy Earl Howatt was on the handle-bars, a frequent practice among boys. In the darkness they collided head-on with team coming towards them, driven by another boy, Claude Howatt, aged 13 years. The impact of the collision threw the boys to the ground with great force.

Earl Howatt had three ribs broken and a blood vessel burst. He only lived half an hour. Dr. Seaman was summoned but the unfortunate

lad was dead before the Doctor could get to him.

Otto Doull was badly hurt about the head and was rendered unconscious remaining in that state until 4 o'clock yesterday afternoon. Up to 11 o'clock last night he had not been told of the sad fate of his companion.

The horse was somewhat cut by the bicycle which machine however was not damaged. Claude Howatt, the driver of the horse was knocked out of the carriage under the horse's feet.

The sad affair is deeply deplored. The deceased Earl Howatt was a son of Mr. and Mrs. Robert Howatt of Cape Traverse. He was 14 years of age.

The injured lad is a son of Mr. Charles Doull and is sixteen years old. Claude Howatt, the driver of the team was a 13 year old boy and a near relative of the deceased. He is a son of Mr. P. S. Howatt. Besides his parents the deceased lad leaves to mourn five sisters and one brother.

It is with feelings of deep regret that we record the death of Miss Lucy McNutt, daughter of the late Mr. Peter McNutt, which took place on Sunday, June 6th, in the Prince Edward Island Hospital, Charlottetown, where she underwent a very serious operation. At first all seemed to go well, but after a few days there was collapse and death ensued very shortly thereafter.

The tidings of her demise came to her many friends as a sudden and grievous shock. The whole community was moved by it. It was so unexpected, for she seemed more vigorous than many of her associates. Since her death, however, it has been learned that she and her surviving sister knew that she was suffering from a malady that might prove fatal at any time, and yet she herself was to all appearances meeting each day with radiant health and happy expectation, thereby showing a courage which had its roots in that unswerving faith in her Heavenly Father which gave to her the sweet realization of the promise "All things work together for good to them that love God."

The late Miss McNutt was a devoted daughter and sister who, up to the very last showed more concern for the comfort of others than all anxiety for herself.

In the congregations of Malpeque and St. James', Charlottetown, where she was so well known and so justly esteemed for her splendid character, her genial disposition, and beneficent work, she will be long remembered. Her activities in the Young People's Societies were ever ungrudgingly performed and proved a fine contribution to the welfare of the church. Her merit to in life may well be expressed in the words,

"In the world For us, therefore I must count worth while."

Active, bright, cheerful, she carried with her sunshine wherever she went. At the close of what was to us an all too brief career she realized that she was leaving a young trust to meet her in the passing hour, and felt that she was not leaving home but was going home to look on "The Angel faces whom she had loved long since and lost a while."

The loss and sorrow to the aged mother who was recently bereaved of her husband was can only feebly conceive. With the mother, the sister Mary, the niece Miss Bagnall who was brought up with the deceased and was a younger sister in the home, the two brothers, Preston and Ernest, and the many mourning relatives and friends, we deeply and affectionately sympathize.
