Largest warship afloat, was believed to be on the way to the Bilbao zone from Gibraltar, thus lending added emphasis to the seriousness of the situation that has developed. The cruiser Strophshire sped to Bilbao from Gibraltar during the weekend while the cruisers Blanch, Brilliant, Beagle and Brazen already were on the coast of Northern Spain.

A full statement will be made in the House of Commons tomorrow on the situation. It was expected tonight.

The Hood, which sailed hurriedly yesterday from Gibraltar for an unannounced destination, was not expected to reach the northern Spanish trouble zone before noon tomorrow.

That the Government considered the situation grave was read into the fact that the session today was only the second meeting of a Cabinet council to be held on 1936 since the general strike of 1926.

Informal sources said the cabinet had to choose between only two decisions:

1. Order the Hood to escort the British merchant into Bilbao in the teeth of insurgent guns.

2. Inform the food ships to try to deliver their cargoes elsewhere.

The Government never has accorded belligerent rights to the two sides fighting Spain's civil war and it therefore was considered unlikely Franco's right to establish a blockade could be recognized.

A possibility did exist, however, that the Cabinet may have decided to accord belligerent rights to the parties in the civil war.

The international "hands-off Spain" agreement prohibits only the exportation of arms and munitions to the Spanish belligerents and bans the flow of foreign volunteers.

Britain in the past has stated she will not tolerate any interference with her shipping on the high seas.

All members were present except Viscount Swinton, Secretary for Air. But an official statement indicated it was not a formal cabinet session.

London Gallery Finds Art Treasure

LONDON, April 10—(CP)—The National Gallery has discovered an old master in its own storehouse. Thought to be a copy, it had been stored away for 60 years.

Now it hangs in the newly opened east wing with the label reading "The Magdalen Laying Aside Her Jewels," by Paolo Veronese.

The painting came to the National Gallery in 1875 as part of the Wynne Ellis bequest and was regarded as a fine copy of the Venetian master.

Experts, however, became interested in it, and Kenneth Clark, director of the National Gallery, consulted heads of many great galleries.

Finally it was established beyond doubt that the painting is an early but authentic work by Veronese, the Venetian artist who ranks with Titoretto and Tizian.

BOSTON, April 9—(CP)—Old friends are the best" writes Dr. W. C. Moore, retired Kentville, N. S. physician, in a letter received here by his boyhood chum, Leslie E. Dennison which relates his wanderings on the Pacific Coast where he and Mrs. Moore are meeting many former King's County natives.

After a lapse of 53 years, Dr. Moore, son of the late Daniel C. Moore, ship owner and merchant of Kentville, has renewed acquaintance with G. Aubrey Davidson, former Kentville Railway worker who became Vice-President of San Diego's Bank of America.

In a month or so Dr. and Mrs. Moore will visit Vancouver, after travelling through northern California, Oregon and Washington by easy stage "for in all our 11 years of travelling we never once slept one in a sleeping car." In the British Columbia city the doctor looks forward to meeting Thad R. Harris his old school mate. "We are the only survivors of quite a large class of little boys and girls who were taught 77 years ago by a Miss Fuller," he said.

LAND PLANES FOR EMPIRE AIR SERVICE

Britain Building Fleet Of 14 Giant Airplanes To Supplement Flying-boat Services.

LONDON, April 11—(CP)—A fleet of 14 giant land-planes will be available within a year or more for Empire air routes to supplement the flying-boat service already in operation.

Initial experimental flights across the Atlantic will be undertaken with flying boats of Cambria type but land planes may eventually go into regular service between Britain and North America.

Some experts question whether the present flying boats could carry sufficient payload in addition to the quantity of fuel necessary for a safe Atlantic crossing. The land planes, of which five are now on the stocks for Imperial Airways, will weigh 20 tons, fully laden. Nine more have been ordered.

On Empire routes the land planes, which will be known as "e" class air liners, will be built to carry 27 passengers on day flights and will have sleeping berths for 20 persons.

They will carry a crew of six, including a ship's clerk—an official whose duties correspond to those of a purser on a ship. Their maximum speed will be more than 200 miles an hour. They are four-engine monoplane, with all metal hulls and retractable landing gear.

Newfoundland Terminus

The projected Newfoundland terminus for flying boats on the Atlantic service is Botwood. Some 40 miles from there, at Hattie's camp, a landing field is being prepared for land planes.

One drawback to use of flying boats is the prevalence of ice in Newfoundland in the spring. In the Irish Free State a flying boat base is being prepared at Rynanna while a land plane base is under construction nearby at Killybegs. It should be ready for use in September.

This brought a strenuous denial from Finance Minister Dunning. He said ever since taking office he had dealt with Alberta on exactly the same basis as other provinces.

The new Combines Investigation Act, passed by the Commons and amended in the Senate, necessitated a compromise at the end and the Government accepted the Senate's proposal "with reluctance," as Labor Minister Rogers put it.

The Senate amendment stipulated that before an investigation may be launched by the commissioner who will be appointed under the revised Act, approval must be obtained from a judge of the Exchequer Court or the President of the Dominion Trade and Industry Commission.

Mr. Rogers said he feared the provision would slow up procedure but was willing to give it a trial for one year.

Mr. Bennett who had fought against some of the powers the original bill would have conferred on the commissioner expressed satisfaction with the change. He said it would give a greater assurance of civil liberty and would lead to greater confidence in the Act since it did not now subject persons to penal treatment before they were proved guilty.

Liberal Protest Tariff

The last dispute of the session occurred within the Liberal Party as a group of low tariff proponents took strenuous objection to an increase in the furniture tariff.

For several hours they pleaded with the Government to drop the item but Mr. Dunning was firm.

The Minister declared out of some 600 changes in the tariff the furniture rate was the only one revised upward this session. The position of the industry necessitated the action and with the recommendation for increased protection the tariff board had coupled a direction to the industry to put its house in order and improve its internal organization.

Later the situation would be reviewed again and meanwhile the increased rate was to be regarded as a temporary measure.

The new Combines Investigation Act, passed by the Commons and amended in the Senate, necessitated a compromise at the end and the Government accepted the Senate's proposal "with reluctance," as Labor Minister Rogers put it.

The Senate amendment stipulated that before an investigation may be launched by the commissioner who will be appointed under the revised Act, approval must be obtained from a judge of the Exchequer Court or the President of the Dominion Trade and Industry Commission.

Mr. Rogers said he feared the provision would slow up procedure but was willing to give it a trial for one year.

Mr. Bennett who had fought against some of the powers the original bill would have conferred on the commissioner expressed satisfaction with the change. He said it would give a greater assurance of civil liberty and would lead to greater confidence in the Act since it did not now subject persons to penal treatment before they were proved guilty.

Liberal Protest Tariff

The last dispute of the session occurred within the Liberal Party as a group of low tariff proponents took strenuous objection to an increase in the furniture tariff.

For several hours they pleaded with the Government to drop the item but Mr. Dunning was firm.

The Minister declared out of some 600 changes in the tariff the furniture rate was the only one revised upward this session. The position of the industry necessitated the action and with the recommendation for increased protection the tariff board had coupled a direction to the industry to put its house in order and improve its internal organization.

Later the situation would be reviewed again and meanwhile the increased rate was to be regarded as a temporary measure.

Before the last election Prime Minister Mackenzie King had declared it was the policy of the Liberal Party to reduce tariffs to the

level prevailing in 1930 when the Liberals left office.

In opposition the Liberals declared they were fighting "shoulder to shoulder" against high tariffs. Now they were fighting "back to back."

"Furniture has triumphed and the flag of victory waves over Waterloo," he said pointing to Hon. W. E. Butler, Minister of Trade and Commerce and member for Waterloo North. The furniture item represented a great advance and proved the Liberal Government proposed to follow the policies of its predecessors and serve the interests of Canada.
