Advices received from Amsterdam last Saturday, credited the Telegraf as saying that the Nieuw Amsterdam was still lying at Rotterdam, because the German government had declined to give a guarantee for her safe crossing of the Atlantic to the United States.

GEN. LAWRENCE IS CHIEF OF STAFF

LONDON, Jan. 24.—James Ian MacPherson, parliamentary secretary to the war office, announced in the House of Commons today that Lieut. General Sir Herbert Alexander Lawrence had been appointed chief of the general staff in France, Col. E. W. Cox, to be a brigadier general on the general staff of the intelligence department, and General Travers Clarke, quartermaster general. These changes, Mr. MacPherson added, had nothing to do with the report to the war council on the recent operations at Cambrai.

To Eldon. The first night they slept in an old unoccupied log cabin, having their packs with them, and the next morning went up to the top of the mountain and staked four claims; this was on August 1, 1915. They called the claims "The Kitchener," "The Joffre," "The French" and "The Lloyd-George." They took in the whole of the mountain, and staked out two more claims, one for R. C. Edwards, editor of the Eye-Opener, and the other for Wood's daughter.

Formed a Company. Returning to Calgary, Mr. MacLeod formed a small company with a few Calgary business men, the capital being \$20,000.

It was the intention of the company to quarry the property, and to make it pay for itself, so roads were built, trails laid and camps pitched. With all the equipment on hand, the men started to take down the ore, when an ice and snow slide came down the mountain that almost killed Wood and another miner, the men being carried down the mountain for a considerable distance.

The snow slide covered the copper ledge with thousands of tons of ice and snow, and so the effort to get at the copper in that way was abandoned.

It was decided to go down below the cut and tunnel across the cut of the copper vein. The process of tunneling was very expensive, as the tunnel was very large, and the miners had to go in 200 feet before cutting the vein.

The tunnelling cost about \$40 per foot, the rock being very hard and the method adopted being primitive. As this operation was too expensive, the company decided to take the men off and to let the mine by contract.

In the summer of 1917 the company decided to work again on the copper vein covered by the snow drift. The ice having been melted, and on one day one of the miners working in the mine, in coming back from work, saw a big boulder as large as a small building that had slipped down, and he was surprised to see it all covered with silver and copper and lead stain.

The miner could see where it had broken off, and he at once looked for the vein. After working from November 1 of last year till last week, the whole time never losing the vein, which was about eight feet wide, with hanging walls in places, the miner found the galena on the top of the mountain, about 1,500 feet above, which covered from 20 to 30 feet of solid galena. He brought a big chunk of it to Calgary, which is now in the office of MacLeod Brothers in their store at Ninth avenue and First street east.

The location of the mine is at Eldon Siding, west of Banff, on the main line of the C.P.R., some four miles by air line from the C.P.R. tracks.

At a time when both the British and French are looking for lead, the find will be of great value to the allies. The assayers found a trace of gold in the ore. The Nelson, B.C., assayer, Mr. Widowski, placed the value of the galena at \$118.83 to \$138.85.

ONLY 6 SHIPS SUNK IN WEEK.

LONDON, Jan. 23.—Again the sinkings of British merchantmen by mine or submarine have been held at a low point. Only six vessels of 1,600 tons or over and two under that tonnage were destroyed in the past week, according to the admiralty report tonight.

The sinkings of British merchantmen for the past week duplicate the sinkings for the previous week—six large ships and two small ones. In the previous week two fishing vessels also were sunk; in the past week the fishing craft escaped entirely.

The admiralty reports of January 22 and January 9 gave the sinkings as 21 merchantmen, of which eighteen were over 1,600 tons in each case. Arrivals 2,255, sailings, 2,242. British merchantmen of 1,600 tons or over sunk by mine or submarine, 6; under 1,600 tons, 2; fishing vessels, none.

Patriotic Maximum Is Now Raised to \$40

OTTAWA, Jan. 25.—A number of important changes to the schedule of allowances allotted to dependents of soldiers have been made by the executive committee of the Canadian patriotic fund.

By the new regulations the maximum allowance for dependents in eastern Canada has been raised to \$40 per month, instead of \$35 as formerly. This increase, which amounts to \$10 within the last three months, is due to the increased cost of living and will assist those wives of soldiers who have large families.

Another regulation provides that the different branches shall not deduct \$5 per month from the wives of non-commissioned officers, with the rank of sergeant or sergeant-major; this has been done in the past. This is due to a uniform scale of separation allowance having been adopted for privates and non-commissioned officers.

It is also provided that there shall be no reduction in the allowance granted to returned soldiers who are "out patients at convalescent homes, on account of the subsistence allowance having been raised from 60 cents to 80 cents per day.

HAYRE, Jan. 25.—The Belgian government's terms of peace, so far as they concern Belgium, herself set forth in her reply to Pope Benedict's peace note, made public today, are in substance absolute political and territorial independence.

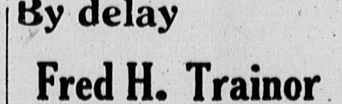
BOHEMIA ASKS INDEPENDENCE.

LONDON, Jan. 22.—(Via Reuter's Ottawa Agency)—In the House of Commons yesterday Hon. A. Bonar Law stated that all the documents connected with the Cambrai inquiry were submitted to the War Cabinet, at whose request Lieut. General Smuts' report was approved by the Cabinet, and was not subject to revision by Earl Derby or any other member of the War Cabinet. The decision not to publish the report was taken by the War Cabinet.
