

CRYSTALS GO INTO LEAD IN ISLAND HOCKEY LEAGUE

Defeat Abegweits In Summerside Last Night By 3 To 2 Score—Thrilling Game All The Way.

(Special to the Guardian) SUMMERSIDE, Jan. 18.—The Crystals tied another knot in their claim to the island senior hockey title last night when they drew the long end of a 3-2 score against the Abegweits in a thrilling game. Both teams furnishing the best brand of hockey that has been seen in the Summerside rink for the last three years. The attendance was exceptionally large.

Manager Gaudet had a mirror-like sheet of ice for the steel-shod warriors, and fast skating, brilliant combination play, fast wing shots and stellar bits of individual play marked a game that had the fans on their feet from the bell to the end.

Both the Summerside and Charlottetown fans welcomed Montgomery Crystal, wing man on his first appearance in a game following a severe leg injury received in practice. He was not able to continue, however, receiving a bad cut in the face from a player's skate in the first period, necessitating several stitches.

The game started promptly on time at 8:30 p.m. Few penalties were given, the ice and the disposition of the players being all for hockey and nothing else.

Anderson drew the first ticket to the pen a minor leave for illegal checking. After a brilliant piece of combination play Silliphant sagged the net for the first tally for the Crystals after seven minutes of play, getting the rubber on a pass from Gallant and countering nicely. First period ended with the Crystals sitting pretty on a 1-0 score.

Second Period.

Three minutes after the whistle blew for the second period, Silliphant repeated with a fast shot to the net getting the rubber on a rebound from a shot by Schurman. Three minutes afterwards Prowse chalked up the first counter for the red and black and the Charlottetown fans had a chance to cheer.

Five minutes afterwards Cox presented the Abegweits with their second and last goal of the evening. Six minutes afterwards, Gallant found the inside of the net for another black and white mark against the visitors. This period was marked with exceptionally fast hockey.

Third Period.

Shortly after the whistle blow for the third period Anderson drew a rest for climbing the back of a Crystal player. The Abegweits made a desperate effort to even the score and Crockett made more saves than the Salvation Army doing brilliant work with feet, legs, hands, sticks and arms.

He was all there and right there at the right time. The Crystals defense gave him splendid support and some excellent work by Gallant, Silliphant and Schurman drew the puck away from what at many times was a dangerous situation for the home team. Collings, the Abegweits goalie, had the admiration of the fans for he played a hard game in his league style. Prowse, the veteran of championship games was up to standard and that is all the fans could want. Anderson as a defense man can both give and take and the fans like to see him do both.

THE MARKETS

MONTREAL, Jan. 18.—A feature of the export trade in Canadian grain here today was the demand that developed from Italy for Manitoba grades of wheat and a moderate amount of business was worked. The trade in cash grains was quiet but a steady feeling prevailed in the market. There was some demand from foreign buyers for spring wheat grades of flour and some sales were made but the volume of business on the whole was small. The demand from local sources was also slow and values were unchanged. A moderate trade was done in winter wheat grades and prices were firm. Prices for all lines of millfeed were firmly maintained under a good demand from all sources. The tone of the market for standard grades of rolled oats was steady with a fair business passing. Only a small amount of business was done in eggs and the undertone continued easy but there was no further change in prices. The receipts were 1,103 cases. The market for potatoes was without any new feature to note, prices being steady with only a limited trade passing. Sales of odd cars of Prince Edward Island Green Mount of tains were made at \$1.15 per bag of 90 lbs; Prince Edward Island white potatoes at \$1.05 per bag of 90 lbs. New Brunswick Green Mountains at \$1 per bag of 90 lbs in bulk and New Brunswick white potatoes at 95 cents of 90 lbs in bulk ex-tracker. The trade in imported beans was quiet but as the offerings on spot and to arrive were small the tone of the market was firm. Car lots of choice white handpicked were offered at \$2.80 per bushel ex-tracker, and smaller quantities at \$2.90 per bushel, ex-tracker. Owing to the continued indifferent attitude of buyers the trade in butter was extremely dull and the undertone was easy. The receipts were 83 packages. There was practically no change in the condition of the cheese trade business being exceedingly slow and prices were unchanged. The receipts were 24 boxes.

Mr. McNeill said, I'm short of funds tonight, the best I can do is to let you have \$10.00 on the check. I gave him the check and endorsed it in front of him, with his own pen. Mr. McNeill told me to call in Monday.

I called in Monday on my way home. He did not get the check cashed.

I received \$5.00 more on the check from him. I called again that night and asked for the balance of the money. He said he hadn't been to the bank yet. I saw McNeill again on Wednesday. I went to his place Tuesday, he was not at home. He gave the same answer on Wednesday as on Monday "he hadn't been to the bank."

I called again on January 5th. Mr. McNeill telling my brother Frank that he wished to see me.

On being informed of the fact I went immediately to McNeill's store. Mr. McNeill was there. I asked him what he wanted. He said the man George Brown forgot to put the number of his pass book on this check and for me to get in touch with Brown. I told him I would probably see Mr. Brown on the street. I saw him the Tuesday after Christmas on Grafton street. I wrote to him on January 6th.

After Mass, I went to the Post Office and wrote the letter. I told Mr. Brown in the letter to write to the Bank and let them know about his pass book. I received no answer to the letter. About the middle of January I was passing McNeill's store, he called me in. I saw Mr. McNeill on different times between January 6th and 20th. He called me in the store and told me the bank was shut down at the bank Court recess at 1 o'clock until 2:30 p. m.

The Supreme Court resumed at 2:30 this afternoon. The direct examination of Lawlor by Mr. McGuigan was continued. Lawlor said that when he was told the cheque was no good, he had a talk with Mr. McNeill. After this discussion he (Lawlor) thought it best to go and see the Magistrate in the city police court to lay a complaint against George Brown. He saw the Magistrate again about a week afterwards, when Mr. McNeill and he went to see him again.

"We went at the Magistrate's suggestion and we saw him at his office," said Lawlor. "The cheque at the time was in the possession of Mr. McNeill."

Witness stated that he went up and saw the Magistrate, who told him to get the cheque from Mr. McNeill and bring it up to him. He (Lawlor) told Mr. McNeill to bring the cheque up to the Magistrate. Three or four days later the Magistrate wanted to see me again," said the witness.

"I then wanted a description of Brown, which I gave as well as I could. Then on Feb. 9th, 1927, I was arrested. I have been in the Queens County Jail ever since. This was the first time I ever appeared on any charge. I never was in Jail before.

This concluded the direct examination.

The Attorney General then began the cross examination. In reply to his questions, the witness stated, in substance: "I enlisted in Sept. 14th, 1914. Don't know the date I went to Valcartier. Was there until the first division sailed to France. I don't remember the exact dates, but I was there about a month. Then I came back to Charlottetown and was discharged. I stayed in Charlottetown for a while, then went to St. John where I remained till Feb. 17th, 1917, then I enlisted again went overseas and was discharged from the army on Jan. 22nd, 1919. Then I went to Boston where I stayed eight years.

I attended Queen Square School. I can read, but am not a good penman. (The witness then wrote, at the request of Mr. Saunders, the following: "I know Fred Smith, but I do not know George Brown. 24th December, 1926. (Sgd.) Fred Lawlor.") I started in the upholstery business shortly after I came home. I got a little business. My establishment was on the corner of Prince and Grafton. Miss Steele visited my place of business about the middle of November. She was there at noon on her way home. I don't know the exact date. A man by the name of Mahar also called twice at my place of business. There was an interval of a week between the two visits.

Ed. Acorn also had a settee and five chairs repaired at my shop. He did not come to my place of business. I met him on the street. This was around the 10th of December. I saw him twice—once when I brought the furniture back to him about the 17th. I met George Brown on the 30th of November. He said he lived at Hazelbrook. He told me that he had furniture to repair.

(At this point counsel quoted evidence taken at the witness' appearance before the court last summer. The sense of this was that witness had stated that Brown did not give him the first day he visited Lawlor. But witness stated that it now appeared to him that Brown did.)

"I arranged with him about the price when he had taken the first lot of his furniture away. I then told him that the charges would be \$37.00. Part of the work had then been done.

Questioned about his method of keeping accounts, witness said: "I have never kept books. Generally I now the men who come in, but I didn't know Brown. I kept no record of my business, as it was not on a large enough scale. I might sometimes have marked items down on pieces of paper. (Here Mr. Saunders questioned the accused very closely about this method of keeping his accounts). "I turn the pieces of paper which had been attached to the furniture, and put them on file. I did this so that I would keep track of the work I had done, for the different customers. I burned all these slips on Dec. 27th. Asked to describe Mr.

"The Fire Brigade" At The Prince Edward Accorded A Rousing Reception.

There has been a number of "Fire" pictures screened at the local theatre but none that can be compared to "The Fire Brigade" which opened a four days engagement at the Prince Edward yesterday.
