No Election In Britain This Year

(Canadian Press) LONDON, Feb. 4.—There will be no general election in Great Britain this year. This announcement was made by Winston Churchill, Chancellor of the Exchequer, in a speech at Birmingham last night. Churchill also vouchsafed the information that there will be no reduction in the income tax in this year's budget, but he left it to be inferred that an attempt may be made to lower local rates.

At the beginning of 1918, he said, there was a deficit for the financial year of more than £150,000,000. Today it was about £95,000,000. It was like a boat race and though he was bearing up well he was not going to make any predictions as to the order when the rival boats of reunion and expenditure would pass the line at midnight March 31st.

The government is being criticized for not reducing expenditures but hopes to have a better tale to tell when it opens the budget next April. The new act granting the franchise to all women must be put into law which would take until spring or summer, 1929. The government would not attempt to snatch a verdict from the electorate under the shadow of budget difficulties.

"BEN-HUR" CELEBRATES A BRILLIANT PREMIERE

Novarro And Bushman Especially Distinguished Themselves; Chariot Race And Sea Battle Win Ovation From Enthusiastic Audience.

Probably the most distinguished audience that ever looked at an exemplar of the Newer Art in this city saw "Ben-Hur" at the Prince Edward Theatre at last night's premiere. Johnny Nemis Won Decision From Joe Irvine, While Toronto Battler, Bill Burns, Had The Edge On His Opponent, Young Dempsey. --Two Preliminary Bout Ad-ded Interest To Program.

Johnny Nemis, the fast moving Sydney welterweight, won the decision from Joe Irvine, the popular St. John welterweight, in the first of the best bouts ever seen in this part of the country. Nemis kept after his opponent at all times, putting a snappy left hand to good effect. His right-cross also did Irvine plenty of damage. Irvine had his opponent in a bad way in the third round, but failed to follow up his lead, this round a hard left, following a short right had Nemis backing away and quite groggy, however, the next round found Nemis in good shape and forcing the fighting.

Irvine took a terrific beating towards the latter part of the bout, but finished the ninth round with a burst of speed that brought the fans to their feet. The St. John boy proved his worth and gained many friends on the strength of his wonderful showing against the younger opponent. THE MARKETS

OTTAWA, Feb. 6.—Fresh egg markets continue firm, but sales of storage are inactive at lower prices. TORONTO.—The local situation is unchanged. Country shippers report increasing receipts. They are paying for extras 38; firsts 36; seconds 23, and are making sales at extras 42; firsts 39-40; seconds 24 f. o. b. H. C. eggs are selling spot at extras 44-45; firsts 42; pullets extras 37. MONTREAL.—The egg market here is firm with a good demand for fresh eggs which are jobbing at extras 46; firsts 41; pullets extras 37. Storage eggs are dragging at extras 33; firsts 31; seconds 26. EDMONTON.—With heavy stocks on hand the egg market here is weak. Dealers are quoting country shippers extras 34-36; firsts 32-33; seconds 25-26. VANCOUVER.—Ten cars of eggs were shipped east from this centre last week. Prices are unchanged with the majority of firms quoting producers extras 25; firsts 25; seconds 22. ST. JOHN.—The egg market here is more settled than it has been for some time. Receipts are steady with slight increase. Dealers are paying country shippers extras 35; firsts 31; seconds 24. CHICAGO.—Spot 33; February 26 3/8; March 27 1/4; April 27 1/2; New York.—Fresh firsts 36.
