RELIGIOUS SERVICES

TRINITY UNITED CHURCH

Notwithstanding the cold and blustery winter weather there was a very fair attendance at the morning service. Rev. J. W. Barbour preached the sermon from James 4-8, "Draw near to God and He will draw near to thee. It is natural for us to turn to God in times of great stress and strain. Reference was made to the many expressions of appreciation of the Memorial Service held last Tuesday. It was a significant tribute of loyalty and national unity. We are bound together by ideals and principles and by a deep sense of brotherhood. "It has been a great inspiration to me" said Mr. Barbour, "during the past two years to find such cordial goodwill amongst Ministers and people during the week of prayer in this City." He found cause for gratitude in the hearty cooperation and support which Bishop O'Sullivan has given to the Ministerial Association in matters of moral and spiritual concern and for better Sunday observance. The black and purple tinting used by the King's Daughters in decorating the Church for our service last Tuesday "was graciously loaned by the Bishop so that though we were worshipping in different churches in the city there was charity and goodwill between us. That is the basis of Christian faith. Speaking of the confused conditions existing and the international situation he said, "anyone who is awake must see that social change is inevitable." In the midst of our turmoil there is only one refuge. Draw nigh to God and He will draw nigh to thee. In prayer we shall find our direction. Prayer needs preparation. It is most effective when it is accompanied by sacrifice and service.

At night Rev. Hugh Miller preached on the Revolt of Youth. His text was 1 Timothy 4-12. "Let no man despise thy youth" and his concluding prayer was for God's blessing on the youth of this and other lands.

The music of the day was stirring and comprised an Anthem, "Te Deum Laudamus" in the morning, and "Jesus Saviour Pilot Me," in the evening also a Choral "Saviour, breathe an evening blessing."

Both services were broadcast. This afternoon from 3.00 to 4.30 p. m. members of the W. M. S. will be in the Social Hall to receive and pack the clothing which the congregation are sending to the distressed districts of Newfoundland.

ST. JAMES CHURCH

In spite of the blustery weather there were good attendances at St. James Church yesterday when the services were conducted by the minister, Rev. Dr. R. Moorhead Legate, D.D. His morning sermon on the mercy of God to men was based on Genesis IX and 15, and Revelations IV and 5: "I do set my bow in the cloud, and it shall be for a token of a covenant between me and the earth." There was a rainbow round about the throne. As long as life lasted on this earth the rainbow would stand as the visible witness of God's covenant. The solo part in the anthem, "O Come to My Heart, Lord Jesus," was taken by Mr. Lyster MacInnis.

The evening service was well attended by regular worshippers as well as several visitors, and was of an evangelistic nature. Dr. Legate took as his text, "If a man have one hundred sheep and one of them be gone astray, doth he not leave the ninety and nine and seeketh that which is gone astray," from the eighteenth chapter of St. Matthew's Gospel. The minister stressed the necessity of having an understanding of the source of our Christian doctrine, and pointed out that religion will have no meaning for us until we come to the realization that we are, each of us, wanderers. Immense truth lies behind the apparently simple text which reveals to us the limitless, unchanging, unceasing love which God has for us.

The choir rendered as an offertory number "Softly and Tenderly, Jesus is Calling," from the Book of Praise.

HOLY REDEEMER CHURCH

Yesterday was the Feast of the Purification of the Blessed Virgin Mary; also Candlemas Day. Candles were blessed previous to High Mass by the Rector, Rev. H. I. brooke, twice before the Court of Appeal at Montreal and once before the Supreme Court of Canada at Ottawa.

For four years the death of Ludwig Chapdelaine and the fight of his widow, Beatrice Bernard Chapdelaine, against a charge that she murdered her husband by poisoning his soup has been a cause celebre in Quebec's legal history.

The East Angus taxicab driver died in agony in St. Vincent de Paul Hospital in Sherbrooke in March, 1932. A coroner's jury first brought in a verdict of death from natural causes but four months later the widow was arrested and charged with murder.

She faced three juries in Court of King's Bench. She was convicted twice at Sherbrooke, each time being sentenced to be hanged. The appeal side of the Court of King's Bench granted a new trial after the first conviction but dismissed an appeal after the second conviction. As the Appeal Court was not unanimous the case was taken to Supreme Court of Canada which granted a third trial, venue being changed from Sherbrooke to Quebec.

In each case the successful appeal was based on claims that the trial judges permitted statements to be illegally admitted into evidence. Argument at all three trials centred largely around circumstances of death. Doctors of the Sherbrooke hospital, backed by Dr. Rosaire Fontaine, Quebec medico-legal expert, expressed the "conscientious" belief that the man died of arsenic. Dr. I. M. Rabinowitch, an expert on poisons and stomach ailments attached to the Montreal General Hospital, testified his conviction the man died of plomaine poisoning or arsenic. Arsenic would have shown itself in hair of the scalp he said. None had been found there.

Throughout the case weighed the figure of Mrs. Chapdelaine's brother, Gedeon Bernard, who was tried in 1932-33 on a charge of murder in connection with the same case. He was convicted of manslaughter and sentenced to five years imprisonment.

Bernard testified he procured arsenic and gave it to his sister. After the second trial he wrote, and swore to, a letter from prison in which he repudiated this testimony. The letter had been written because "prisoners bothered me." He reaffirmed his original testimony in the third trial.

The first trial ended in dramatic circumstances when a juror became ill in the final stages. Rather than have a mistrial, the court decided to end the case around the juror's bedside—in the same hospital where Chapdelaine died.

With fellow jurors sitting in his room the juror heard the last testimony, argument by counsel and Justice C. D. White's summing up. A verdict of murder was returned and sentence of death pronounced. That was on Dec. 17, 1932, and the sentence was to be carried out on March 17, 1933.

Reprieve pending appeal followed. The Appeal Court granted a second trial which ended on Jan. 24, 1934, with a second conviction. Justice Louis Cousineau sentenced the woman to die on April 13, 1934. Again there was a reprieve and an appeal, which went from the Quebec Appeal Court to the Supreme Court of Canada. That body on Nov. 26, 1934, granted a third trial. Venue was changed to Quebec when defence claimed the case had attracted such wide interest in the Sherbrooke district an impartial hearing would be difficult.

WHOLESALE JAIL BREAK IS HINTED

(A. P. By Guardian's Special Wire) JOLIET, Ill., Feb. 2—State's Attorney W. R. McCabe today announced he had obtained information that convict companions of the slain Richard Loeb were planning to blast their way out of the Stateville penitentiary.

Officials promptly depreciated the story but the prosecutor, heading the probe into Loeb's death, asserted he would demand that prison authorities dig up the yard in an effort to find buried explosives. McCabe said he had learned several hundred pounds of celluloid had been mixed with chemicals taken from fire extinguishers and that the mixture had been canned and cached in the yard.

CELLULOID MISSING

"The celluloid is missing from the cell occupied by Loeb and Edward Skopelowski, Chicago robber who used it to make rings and other trinkets," McCabe told reporters. "I have been informed four or five extinguishers have been drained and that from these elements a deadly explosive had been manufactured."

"I am going to question Skopelowski tomorrow and ask penitentiary officials to dig up the yard."

It will also seek to find an answer to the question "Was Loeb the genius behind this plot?"

HACKED TO DEATH

McCabe said questioning of Skopelowski shortly after Loeb was hacked to death by James Day in a razor fight in a prison bathroom had brought out that Loeb "kept books" for Skopelowski's trinket business. He said he had established that Skopelowski received celluloid strips in 100-pound lots and that several of these were reported missing.

"Perhaps Loeb would be able to give us an account of the stuff," he added. "If he were alive."

He promised to interrogate a number of inmates in an effort to learn more of the alleged conspiracy and to substantiate his belief that Nathan Leopold, partner of Loeb in the 1934 "thrill killing" of Bobby Franks, part depicted in "a deliberate plot to murder Loeb."

CONTRIBUTION OF THE CHURCH TO CIVILIZATION

"What does civilization owe to the Christian church?" was the question answered by Evangelist F. W. Johnston in his lecture Sunday night at the Brighton Club Room. He said that the world in general owed considerable to the influence of the church of Christ; for while it is true that the great masses of the world have not become Christians yet the fact is undeniable that wherever the Christian church has flourished, and has planted its standards, it has had a subduing effect even upon those who have remained unconverted. But as Mr. Johnston said, take away the church of Christ, cast aside its great principles, and civilization is doomed, and the world ever after will be an unsafe place to live in. Our common civil law and the protection it affords has gotten its principles from the church of Christ. Our parliamentarians, our senators, our judges and civil officials in general, while not all Christian by any means, yet the principles that have guided them in reaching their decisions have to a large extent been dictated by the church. But let all such be replaced by infidels and atheists, the men who have no regard for the principles of Christ, where then may we ask will be our noble civilization? It would be doomed to destruction.

Mr. Johnston spoke of the atmosphere surrounding the church of Christ, that wherever it flourished there was a sympathetic feeling toward suffering humanity. Hospitals, sanitariums, orphanages and the like, homes for the poor and the aged, and similar institutions these he said, spring up in the atmosphere of the Christian church. But wherever we find atheism and infidelity he said that no such works of charity spring up in such an atmosphere.
