THE TRIAL OF MORTON MCNUTT

For Attempted Murder By Gun at Truro

MRS HAMILTON'S STORY

The Defence Will Plead Insanity—The Prisoner's Mother Testifies In His Favor.

MORTON MCNUTT'S TRIAL.

TRURO, Nov. 18.—(Special)—The trial of Morton McNutt for the attempted murder of his wife and his mother-in-law, Mrs. John Hamilton, commenced today. The jury was selected from the first panel.

MRS. HAMILTON'S TESTIMONY.

Several witnesses were examined for the Crown but Mrs. Hamilton was the only one who knew anything about the shooting.

She described how the shooting of his wife occurred in the sitting room and how witness received one shot in the arm.

THE DEFENCE INSANITY.

After some medical testimony the case for the Crown closed.

Counsel Biglow in opening for the defence said he was going to prove that McNutt was insane and that certain members of his family had previously been predisposed that way.

The prisoner's mother gave evidence this afternoon.

KING EDWARD INTEREST.

NEW YORK, November 14.—King Edward is reported to be considering the expediency of reviving the old custom of always having a member of the ministry at court, except when he is in residence at Buckingham Palace, says a despatch to the Tribune. This change will make it necessary for some member of the ministry to be at Windsor or Sandringham as well as Balmoral whenever the King is out of London. If it be adopted, it will be a fresh proof of the active interest taken by the King in public affairs.

LAURIER A SICK MAN.

OTTAWA, November 16.—Sir Wilfrid and Lady Laurier had many visitors today on the eve of their departure for "the Sunny South." All the ministers in town called to say good-by to their leader. Sir Wilfrid will be away fully a month, and perhaps longer. The prime minister is too sick a man to discuss political affairs at the United States capital just now, although he may call there on his return.

PRINCE EDWARD DEAD.

LONDON, Nov. 16.—Prince Edward of Saxe, Weimar died here this morning. He was attacked by appendicitis Thursday, and succumbed to congestion of the kidneys with which the original malady became complicated. Prince Edward was born near London in 1833, and was married morganatically in 1851 to Lady Augusta Gordon-Lennox.

CHOLERA RAGING IN PALESTINE.

LONDON, Nov. 18.—(Special)—Cholera is spreading in Palestine. The population of Gaza and Lydda have been decimated and the people are taking flight.

At Jaffa there have been 57 deaths in three days. The disease is also raging in the neighboring villages.

WESLEY VANWART ESTATE.

FREDERICTON, November, 16.—Have-lock Coy, referee in equity, has handed in a report concerning the estate of the late Wesley Vanwart. Claims were allowed against the estate of \$43,511, besides the claim against the firm of Vanwart Bros., of which former Judge J. A. Vanwart, now living in England, \$29,000. The personal estate will pay sixty cents on the dollar of the first group, nothing on the second. The estate assets include \$28,000, life insurance. An additional insurance of \$52,500 is payable to the widow, who now resides in Chicago.
