beginning with Richeson's antecedents in Amherst (Va.) until he settled down to the pastorate of the Baptist Church in Hyannis, the detective traced their man. Reports of his associations with women were investigated and the women found and the rumors either proved or disproved. As a result volumes of testimony were compiled and were ready for use at the trial.
In all Miss Patsy Felts, now dying in Salt Lake City of consumption, aroused the greatest interest. Richeson became engaged to her in 1903. She lent him money when he was a student at William Jewell College, at Liberty (Mo.), of which her father was one of the faculty, helped him with cash when he was studying in Boston. Jan. 16—It was Mr. Edmonds who retained the lawyers to defend Richeson, with the exception of Attorney John L. Lee, who was retained by Mr. Richeson's father. But after Richeson was sentenced, Mr. Lee returned to Virginia, and the burden of Richeson's defence was left on the shoulders of William A. Morse. And now it is known that after spending almost \$20,000 in the attempt to establish the innocence of the man his daughter loved, Mr. Edmonds has withdrawn his support.

at the Newton Theological Seminary, and stood by him to the very end. She advanced him a total of about \$700 and the obligation was not discharged until after Richeson was arrested for the murder of the Linnell girl, when she received a cheque for \$167.66 from his counsel and a request that she send back a promissory note she held, and such letters from Richeson as she had kept.
Miss Felts was probably Richeson's first sweetheart after he passed beyond the age of "calf love." There were other women encountered in the countrywide search, but she seemed to be the one to whom he constantly held out promises of marriage as soon as he had secured a church. Even on the day after the death of Miss Linnell he wrote a letter at the house of Miss Violet Edmonds and told Miss Felts that soon, in that very month of October, he would be on his way west, where he could seek a church that he might "preach to thousands instead of to hundreds." The deception of the man was such that it was believed in the east that Patsy Felts was an elderly person who had befriended Richeson because of his evident desire to become a clergyman. Instead, she is said to be a year or two the junior of Richeson and has been in Salt Lake City for two years at a sanitarium seeking to recover from tuberculosis. Now her condition is such that she will be moved to Arizona soon in the hope of saving her life.

In the institution, Mrs. Snead disappeared. Boyce drew \$50,000 from his bank and then he, too, dropped from sight.
Snead's first thought was that the couple had eloped. He placed the matter in the hands of detectives with the result that young Boyce and Snead's wife were located in the Canadian west.
WINNIPEG, Man., Jan. 15—A.G. Boyce, whose father was murdered in North Worth Saturday by J. B. Snead, with whose wife young Boyce had eloped, arrived in Winnipeg last night, and talked freely. He said he had been in Regina.
"I feel it is my duty to get back home at once, and yet they say that I should stay here for a time till the whole thing blows over, and I don't know but that might be the best way for all concerned, but the more I think the more I feel that I must get back at once. You can't imagine what a man this Snead is. He treated his wife most shamefully, and I don't believe he had any good intentions towards her when he got her back. Why this last murderous act of his is only on a par with the way he has been treating the poor woman all along, and to think what she will feel after this last act.
Throughout Boyce spoke quite calmly, but it was evident that he was under a severe mental strain. He said further that when he went out to Regina he was under the impression that the matter would soon be hushed up and that he would be able to settle down in peace and live a decent and quiet life in the Canadian west. He had been interested in farming and stock raising from his earliest days, and he thought he could do well out there in the new country, and still be in close touch with his friends at home.

RICHESON BARED BREAST TO PASTOR

BOSTON, Jan. 16—What is to be done with Rev. Clarence V. T. Richeson, sentenced to die for the murder of Avis Linnell, depends in a large measure upon the action the governor's council takes tomorrow upon the petition for clemency of Silas N. Phelps, also sentenced for murder.
Should the council commute Phelps' sentence to life imprisonment, it is argued by some that Richeson would have some chance of spending the rest of his life in jail, instead of going to the chair.
There was a conference lasting five hours at the office of William A. Morse yesterday. The counsel for Richeson said that he had not heard from Richeson's people since the pastor confessed the murder, but he does not think that the convicted clergyman's family has completely deserted him. After the conference Mr. Morse visited Richeson in his cell at the Charles Street jail.

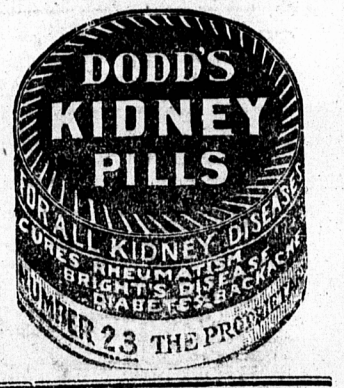
he finally told all to Mr. Helms. It was an emotional recital and came suddenly after a breakdown.

Richeson's lawyers were consulted with the prisoner's consent. He had made it clear that it was not to be accepted as a mere confession to a spiritual adviser, which would have remained inviolate as are the details now. The written acknowledgment followed several days after.
"I'm sorry not to be in a position to discuss the matter," said Mr. Helms. "It is out of the question. I would like to run a country newspaper before entering the ministry and I fully appreciate the news value. It would make absorbing reading. I have been carrying many weighty things in my mind, but they are too sacred to discuss.
"I could not possibly say anything without violating solemn pledges and responsibilities."
If Richeson had had his way Avis Linnell would have been dead forty-eight hours before she swallowed poison on the evening of Saturday, Oct. 14. It has just been learned that Richeson telephoned to Miss Linnell at the headquarters of the Young Women's Christian Association on the evening of Thursday, Oct. 12, and urged her to meet him that night. The police say if she had consented she would have received the fatal capsule then instead of the following Saturday afternoon.
Girl friends and attaches of the institution heard Avis exclaim: "I can't possibly see you this evening. There is a party here and I cannot leave. I shall have to let it go until Saturday."
It was learned today that the Pinkertons were employed to send detectives from their agencies in various parts of the country to gather information about Richeson. The government had no men available for such a search. General Superintendent Letch, whose office is here, went to Kansas City to direct the search in

FATHER SLAIN BY MAN WHOM SON WRONGED

FORT WORTH, TEX., Jan. 15—Before a score of witnesses in the crowded lobby of a hotel here J. B. Snead shot and instantly killed A. G. Boyce Sr., owner of the biggest ranch in the world, whose son eloped with Mrs. Snead several months ago. The killing came as a startling climax to the dramatic drama, on which the curtain apparently had been rung down when Snead, after a country wide quest that had cost him \$23,000 overtook the fleeing couple and effected a reconciliation with his wife.
One day last fall Mrs. Snead told her husband she had fallen in love with the younger Boyce, who had been a neighbor of the Sneads for several years. She said she had learned to care so much for the ranchman that she willingly would desert her husband and two children. Mrs. Snead pleaded that her husband allow her to take the children and go with Boyce, a bachelor, to South America. Snead's answer was to have his wife examined by alienists, who recommended that she be committed to a sanitarium here. Several days after she had been placed under treatment
