THURSDAY

Apparently the overseers of the poor in Suffolk, England, are very anxious that steps should be taken whereby the so-called "Go Preachers" should not be allowed to continue conducting their meetings in the Maritime Provinces, and other parts of Canada. Already several different kinds of literature has been received at the local police station warning the people to take no heed to the doctrine preached by them and yesterday afternoon Chief Rideout received a card of which shows a picture of a horse with the words, "It's no use locking the stable door after the horse is gone." On the inside of the card is printed several articles which gives many reasons why the doctrine of the "Go Preachers" should be heeded.—Moncton Transcript.

Mrs Mary A. Myers, widow of the late Isaac Myers, died at her home at Hampton at 12.30 o'clock yesterday morning, aged 72 years. Mrs Myers had been suffering for some time from invalid trouble and had been bedfast for the past two months. Her loving mother and friend, she will be sorely missed by her family of two sons: William at Candie, Alaska and George at Hampton; and two daughters: Mrs D. H. Haslam, Duluth, and Mrs E. McKinnon, Hampton, who have the sympathy of a large circle of relatives and friends. The funeral will take place this afternoon at 1.30, Rev Mr Thompson and Rev Wm McLeod officiating. The pall bearers will be—Jabez Lea, John S. McQuarrie, James Inman, W. H. Inman, Wm H. Ferguson and K. C. Holm.

Word was received in this city yesterday of a robbery which occurred at Pownal on Sunday night. The circumstances surrounding the burglary itself are not known but the transpiring events which led up to it succeeded it are of interest. It appears that Cameron Robertson, Pownal, who conducts a general store at Klondyke Corner, about a half a mile from Pownal, had a sum of money, totalling one hundred and eighty dollars, which he was keeping in his house. This amount seemed to be rather large for one to have laying around a house, so Mr Robertson, before going to church on Sunday evening, carried the money over to the store and placed it in the till and on leaving, it is supposed, locked the door carefully. He went to church and afterwards proceeded to his home without calling at the store. When opening the shop door Monday morning he discovered it unlocked. He immediately went to the till and found that the cash had disappeared. There was absolutely no clue to the robbers, and it is not positively known whether the door was opened by a duplicate key or whether it was found open. At any rate the money is gone and with it all traces of the parties who so generously helped themselves to Mr Robertson's cash.

A meeting of the Northern Farmers' Institute was held in the hall at Pownal, Saturday evening, Nov 20th. The President, Adam Brown, took the chair and after a few introductory remarks introduced Prof. Ross to the meeting. The Prof began his address by taking up the subject of Farmer's Institutes and the necessity of farmer's organizing to look after their own interests in the way manufacturers and other professions organize to further their interests. He showed that the Institutes had done and were doing good work for the farmers and members. He then spoke on the reports published by the different branches of the Department of Agriculture and showed how there were lots of valuable information to be gained by studying them. He spoke after this for a short time on Dairying. Christopher LePage asked what could be done to protect the cattle from the horn fly. Walter Buntain stated that much could be done to lessen it, if all the farmers in the neighborhood would turn over the manure in the pastures. The President, A. Brown, made some remarks and asked some questions after which a vote of thanks was moved by Rev Dr. Chaisson and seconded by Mr Gallant. The President then thanked the people of Pownal for the use of their line hall, after which the meeting adjourned.

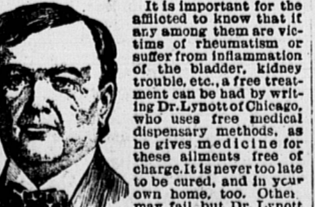

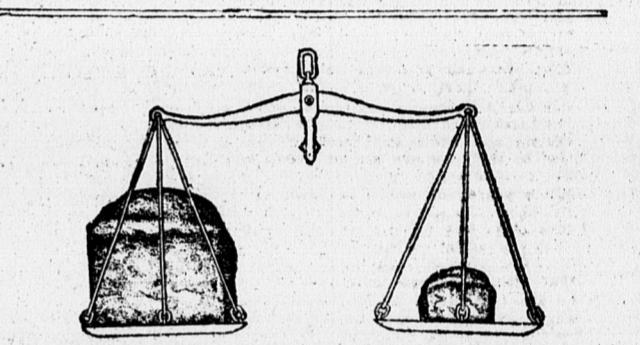
