Baroness Loses Sight In Crash

By Guardian's Special Wire) GERONA, Spain, Aug. 9.—Physicians said today that Baroness Maud Von Thyssen will be blind in one eye as the result of the automobile crash last week in which Prince Alexis Mdivani lost his life. The doctors in attendance on the Baroness expressed confidence she would recover but said they could not save the sight of her right eye. They said the left eye was also badly injured but that the pupil was intact and they believed it could be saved. She has not yet been informed of Prince Mdivani's death. Her husband was reported to have visited the home of Mdivani's sister, Senora De Sert at Palamos, and to have engaged in a heated discussion there. The Baroness refused to comment but it was rumored the discussion possibly concerned a suit for damages against the Mdivani estate.

Trade with the Antipodes shows a further expansion. Sales to Australia rose over \$18,000,000 in the year ended June last, an increase of nearly \$5,000,000 over the previous twelve months, and purchases from that Dominion totaled over \$7,000,000, an increase of a little over \$1,000,000. Exports to New Zealand amounted to over \$5,000,000, an increase of \$3,000,000 and purchases from New Zealand were \$2,400,000, a decrease of nearly \$1,000,000. Sales to South Africa were \$12,800,000, an increase of \$4,000,000, while imports from that Dominion were \$4,225,000, a slight increase.

One of Good Spots

The severance of friendly relations between the two countries not having occurred until the beginning of August, Canada's trade with Japan for the year ended June again showed one of the few satisfactory conditions in this Dominion's dealings with foreign countries. For the twelve months ended June this Dominion's sales to Japan were nearly \$18,000,000, an increase of \$4,500,000, while Canada's purchases from Japan were, officially, \$4,350,000, an increase of \$600,000. This total of imports would be much larger if there were included the Canadian importation of silk which is of Japanese origin, but which reaches the Dominion via the United States.

With all the European countries, excepting the three Scandinavian nations, there was a further decline in business. Sales to Belgium were \$11,000,000, a drop of \$1,000,000, to France exports were \$9,000,000, a decrease of over \$2,000,000; to Germany they had slumped to a little over \$3,000,000, as compared with \$10,000,000 in the previous twelve months; to Italy exports were \$3,500,000, a drop of \$200,000; to the Netherlands the sales amounted to about \$3,000,000, a decrease of \$1,000,000, while the exports to the various Central and South American countries, though not large in volume showed further important increases.

BIG INCREASE IN FISHING EXPORTS

(C.P. By Guardian's Special Wire) OTTAWA, Aug. 9.—The world at large, and Canada in particular, is eating more Canadian fish than previously. This is brought out by government statistical figures, says the weekly statistical review of the Trade and Commerce Department. Canadian exports of fish and fish products in the first half of this year totalled \$9,363,676 and went to 66 countries and groups of countries in the world. This was an increase of \$856,000 over the corresponding period last year and more than \$2,000,000 over the same period of 1933.

For the calendar year 1934, Canadian fishery exports totalled \$22,150,952, as compared with \$20,050,172 in 1933 and \$18,498,466 in 1932. Deducting these exports from domestic production figures, statisticians said that Canadians consumed Canadian fish to the value of \$12,000,000 in 1934 and approximately \$7,500,000 in both 1933 and 1932.

Canada's most important customer is the United States which takes most of the Dominion's shipments of fresh fish. Exports to the United States this year to date totalled \$4,460,504 of which fresh fish accounted for \$3,815,560. In the corresponding period last year exports to that country totalled \$3,983,607 of which \$3,339,947 were fresh fish. Exports to the United Kingdom totalled \$1,889,123 this year mostly made up of canned fish as compared with \$1,723,493 in the first half of last year. Exports to Australia have steadily increased from \$462,232 in the first half of 1933 to \$462,883 in 1934 and \$570,096 this year to date. The British West Indies and other British colonies in the Caribbean imported Canadian fish, mostly dried and salted, to the value of \$551,694 this year.

three-power conference on the Italo-Ethiopian dispute. Great Britain, France and Italy are to meet at Paris next week and in conversations based on their 1906 treaty endeavor to find a solution for the present impasse, which otherwise will come before the League of Nations Council Sept. 4 in all its stubbornness.

The Suez Canal question may be the first problem to settle, if the three-power parley should fail, informed observers said tonight.

May Be Requested

The special phrase used by Eden, "the Council will have to discharge the obligations placed upon it in the Covenant," signified literally that invocation of Article XVI will likely be requested, probably by Ethiopia, if the deadlock is unrelieved. If such an extreme measure is taken it is asserted Great Britain would give its unequivocal support.

Article XVI provides immediate application of economic and military sanctions against an aggressor.

The principles by which the convention of 1888 established the canal charter left nothing open to clearly and to the terms specify more than once that the canal is to be left open to both merchant and warcraft.

But the objection raised by the Italian foreign affairs magazine Affari Esteri that the League has not the right to modify this convention because its validity was recognized in the Versailles Treaty itself is not valid, it is felt here. The London Law Times has already urged this step should be seriously considered.

HONORED AS HEROES

(A. P. By Guardian's Special Wire) ROME, August 9.—Seven Italians who were found burned to death in an airplane near Cairo were honored tonight as the first heroes of Italy's East African campaign. Newspapers assured the nation "they have not died in vain."

The Giornale D'Italia said one of the victims, Luigi Ranza, Minister of Public Works, as enroute to Eritrea "to organize public works which would make more secure an East Africa which must be opened to Italian labor and civilization."

It also said another of those killed, Raimondo Franchetti, an explorer, was "one of the pioneers of Italy in Africa and explored those territories which must be opened to our work." Franchetti was an authority on the Ethiopian hinterland.

Full state honors were ordered for Ranza and his companions by Mussolini himself, he was described as profoundly saddened by the tragedy.

Francesco W. Gerard, former United States Ambassador to Germany categorically denied tonight London reports he had come to Rome to confer with Premier Mussolini on the Ethiopian situation as a representative of the American Government.

SEEK JAPANESE CREDIT

ADDIS ABABA, August 9.—(AP)—One man Ethiopian mission hastened toward Japan tonight, presumably in an effort to secure credits for the purchase of war supplies, another indication of the Japanese had worked out an understanding for Japanese economic expansion in Ethiopia and the safeguarding of any capital Japan may stake on the side of Ethiopia.

The Emperor's war council, confronted by stocks of only about 11,000,000 rounds of ammunition, was reported to have decided upon the sternest measures for their conservation in event of war.

MAY LIFT ARMS BAN

LONDON August 9.—(AP)—Great Britain's temporary ban on arms shipments to Ethiopia may be lifted in the event of a failure of the three-power conference in Paris next week on the Italo-Ethiopian dispute, it was learned tonight.

The British said convinced the conference with France and Italy will definitely determine whether there will be war or peace. If no solution is reached the Government may decide to let arms go forward.

English press reports asserted the United States is taking an active interest in the controversy and that James W. Gerard, former American Ambassador to Germany, as enroute to Rome at Washington's request to talk things over with Premier Mussolini.

(Officials of the Washington State Department said they were unaware of any order dispatching Gerard to Rome as an official representative.)

The Ethiopian Legation declined with thanks today the request of hundreds of Englishmen that they be allowed to enlist in the Ethiopian army.

N.B. TUBER YIELD BELOW AVERAGE

Crop Curtailment Not So Great As First Thought, However, Is Claim.

(C. P. By Guardian's Special Wire) FREDERICTON, N. B., Aug. 9.—Another three weeks will elapse before the new potato crop in New Brunswick to the Upper Canadian markets gets under way is the opinion of agricultural officials. In some sections of Victoria, Carleton and York counties, the early-type Irish Cobblers are barely ready for digging after a growing season of three months. There is no demand at the present time for New Brunswick early tubers in Montreal and the price situation still is adverse. The general harvesting of the late crop of Green Mountains will not be under way until the end of September or early October.

Speculate On Crop

While there is much speculation in the potato-belt at the present time the probable extent of yield curtailment for the year is difficult to estimate. It is stated here today by O. C. Hicks, superintendent of the provincial soils and crops division. Reports of a curtailment of forty per cent in Carleton County this season compared with last year are believed to be exaggerated, although there is no doubt that there will be some reduction.

The acreage placed to potatoes in New Brunswick this year was reduced to twenty to twenty-five per cent of last year's acreage. The yield, which prevails in most areas, will also take some toll of the crop, but the blight situation has not become serious as yet, and there is no reason to believe that the general reduction in the yield will be as serious as at first thought.

Survey Underway

Growers in some localities have observed that the potatoes are turning out poorly, there being few tubers in a hill in some places, but how general this situation is remains to be observed by officials of the Federal Inspection Service, who are now making their second survey of the season. It is reported from Carleton County that the yield-per-acre this year is from 80 to 100 barrels on the average compared with 100 to 120 barrels per acre last season.

Transient To Be Tried By B. C. Court

(C. P. By Guardian's Special Wire) CALGARY, Aug. 9.—Charged with obstructing a Canadian Pacific Railway train at Golden, B. C., when the rails were greased, John Woods, a transient arrested in Calgary, will be returned to the British Columbia town for trial. Woods, already serving a 21-day jail sentence for illegal riding, appeared before Magistrate H. C. Scott today and was remanded to custody of the Royal Canadian Mounted Police. The offence was committed in British Columbia and Magistrate Scott stated he had no jurisdiction to hear the case here. Woods was charged under the Criminal Code. Only one train-rider appeared in court today. He was fined \$10 and costs or 10 days in jail.

VICTORIA, Aug. 9.—British Columbia provincial police records today confirmed reports a Canadian Pacific Railway freight train had been stopped by greased rails east of Golden, B. C., on Tuesday but denied reports that the train itself had caused trouble in the town itself.

Karlton Hackett, President of the Company, announced officials had agreed to present to Insull a suitably-inscribed key to the front door of the opera house.

Internal Strife Grips Germany Despite Domestic Improvement

(Associated Press Foreign Staff) (A.P. By Guardian's Special Wire) BERLIN, Aug. 9.—Germans get a two-sided picture tonight in which a reduction of 122,000 in unemployment lists bespoke domestic well-being while disorders and agitation showed difficulties abroad.

Save for brief reports of actions against Jews and Catholics in the provinces, newspapers turned from these worries to cheer unanimously a cut in unemployment during July to 1,754,000. This figure does not include 168,000 officially classed as "emergency workers," such as those sent to farms who are earning a pittance.

A shortage in certain food supplies led to a report three high officials would meet Monday on the question.

Secret police issued a statement saying Catholic youths were responsible for a fight at Krefeld yesterday in which a group of 15 year old Hitler youths was attacked and two were injured.

Reports from Saarbruecken indicated anti-Jewish action there in controversy of the pre-plebiscite agreement at Rome and that a new plebiscite would be asked.

A Catholic priest at Fichtelberg was officially ordered to discontinue religious instruction because he allegedly incited youths against the state Nazi movement.
