## URGENT SOLUTION OF THE IRISH QUESTION

### Railway Workers Ask for Meeting Between Mr. Lloyd George and a Deputation Representing All Ireland. Further Disorders.

(Special to The Guardian.)  
LONDON, June 18.—Following a conference of executives of the National Union railway workers and delegates from the Irish railway unions at Bristol, a resolution was adopted calling for a meeting between Lloyd George and a deputation representing all Ireland. The resolution urges the new conference to take such proposals as will create an atmosphere enabling the securing of a real permanent solution to the Irish question. The conference was of opinion that murders and outrages in Ireland were the inevitable result in a government policy of not governing Ireland in accord with the wishes of the people. It urged the government to cease sending munitions into Ireland, which it de-

clared as provocative of conflict. Simultaneously with this conference, violence began to revive in different parts of Ireland. Several hundred armed men, alleged to be Sinn Feiners, some of whom were masked, held up pedestrians in Londonderry during the night. The police were apparently powerless to prevent these occurrences. In addition to the Cookstown and Malrow affairs, the raiders burned the barracks at Bandon, Cork. The government is renewing its efforts to meet these disorders. Five hundred troops of the Cheshire regiment were landed today at Dublin, and simultaneously marines with machine guns, and full equipment, were landed on the Irish coast to take over the coast guard stations.

## Reported That Ex-Kaiser was Assaulted

DOORN, Holland, June 18.—There are persistent rumors in the village that the former German Emperor has been assaulted by a Belgian, who, showing a forged pass, gained admittance to Doorn Castle. It is asserted that the former Emperor was wounded in the jaw, and that the Belgian was arrested. It has been impossible, thus far, to ascertain whether these rumors are true.

The At Home held in honor of Rear Admiral Everett, Captain Nobel, M. V. O., and the officers of H. M. S. Calcutta at the Government House last evening proved the greatest social event of the year. There was a very large attendance and everyone entered the merry dance to the splendid music of the ship's band with great zest. There were hundreds of spectators present and the building was most tastefully illuminated. The affair was under the auspices of the Navy League and all present were unanimous in declaring it an event of exceptional interest and enjoyment.

## To Go Before The Privy Council

(Special to The Guardian.)  
OTTAWA, June 18.—The question of the jurisdiction of the Board of Commerce of Canada as a profit fixing tribunal, will be taken to the Privy Council. E. L. Newcombe, K. C., Deputy Minister of Justice is on his way to England to make application on behalf of the government for leave to appeal against the findings of the Supreme Court of Canada in the case of the Board of Commerce vs. The Ottawa Clothiers. The case involving the right of the Board to limit the profit which any merchant in Ottawa might make on the sale of men's clothing was argued before the Supreme Court, which divided in its opinion, three judges upholding the legality of the Board's orders, and three judges dissenting.

## Admits He Was Offered Money for His Influence

OWEN SOUND, Ont., June 18. D. J. Taylor, M. P. P. for North Grey, in an interview tonight stated that he had been correctly reported to the effect that he had received an offer of \$1,000 for his influence in the Legislature in forwarding a certain matter, but refused absolutely to divulge the name of the person or interest by whom, and for whom, the offer was made. Mr. Taylor admitted that he had not mentioned the matter to Premier Durney, and did not think that Mr. Hicks, the U. P. O. whip, was referring to him when he charged that money had been offered members of the government for their influence in the House. The offer was made to him prior to the opening of the session. Mr. Taylor said.

## Brusloff Arrested Owing To Failure

(Special to The Guardian.)  
LONDON, June 18.—General Brusloff's recent arrest was caused by the fear that he would utilize a big defeat on the Polish front to overthrow the Soviet and form a new government, according to a Helsingfors telegram, quoting a Russian newspaper as its authority. A Bolshevik commission, the newspaper says, was sent to the Polish front where Brusloff was commanding Soviet troops and ordered him arrested, owing to the failure of his plans for the offensive. A Warsaw despatch early in June quoted advice to Warsaw newspapers that General Brusloff had been arrested charged with responsibility for heavy losses suffered by the Red Armies along the Beresina River. More recent reports on General Brusloff were that he had been arrested in London, and the other in Tokio, had the General in supreme authority at Moscow, in place of Nikolai Lenin, the Bolshevik premier. When the London report was received, officials quarters were not inclined to accept it as true.

## Any Bone Dry

FRENCHLICK, Ind., June 18.—Democratic party leaders in conference here on candidates and platform planks to be presented to the National convention in San Francisco, predicted today that a hot skirmish would result if William Jennings Bryan attempted to insert a dry bone declaration in the resolutions. As a retaliatory move it was suggested that a wet plank might be offered for the convention's consideration. Governor Alfred E. Smith and Chas. F. Murphy, the New York leaders, it is understood, have not yet reached a decision on a candidate to be favored by their support. Governor Smith, it is said, will receive the complimentary vote of the New York delegates on the first ballot. The candidacy of Wm. G. McAdoo will be the target of the Tammany Hall chief, it has apparently been decided.

## Strike Postponed

TORONTO, June 18.—The strike of street railway employees scheduled for today, was postponed until next Wednesday. The company's request for more time to consider the men's demands was voted on favorably by the men last night.

## Turkish Delegation Arrives In Paris

PARIS, June 18.—Turkey's Peace Delegation, headed by Damad Ferid Pasha, Grand Vizier, arrived in Paris this afternoon. The party was escorted to Versailles where it is installed in the same suite of rooms used by the Germans last year.

## CORBETT ELLIS TAKE STAND IN OWN DEFENCE

### Crown Counsel Intimates Unusual Circumstances Surrounding the Marriage of the Prisoner and Deceased in England.

Alleged circumstances of a most unusual kind surrounding the marriage in England of Thomas Corbett Ellis were brought out in an indirect manner by Crown Counsel in the murder trial at Summerside yesterday. A bogus marriage at a vicarage to be followed eventually by a compulsory legal ceremony with Ellis under military escort; the dishonouring of Marie Bramfit, and a separation from her husband until the day they sailed for Canada formed the subject matter of a succession of questions asked of Wm. Johnston, father of the accused by Mr. Johnston. The question was based on an assumption that the deceased had told her father in law of the circumstances, but to almost everyone Mr. Ellis answered in the negative. Counsel said that in putting them he was acting on information in his possession. Shortly after four o'clock the prisoner took the stand in his own defence. Ellis showed indications that when he holding himself under control, but spoke up clearly and firmly in replying to Mr. Strong's examination as to his movements before the war and his military record occupied the time until adjournment. His own version of the events and causes leading up to the tragedy of Jan. 7th will be related by the accused when he resumes his testimony this morning.

Evelyn Ellis was recalled to the stand. She was asked by Mr. Johnston if she knew Bligh Yeo. Witness said that the latter was at the Ellis home on January 8th. They were working together all day. "Do you remember saying to her that when you saw her Mr. Durney coming that Corbett would be arrested?" "I didn't say anything of the sort. I said that he would try to make trouble. I knew that by the way he came in with a big swine." The witness said that Mr. Bamford was always trying to make trouble. Evelyn also did not remember telling Bligh Yeo about the quarrel between Ellis and his wife on the morning of the 6th. She did not tell Bligh that Ellis said to his wife: "Why in Hell didn't you give me that message?" "Did you tell Miss Bligh Yeo that Corbett told his mother when he went upstairs after supper on the 7th? 'It's all mother—' it is." "No." "Did you tell Bligh Yeo that when he came downstairs he said to you: 'It's all Evelyn!'" "I don't remember having said so."

Mrs. William Ellis, mother of the prisoner was then called by the defense. The witness related an incident which occurred on one morning in October, when the deceased after saying she was unhappy left the house remarking that she would not "eat another bite in the house." She returned at dinner time and called the witness to the door. Deceased said: "I left this house this morning with the intention of drowning myself. But I thought it was too hard a death." She also told witness that she had made arrangements to spend the weekend elsewhere, but was prevailed upon to come in. The witness noticed that her clothes were wet and said: "Marie change your clothes or you'll die." She added that it was raining hard at the time. Later in the afternoon the deceased had recovered from her fit and came downstairs where she chatted pleasantly and was in good humor. On another occasion Marie said: "I wish I could fall out the window and kill myself" and "I wish I could take pneumonia and die." She also said the family were barbarians; had no education. On January 6th, the witness became ill and went to bed. She had a severe cold and other ailments. The witness saw Marie leave the house on the night of the 6th through her window from the bed. It was a moonlight night. She heard her come in about four in the morning. About seven Marie came and closed the door. Witness thought she went to bed. About 8:20 the deceased came out of her room and went down stairs, returning in about ten minutes. She went into her room again and shut the door. Some time after the witness saw Marie burning some letters and rubbish in a small stove upstairs. She did this three times, suggesting to witness that she was cleaning out her trunk. Finally at about 11 o'clock she closed her door and put something against it. "Did you hear that?" "Yes, quite clearly."

The prisoner came to the witness' room at 12 o'clock when he read a couple of letters. He remained ten minutes and then went downstairs.

"Is there any trouble moving about in your house without being heard?" "No. You can hear quite plainly. No one could go up or down stairs without me hearing." Although the witness never saw Marie again alive she heard her moving about in her room about 2:30. Subsequently she heard a strange noise as though a person was "snoring with her mouth open." Later she heard a thump. "When did you next see Corbett?" "About six o'clock or thereabouts. He came upstairs to my room." In pursuance of what you told him that did he do?" "He went to Marie's door and asked her if she wasn't coming down to get something to eat. There was no answer. He pushed the door open and looked in. He went and got a lamp and holding it in his left hand he looked in the door. Agnes and I were both watching him. After a minute he came to the door of my room and said 'Oh, there is!'" Witness said that Corbett then went downstairs. "Where are you going?" she asked. "I'm going for a doctor," he replied. "Don't worry until I get back." After Doctor Stewart came out of Marie's room he went to see witness. She asked the doctor: "What did that woman do?" The doctor said: "She has cut her throat." Witness exclaimed: "What on earth did she do it with?" The doctor responded: "There are two razors, scissors and a mirror on the bed." "How did Corbett Ellis use his wife?" "As far as I saw he used her as well as any man could." "Did he ever hit her?" "No, never." "Did deceased ever smoke cigarettes?" "Yes, she told me she did. I only saw her once." Mr. Johnston rose to cross-examine the witness. "You were pretty sick that day Mr. Ellis?" "On the 6th, yes, but on the 7th, I was a little better." Witness said that she was looking out the window quite a lot just for diversion. She also watched the deceased's room. She was afraid of the way Marie was acting, and hoped she would speak to her. "You knew that she was out at night—might have been anywhere—out in the snow or in a barn. Her husband was upstairs in bed and did not know where she was, and yet you never said a word to her?" "No. I was expecting that each time she came out she would come to me as she usually did." "The witness had an idea from what Agnes had told her that Marie had gone to the Ramsay's." "And that's why you never suggested to your son during the night that he ought to be looking after his wife?" "Yes." Corbett rose, the witness said between 9 and 6:30 a. m. and went downstairs. The witness did not know what occurred. "Didn't you speak to him about his wife who had been out all night?" "No, I don't remember. He only enquired if he had better get a doctor for me." "You only discussed your own ailments then?" "Yes." Witness said, Corbett came upstairs at noon but she did not say anything to him about Marie having placed something against the door. "You did not think it of sufficient importance?" "I thought she was packing her trunk to go away. She talked of visiting her brother." "Was there any talk of a separation?" "None that I know of." "Didn't you advise her about a separation?" "I never did any such thing." "Didn't Marie read to you a letter after her brother in which he advised her to accept a position in a sanatorium at Muskoka, Ont.?" "No." "Now you heard a noise like a person snoring with her mouth open about four o'clock and then afterwards a thump?" "Yes." "How long after was the thump?" "Almost immediately." "Was there a jar?" "Yes, I felt it slightly." "You know that little table?" "Do you think that something falling against that table would cause such a jar?" "I don't know." Witness said that Agnes and she were frightened. She asked Agnes to go and peep in. It struck witness after a while that perhaps it was just something that was dropped. Since she heard no further movement, witness became uneasy. Both

## Gompers May Not Be a Candidate

(Special to The Guardian.)  
MONTREAL, June 18.—The endorsement of government ownership of the United States railroads by the American Federation of Labor leaders, declared here tonight, was the first real defeat that Samuel Gompers, veteran Pres. of the Federation, has received in years. This repudiation of his administration, it is reported, prompted the Labor Chief to state before the convention late today that he was not quite sure he would be a candidate for re-election. Mr. Gompers' fought hard against his convention's action today, declaring that it was a step toward the enslavement of the workers as government employees, who, he said, had been denied many political and economic rights under past administrations. He received but a mild ovation. The United Mine Workers and the powerful railroad workers organizations combined to bring about president Gompers' defeat. They also had the support of the Machinists Union, and the Metal Trades organization, all powerful voting factors. The Carpenters Union and the Building Trades organization stood loyal by the veteran president, but were overwhelmed, the final vote being 29,059 for government ownership and 8,349 against.

As a result of the convention's action, the executive council, whose members support Mr. Gompers, are placed in an embarrassing position. They must now take steps to bring about government ownership, which they have opposed, or resign. Supporters of Mr. Gompers declared tonight that they would urge him to retain the leadership of the federation, and stand up for re-election for the 39th time.

girls were afraid to go. They said they were afraid 'she'd make at them.' Witness repeated her story of how Corbett discovered the body. The mother was quite sure that Dr. Stewart told her that there were two razors, scissors and a mirror on the bed. Not until the preliminary hearing did she know the razors were on the table. Agnes Ellis the other sister of the accused was the next witness for the defense. Examined by Mr. Saunders she testified to having seen the prisoner in her mother's room on the morning of Jan. 7th. Together they came down to the dining room where they met Evelyn and Marie. Some time later she saw Marie going up stairs holding something close to her body. She saw the deceased last at about eleven o'clock, when the latter was burning letters in the hall stove upstairs. That afternoon she heard the deceased push something against the bedroom door. At about 4:30 she heard a noise which sounded like snoring a few moments afterwards she heard another noise as though something had fallen.

The witness corroborated the story told by her sister as to the prisoner's movement and also as to his actions and remarks after he had looked into the room of the deceased. Mr. Johnston cross-examined. "Have you been going over the evidence with the others?" "Yes but not to frame up anything." The witness admitted after considerable hesitation that there were typewritten copies of the evidence at home. "Was there anything on those copies about Marie hugging something to her body?" "No." "Well, that's something now then. When did you think of it? I had forgotten about it. When did you think of it?" the counsel repeated.

Witness who did not seem to understand from her frequent questions of "what do you mean?" finally replied that it was fairly recently—but that it was quite true. "Did anyone in this court tell you about it this very morning?" "No" (emphatically). Witness agreed with her mother and sister that Dr. Stewart said that the razors, scissors and mirror were on the bed. ## REVENUE STAMPS PROVIDED COLLECTION OF LUXURY TAX

### The Difficult and Cumbersome Job of Tax Collecting Greatly Reduced by New Method Which is Greeted with Relief by Officials and Merchants.

(Special to The Guardian.)  
OTTAWA, June 18.—As the collection of the Luxury Taxes under the present method is proving difficult, cumbersome and costly, it has been decided to abandon the whole procedure in favor of revenue stamps. These revenue stamps will be ready by July first and as they are available for purchase by merchants, the sending of duplicates of every sales receipt covering goods which are taxable will cease. That will be a great relief to merchants throughout the country and it will be a great relief as well to Mr. George W. Taylor, Assistant Deputy Minister of Customs and Inland Revenue, as he will not

have to provide the tremendous staff, which would otherwise have been necessary to deal with collections, and accompanying vouchers. The revenue stamps will be provided in denominations of from 1 to 10 cents inclusive, 13 cents, 15 cents and all multiples of 10 cents up to \$1. In addition there will be one, two, three, four, five and ten dollar stamps. If a woman buys a sealink coat on which the tax is \$70, the procedure will be for the salesman to affix the \$10 stamps to the sales slip or invoice and collect \$20 from the purchaser, the stamps acting as evidence that the tax has been paid. The stamps will all have to be defaced so that they could not possibly be used again.

## Special Meeting City Council

A special meeting of the City Council was held last evening, His Worship Mayor Riley in the chair and all the Councilors present. It had been expected that the estimates for the year would have been up for discussion but for reasons beyond the control of the Finance Committee it was impossible to submit them and they will be presented at an adjourned meeting next week. The City Surveyor was authorized to extend the tender for cement to an extra 2200 bags to complete permanent street work. A letter was read from residents of Euston and Fitzroy Streets regarding the erection of a garage. As no definite information was available about this, it being impossible to erect any building without the permission of the City Surveyor it was felt by the Council that the remedy if any injustice should appear would be in the hands of the City Surveyor and he would report to the Council. The grave pit at Surrey owned by the City came up for discussion and it is expected that the members of the Council along with competent authorities will make an examination in a few days and decide what should be done with it in the best interests of the city. A number of other matters came in for considerable discussion after which the meeting adjourned.

DEPENDING ON P. E. ISLAND MILK  
ST. JOHN, June 18.—Hope that a sufficient supply of P. E. Island milk will be on hand tomorrow to meet the demand is the only ray of sunshine for the local milk dealers this afternoon. The Kings County milk producers show no signs of weakening in their stand, not to supply milk while the C. N. R. trailers operate on daylight saving time and F. P. Brady, General Manager of the C. N. R., who was in the city today said that no change will be made in the present C. N. R. schedule. It is expected that a daily train service will be established on the St. John Valley line next week and with this prospect local dealers were today negotiating with valley producers for their milk output.

DOUBLE TRAIN SERVICE
