Archbishop Ireland's Able

Plea for

TOTAL ABSTINENCE.

The Distinguished Prelate a Total Abstainer For Twenty-eight Years.

(Chicago Times Herald.)

The address of Archbishop Ireland before the Catholic Total Abstinence Union of America, which has been holding its annual convention in Chicago was a masterly plea for total abstinence among Catholics, based upon physiological, religious and industrial grounds.

The distinguished prelate is a total abstainer. Twenty-eight years ago he signed the pledge to abstain from the use of alcoholic liquors, and although he has sat as the honored guest at many banquet boards in European and American cities, he has faithfully adhered to his pledge, believing that only through total abstinence can a man reach the highest attainment of the mental and physical powers.

The inflexible attitude of the archbishop on the liquor question has a most inspiring effect upon the agencies that are working to promote the cause of temperance and to mitigate the evils of excessive drinking, not only in the Catholic church, but in the Protestant denominations. and ally as Archbishop Ireland, the Protestant temperance forces are encouraged to push the war on the rum traffic with renewed vigor.

It is acknowledged on all hands that the Catholic church can exert greater power in minimizing the evils of the saloon and reducing the consumption of alcoholic stimulants than any other moral agency of modern times, and that the church should be fostering such a society as the one which has been in session in Chicago must be regarded by temperance advocates as one of the most hopeful phases of the temperance movement in this country.

It will be observed that the archbishop is not a compromiser on the liquor question. He is a total abstainer—not a temperance man.

There is no middle ground of moderate indulgence for him. He is not a believer in Professor Atwater's theory that alcohol in moderate doses is a food. He declared that "it is evident more and more every day that alcohol is a poison; that the use of alcohol even in the smallest quantities does harm, and as the years go by the intelligence of the world is awakening to the evils of alcohol." Total abstinence, he declares, is the price of longevity, of good health of business success and of self-respect.

These are the vigorous utterances of a prelate who practices what he preaches and who believes that all the temperance talk of the reformers is of little avail unless they practise before the world absolute total abstinence.

Rev. C. W. Jackson Presented with an Address.

On Friday evening the 25th inst. at a meeting of the Canadian Literary Society the following address was presented to the Rev. C. W. Jackson, Pastor of the Baptist Church who is about leaving us.

CATHOLIC CHURCH

The Pope Will Decide on Absolution

GIVEN BY TELEPHONE

Should be "a Moral Presence of the Penitent with the Confessor."

A curious instance of the modern tendency of the Roman Catholic Church to keep abreast of the age may be found in a theological treatise just published in London entitled, "The Sacraments explained According to the Teaching and Doctrine of the Catholic Church." The author is the Rev. Arthur Devine, a recognized authority on orthodox Catholic theology. He says it has not yet been officially decided by the Pope whether or not confession can be heard and absolution given by telephone, but he is inclined to believe such action would be valid

under certain circumstances. It is one of the requirements of valid confession and absolution that there should be "a moral presence of the penitent with the confessor." A written confession sent to an absent priest is not valid, but Father Devine says that "a priest might give absolution by telephone, under condition, to a person taken suddenly ill, so as to be in imminent danger of death, and when he cannot possibly reach the place where the person is." In this case "the penitent and confessor may be truly said to be conversing together, and consequently to be morally present to each other." The idea of grafting a venerable rite upon the most modern of inventions will have a curious interest for Protestants as well as for Catholics.

INGERSOLL INTESTATE

Widow Says she is Unable to find a Will.

GAVE ALL TO OTHERS

He Left only \$10,000 in Personal Property Which Includes his Books, etc.

NEW YORK, Aug. 26.—In the Westchester County Court Monday the widow of Robert G. Ingersoll filed her report as administratrix of the estate of the famous orator and lawyer.

In this report the widow showed that her husband had died almost penniless; that his personal property was worth less than \$10,000, and as for realty, he had none at all.

The petition, or rather report, of the widow, Eva A. Ingersoll, is that her husband died intestate. To her knowledge he never made a will. She had made diligent search, as required by law, but was unable to find any such document. But more, she had been unable to learn from any person that he ever had spoken about leaving a will. She had made this enquiry, as was demanded by the law, but it was only a form. She believed he never made a will, because if he had made one she would have known of it.

That Ingersoll did not make a will is not news to those who knew him. He had confidence in others, and above all in every member of his family. That he had no last wish to express regarding the disposition of what little property he had meant nothing except that his family should get it all and dispose of it as was best.

But the comparative poverty of Ingersoll at the time of his death was a surprise to his friends. The widow in her report states that she has estimated the value of the personal property of her husband, and that it does not exceed \$10,000. In this she includes his clothing, books and everything of the kind that comes under the head of personal property.

As to real estate, it was stated that he had none. He did not own the house in which he lived, nor did he have title to a single foot of earth. What had become of all the rich fees earned by his eloquence, the large sums gained by his brilliancy as a lecturer, the money for his books, was not said. It was not necessary to make formal report on that. The family and friends of the colonel know that he gave his all others.

Col. Ingersoll, the report shows, left surviving him Eva A. Ingersoll, his widow; Eva R. the wife of Welston H. Brown, and Maud Ingersoll, and to each one he left an equal one-third interest in his poor estate.

Monday the widow filed her bond as administratrix. It shows in the sum of \$10,000 as a promise that she would faithfully carry out her trust. The bond was signed by herself, by Eva R. Brown and Clinton P. Farrell. In this bond it is shown that Robert G. Ingersoll did not live in his own house, and that it was owned by his daughter, Eva R. Brown, who stated in the bond that she owns Wals-ton, the old home, with thirty-four acres of land adjoining, in Dobbs Ferry; also that it is worth \$50,000, and is without incumbrance, and that in other property she is worth \$50,000.
