There appeared little danger of an immediate, serious tie-up of electricity, gas and water. Although gas-jets burned less brightly in most homes today, the municipal gas company said it had a good reserve on hand. Special pickets in the plants assured water and electricity service.

### Early Settlement Hoped

Meanwhile, Parisians placed hope in the cabinet's decision for the strike's end by tomorrow. The Government, in special session, announced its determination to keep the public services functioning. Consequently, it declared, unless the strike order given by the inter-union public service committee is withdrawn, the government is determined to commandeer necessary men and materials to maintain the services.
