Pirates Are Better Club Says Manager

SAN BERNARDINO, Calif., Mar. 24.—Pittsburg, with virtually the same club that led the National Baseball League last year in scoring runs and slapping out base hits, promises to wind up nearer the top this year.

Manager Pie Traynor, recalling that his Pirates finished the 1936 campaign eight games behind the champion Giants and three games

back of the runnersup, Chicago and St. Louis, spoke with a warning today when he said: "I believe we'll be better this year. I think we have the strongest team since I became manager."

If Traynor's pitching staff can deliver, and the Pirates continue to hit as they did before, Traynor can rest easy.

Much depends on Ed Brandt, the veteran lefthander secured from Brooklyn, where he won 11 and lost 13 last year. Similarly, if Cy Blanton can regain his 1935 form and improve the 13-won-15-lost record of 1936, it will help matters, because Traynor feels he can rely on the remainder of the staff to carry the burden they shouldered last year.

Tommy Padden and Al Todd will handle the regular catching. In the infield, Gus Suhr will be back at first; Pop Young and Lee Handley, the \$20,000 rookie find, alternating at second; hard hitting Floyd "Arky" Vaughn at short and big Bill Brubaker at third.

Jim Browne, who hit .383 for Minneapolis last year, will see outfield duty and John Dickshot

who batted .397 for Buffalo, is another newcomer threatening to alter the regular Pirate order front of the two Waner boys, Paul and Lloyd, and Forrest Jensen.
