Week of Prayer At Montague

The week of prayer services in Montague came to an end on Friday night. Dee regret was felt that Rev. Mr. Plannigan of the Baptist Church was ill and unable to attend any of the services. Rev. Mr. Ray was the speaker in the Baptist Church on Tuesday night. Rev. C. E. Armstrong took the service in the Presbyterian Church on Wednesday night. A solo by Miss Enid Coffin, "The City Poursquare" was very sweetly sung. There was also a solo by Mr. Allison MacLean, "My Heavenly Father Watcheth Over All".

On Thursday night in the United Church the four ministers took part, the subject being "Youth". Rev. Laurence Ray was the first speaker. His text was Eccles 12-1: "Remember now thy Creator in the days of thy youth." He gave many reasons why youth should remember Him, and pointed out that it was the formative period, and if they did not come to Him then, they very seldom did in later years.

Rev. Arthur Long spoke on the words of Paul, Acts 26-19: "I was not disobedient unto the heavenly vision", stressing the need of obedience in youth, and pointed out the case of the Prodigal Son. If he had been an obedient son, not demanding his share of goods from his father and wasting his substance in riotous living, how his heartache would have been saved; and if the young would live lives of obedience to the Heavenly Father, how many would be saved from mistakes and failures.

Rev. C. E. Armstrong took his text from Luke 2-52: "And Jesus increased in wisdom and stature and in favor with God and man", and emphasized the fourfold life. He told of his work with a Tuxis Group and what the life meant in the lives of those boys.

Rev. Owen Hughes was the last speaker, ending with the words of Jesus to Pilate, John 18-34: "Sayest thou this thing of thyself or did others tell thee of me?"

He reminded his hearers that most things came to them second-hand. Education was something told them by others. A business, or farm, was handed down to them to carry on, and so on in most things of life, but urged that in the Christian life both old and young must not take what others told them. Each one must make their own decision and be able to say from their hearts, "I believe in the Lord Jesus Christ"; and believing we must serve Him.

A mixed quartette: "I'm Praying For You" was much enjoyed. The last service of the week was in the Christian Church. Rev. A. Long was the speaker.

A solo by Mrs. Wm. Garrick, "In the Garden With Jesus" was much appreciated. The male quartette was heard in the number, "The Wayside Cross".

respondent, vs. James Gormley, appellant, an appeal from a conviction under the Excise Act. The penalty, imposed in the lower court for second offense, was six months in jail without the option of a fine and in addition a fine of \$500.00 or in default of payment an additional six months in jail.

Mr. J. O. C. Campbell acted for the Crown and Mr. J. J. Johnston, K. C., for the appellant. Notes made by the Stipendiary Magistrate of Charlottetown, K. M. Martin, K. C., of evidence taken at the trial in the lower court were admitted in evidence. Witnesses then included C. F. Deakin, Rudolph LeClair and C. J. Pooley of the Mounted Police for the Crown, and Francis MacDougall and James Gormley for the defence. When court adjourned last evening Mr. Johnston had not completed a long argument on legal aspects of the case.

Other cases disposed of yesterday included:

The King, respondent vs. Hazel Wilson, appellant, appeal allowed without costs. The Attorney General acted for the Crown and Mr. R. R. Bell for the appellant. "Since entering the appeal a conviction was obtained against the appellant on other evidence," Hon. Mr. Campbell said, in giving assent to Mr. Bell's motion for dismissal. The appeal was from a conviction under the Prohibition Act.

The appeal was allowed without costs in a second Prohibition case, that of the King, respondent vs. Dorothy Monaghan, appellant. The Attorney General explained that appeals from two convictions had been entered and one had been withdrawn, therefore he was consenting to the application by Mr. Bell, appellant's counsel, in this case.

In the case the King, respondent vs. Lester Buell, appellant, was adjourned for adjudication. The Attorney General represented the Crown and Mr. J. A. MacDonald, K. C., the appellant. This case, an appeal from a conviction under the Prohibition Act, was adjourned from the last sitting to give the Crown an opportunity to make further attempts to secure a witness. The Court was informed yesterday that the man, John D. McNayre, was out of the province and a vessel along southern New Brunswick. He was unlikely to return for the time.

When Court opened yesterday Miss Bessie L. Smallman sworn in as official Court stenographer.

Mr. Fred Bell, Cape Traverse, was appointed commissioner for taking affidavits in Prince County and Mr. Daniel Mullin, St. Peter's Bay, commissioner for taking affidavits for Kings County.

Charge To Grand Jury

Mr. Justice A. E. Arsenault in his charge to the Grand Jury yesterday referred first to the renovations to the Law Courts Building. They were long overdue, he said, and had been talked of for the past 20 years. It was to be the last time he had seen that credit of the Premier and Attorney General that he had seen that the Court House was being put into condition.

Referring to the Legislative Chamber, where the sessions are being held, and to the fact that for the most of those present it was the first time to sit in this room, His Lordship remarked that

it was not new to either Mr. Justice Saunders or himself.

In most legislatures the government sits on the right of the Speaker but in Prince Edward Island it was opposite and some might wonder why. He personally recalled, Justice Arsenault said, when the government here sat to the right of the Speaker. In Mr. Frederick Peters' time, he believed, the change was made solely for convenience owing to the arrangement of rooms used by Speaker and Premier. As a result this was probably the only place in the British Empire where the government sat on the left of the Speaker.

"Their labors at this sitting would be very light. Justice Arsenault informed members of the Grand Jury. There was but one indictable offense for them to consider. Other duties were then outlined to the jury.

Mr. Justice Arsenault referred with regret to the indisposition of Chief Justice J. A. Matheson but expressed confidence that he had undergone an operation successfully and was on the way to convalescence. The Chief Justice had had a long career and had served the public as well as any man could have done.

211 prisoners had been in the jail since June, Justice Arsenault said. Of that number 202 had been males and 9 females.

Most had been for not very serious offenses although all offenses which send a man to jail were serious enough. His Lordship reported.

GRAND JURY REPORT

To the Presiding Judges, Honorable A. E. Arsenault, Honorable A. C. Saunders, May it please Your Lordships: "Your grand jurors wish to submit the following report: "We have visited the Queen's County Jail and find 26 male and 3 female prisoners. We find this building well kept, clean and in good condition. Sanitary conditions good, food in store first class quality. We are of the opinion that the discipline in this institution is good. The system of labor seems to be working well and we recommend this plan be extended wherever possible. Our attention was drawn to the need of a small storehouse attached to this building. We recommend that this be provided.

"At Falconwood Hospital we find in the women's pavilion 118 patients. These are housed and cared for under ideal conditions. In the men's pavilion there are 140 patients. The accommodation in this pavilion is overtaxed and consideration must be given shortly to allow for segregation and treatment. Your jurors inspected the kitchen and stores and have no hesitation in pronouncing food supply of a high standard and conditions very satisfactory. We believe this institution to be conducted in an efficient manner and the comfort and welfare of the patients is insured. We would again draw attention of the authorities to the need of new laundry building and equipment. We see the need also of an improved road to this institution and recommend that steps be taken at once to remedy this condition.

"We visited the Provincial Infirmary and find 152 patients, ranging in age from 2 to 90 years. 87 male patients and 65 female patients. We find the institution clean and sanitary and the patients well cared for. Your jurors believe this institution is conducted in a very satisfactory manner.

"We are pleased to see renovations being made to the Court House. These have long been needed and will be a great improvement over existing conditions.

"We regret the illness of His Lordship Chief Justice Matheson and we are pleased to learn of his progress toward recovery."

Air Traffic Increases Over Last Season

Charlottetown's Upton Airport, Prince Edward Island base of the Canadian Airways, is a busy place these days.

Airways officials announced last night passenger traffic on the Charlottetown-Summerside - Moncton route was heavy and better than this time last year. On several occasions during the last few days an extra plane has been put on the run to carry the mail.

A flight scheduled today from Upton Airport to the Magdalen Islands was postponed owing to weather conditions. Late yesterday, however, a snow storm and a strong northwest wind showed signs of clearing and the trip would likely be made today. Three passengers, two of them hospital patients, will be taken to Charlottetown on the next flight, it was learned. Meanwhile, two passengers await transportation to the Gulf Islands from here.

At present two twin-motored Dragon planes owned by the Canadian Airways and a two-place Cirrus Moth, owned by Clark Burke of this city, are kept at Upton Airport. A transmitter for two-way radio communication, the first to be used in the Maritime Provinces, is also found at Upton Airport.

FLEET TIE-UP END LOOMS

Agreement Nears In Negotiations At Lunenburg.

(C. P. by Guardian's Special Wire)

LUNENBURG, N. S., Jan. 11 - Tie-up of the Lunenburg fishing fleet appeared near an end tonight as Fishermen's Federation officials and captains of the schooners met for the second time in the one day.

Agreement over demands of the Union for an increase in the scale of prices for fish was reached by fish dealers and representatives of the Federation, but refusal of the General Sea Foods Company, an American concern, to join the negotiations was proving an obstacle.

Captain Angus Walters, President of the Federation, declared that the fleet would not end the fortnight-old tie-up until a place had been found for the three vessels working for the General Sea Foods.

Also, he said, the fleet would remain in port until demands of the Halifax Fish Handlers and Cutters Union had been granted by the National Fish Company.

HALIFAX, Jan. 11 - Approximately 80 workers who had been ordered to evacuate sleeping quarters at the National Fish Company's office and plan, moved to the freighter Maid of Scotland docked at the National Fish Wharf.

The workers, who had evaded picket lines established by the Fish Handlers and Cutters Union, on strike for union recognition, had been ordered to move by the Halifax Health Board. The Board termed use of the offices and plan as sleeping quarters as "un-satisfactory" and "constituted a menace to health."

Despite union efforts to tie-up the trawler Vernoe, the ship sailed for the banks tonight but with a new-and skeleton-crew aboard. The regular crew had quit in support of the union and members announced they would present demands to the company tomorrow.

COLORLESS JEWELS FAVORED BY THE DUCHESS OF KENT

If you imagine that a Royal Princess has a new dress every day, this clothes analysis of the Duchess of Kent will correct the idea.

She has very few clothes - far fewer than most film stars; no more, in fact, than the average well-to-do woman. She wears the same dress over and over again.

She is the only member of the Royal Family who favors black when not in mourning, and frequently varies her style of hair-dressing.

LUNENBURG, N. S., Jan. 11 - Tie-up of the Lunenburg fishing fleet appeared near an end tonight as Fishermen's Federation officials and captains of the schooners met for the second time in the one day.

Agreement over demands of the Union for an increase in the scale of prices for fish was reached by fish dealers and representatives of the Federation, but refusal of the General Sea Foods Company, an American concern, to join the negotiations was proving an obstacle.

Captain Angus Walters, President of the Federation, declared that the fleet would not end the fortnight-old tie-up until a place had been found for the three vessels working for the General Sea Foods.

Also, he said, the fleet would remain in port until demands of the Halifax Fish Handlers and Cutters Union had been granted by the National Fish Company.

HALIFAX, Jan. 11 - Approximately 80 workers who had been ordered to evacuate sleeping quarters at the National Fish Company's office and plan, moved to the freighter Maid of Scotland docked at the National Fish Wharf.

The workers, who had evaded picket lines established by the Fish Handlers and Cutters Union, on strike for union recognition, had been ordered to move by the Halifax Health Board. The Board termed use of the offices and plan as sleeping quarters as "un-satisfactory" and "constituted a menace to health."

Despite union efforts to tie-up the trawler Vernoe, the ship sailed for the banks tonight but with a new-and skeleton-crew aboard. The regular crew had quit in support of the union and members announced they would present demands to the company tomorrow.
