Years ago Jim Thorpe hung up his cleated shoes after tramping his way on American gridirons to the most

exalted niche in the hall of fame of football heroes. Winner of an all-round Olympic championship, he was required to return his trophies when convicted of professionalism.

Signed on by the Giants he failed to make the grade because of inability to hit a curved ball. He who had climbed to the pinnacle of athletic success, who was the greatest exponent of games that sport has ever known, slipped step by step down the ladder of achievement which he had climbed so effortlessly.

Recently he was discovered eking out a livelihood in California by dint of hard, exacting labor with the humblest of tools, a pick and shovel. Never had one of his abilities fallen so far and with such an uninterrupted descent. His last situation had only this in its favor, that it was honorable. A thousand players of a hundred sports have succeeded in capitalizing their skill to win an easy competence and livelihood. The best of them all was reduced like Adam to earn his bread by the very sweat of his brow.

With the stolidism of his race he made no complaint of his lot. He said that things would soon break better for him and now they have. He is returning to his native state as a director of athletics. He will occupy a position commensurate with his talents and abilities, a position in sport, the natural sphere for a man of his pre-eminent athletic talents.

The news will be greeted with pleasure by the hundreds of thousands who so often cheered him in action on the track and football field, and his return will be hailed by all who take joy in watching a real man come back.

GOOD CARD OF BOXING AT L. P. U. GYM.

The regular weekly boxing card staged by the L. P. U. in their new annex, Water St. last night, was enjoyed by another large following of fans. There were four bouts in all, two preliminaries, a semi-final and main. The first clashes went almost the full limit of rounds, while the final lasted just a half round, one of the boxers being disqualified when his second entered the ring during a mix-up.

The first bout of the evening, although between canary weights, was a thriller from start to finish. The youthful aspirants, Effie Stanley, weight, 35 pounds and Biddle Gallant, 46 pounds, gave the fans a demonstration of just how to mix it at top speed for three full rounds. The writer enjoyed this bout immensely, in fact just as much as the bouts that followed. This is not meant as a reflection on the other boxers, nevertheless, the kiddies showed the best of true sportsmanship, plenty cunning, lots of courage, and a surprising knowledge of the boxing art.

Effie, the lighter of the two, had a somewhat longer reach and used it to good advantage, especially when he would unleash long, "powerful" swings which Biddle ran into at times and on other occasions, worked inside to count with short hooks to the body and head. During the many hot exchanges not a foul blow was struck and at no time was it necessary for referee Coughlan to pull the boxers apart. They clinched, broke and immediately went back to work. It was a great match all through and ended in whirlwind fashion, as both "Canaries" stood toe to toe and traded wallops to the tune of the final gong. Both shook hands after the battle, which was fittingly declared a draw.

Second Bout

The second set to between "Kid" Nickerson and Jackie Stanley was a great exhibition, and drew hearty applause from the fans. Nickerson, who was a little heavier and longer in the reach than Stanley, used these assets to good advantage. The latter did most of the leading throughout, but lost many points by his repeated missing in the early rounds. However, as the bout progressed, Stanley changed his tactics to bore in to get under his opponent's punches. This seemed to bother Nickerson somewhat, and he was forced to clinch to keep his sturdy little opponent from counting more often. Nickerson nevertheless, staged a good rally in the final round to gain an even break. The bout was declared a draw. The decision was a popular one.

Semi-Final

The semi-final, featuring a return bout between "Dinty" Stanley and Bonnie Binnis was exciting up till the third round, when the former injured his thumb in a fast exchange and was forced to retire. The bout was awarded to Binnis, on a technical K. O. The absence of bandages on his hands was the direct cause of the injury. In future, it is hoped that all boys boxing will wear the customary bandages for the protection of their hands. When boxing with light gloves, a little tape should be used over the bandages.

Final

The final bout between Gus Longaphie, Charlottetown, and "Kid" Martin, of Amherst, N. S., was rather disappointing due to its sudden ending about midway in the first round. The bout was scheduled to go over the five round route. The end came after Martin took a four count after one minute of fighting. Longaphie fainted Martin into position to cross him with a left to the temple and a right hook to the jaw. He went down for a count of four. On arising, he went into a clinch and on the break-away, stumbled. At this juncture his second jumped into the ring, but referee Tom White quickly siding up the situation, waved Longaphie to his corner and disqualified Martin. The latter wished to continue, but was forced to abide by the rules of boxing.

The way the bout was going, it did not look to the writer if it would last another round. Longaphie, although not as heavy and shorter in reach, was much the cleverer and appeared to be hitting with more power. Another boxing card will be staged next Friday night.

HON. MR. LEPAGE: I am informed by delegations that waited on me that they are not permitted to have access to the assessment roll. It is optional with the Clerk, I believe.

DR. MCMILLAN: I am informed by those who have to deal with this matter that the assessment rolls are accessible to citizens at the present time. I would like to ask the hon. gentleman this question, which has bearing on this point: Are the assessment rolls of the Provincial Government open for the inspection of the public?

HON. MR. LEPAGE: I am not supposed to answer questions except with reference to this clause.

DR. MCMILLAN: I think that is a very proper question. It has a bearing on this amendment. He is insisting that the City of Charlottetown do a certain thing. I am asking, for the purpose of comparison, if the assessment rolls of the Provincial Government are open to the inspection of the public. I think the committee will agree that it is a pertinent question.

HON. MR. LEPAGE: My understanding and the understanding of a great many legal men is that they are open to inspection.

DR. MCMILLAN: I am not asking for the opinion of legal men. I am asking whether they are or are not, at the present time, open to the inspection of the public.

HON. MR. LEPAGE: My understanding is that they are.

DR. MCMILLAN: I suppose we shall have to be satisfied with that answer. Of course, that does not make it definite.

HON. MR. LEPAGE: The Statute provides for it.

DR. MCMILLAN: Well, let us have the Statute. What does the Statute say?

HON. MR. LEPAGE: It has nothing to do with this clause.

DR. MCMILLAN: I am asking you, as a member of the Government. You are a member of the Executive Council of this Province, and you should know. It is a simple question, whether or not the assessment rolls are open to the inspection of the public. If you do not know I will ask any other member of the Government.

HON. MR. LEPAGE: I have already answered that question. I submit that that has nothing to do with the clause under consideration.

DR. MCMILLAN: I believe the Premier will answer the question. Are the assessment rolls open to the inspection of the public, or are they not?

PREMIER LEA: The clause relating to that is a little ambiguous. I might say there was some controversy raised, I think when the Bell Government Tax Act was introduced, and it was claimed at one time that certain information had been given out regarding the assessment roll. At that time I had the Act interpreted by the Attorney General of the day and other lawyers, and they said the clear interpretation of the Act is that the actual amount of levy on property may be seen, but the information secured in making that levy cannot be divulged. That is my recollection, and I think the leader of the Opposition will agree that that was the interpretation of the clause.

HON. MR. STEWART: I think that is correct.

PREMIER LEA: The Clerk has no right to give further information. That is my own interpretation. I may say that people do not take advantage of it because it is rather ambiguous in its wording.

DR. MCMILLAN: That is quite different to the amendment proposed in this case, isn't it?

PREMIER LEA: You can get the bare facts, that is all.

DR. MCMILLAN: But you are not supposed to go over the roll?

PREMIER LEA: Not so far as our Act is concerned.

DR. MCMILLAN: But here my hon. friend proposes to open the assessment roll to anybody that wants to come in, notwithstanding that we have the very same procedure that is followed by the Provincial Government. I make that statement on authoritative information.

HON. MR. LEPAGE: The only thing they ask is to see the assessment roll, the amount that anybody is assessed. I think that is quite proper.

than the city rolls. If the intention is only to give information as to the valuation of property, I think we should be satisfied with the same provision as is made in the case of the Government rolls.

PREMIER LEA: I think that is only reasonable. A taxpayer should know what others are paying, because there has been in the city as well as in the country great injustice regarding taxation. (The Premier cited a particular instance). These things should be compared, and by comparing them we see just what adjustment should be made.

DR. MCMILLAN: This amendment provides for a general inspection. It is quite different from the policy followed with regard to the Government tax rolls. If a private individual goes in and asks for the assessment roll for Queen's County; for instance, he will not be handed the whole roll to inspect; he will be asked what he wants. If he wants information regarding particular cases the Clerk will turn up the book for him. I think that should be quite sufficient. But the purpose of this amendment is the book shall be open for inspection for any length of time.

HON. MR. STEWART: I can quite see how the Clerk would be put to a great deal of inconvenience. Unfortunately, we have citizens here, like everywhere else, who are addicted to curiosity and they might spend half their time pouring over these books to the inconvenience and nuisance of the officials of the building. On that account I think that what has been said by the promoter is quite right. If the clerk will give the information as to the valuation of the property in question, I do not see what more they have any right to ask.

HON. MR. LEPAGE: If the clerk is supposed to give the information it would take up his time. Under this amendment he could just give over the book. If you do everything above board people are not suspicious. I don't think there is any harm in the world in having that assessment roll open to inspection. I know for a fact that certain men with valuable properties in this city, owing to their influence, possibly, are able to impress upon the city officials and get their valuation much lower than other citizens that are not so ambitious to have their taxes cut down. I must say that any time I have asked any of the officials, at the present time, I have got the information. But we don't feel like impressing on people. If I wish to go in and look the roll over it would only take me a few minutes. If the valuation isn't fair the citizens have a right to know these facts.

DR. MCMILLAN: Now we see how different the proposal is from what the Premier intimated with regard to the Government. We are quite prepared to have the same procedure followed in regard to the city as is followed by the Provincial Government, of which my hon. friend is a member. He knows that if any ordinary citizen goes to the tax office of the Provincial Government and asks for the assessment rolls of Queen's County, for him to take out and examine, he will not get them. And it is quite proper that he shouldn't; otherwise you would give anybody who has any grievance the opportunity to make himself a nuisance. My hon. friend wishes to impose on the City something which he would not impose upon the Government of which he is a member. It is, of course, simply to gratify the curiosity of some kippers; that is all. Any one who goes to the Clerk, and asks for reasonable information, gets it; and the hon. member has admitted that every time he asked for information it was supplied to him. What more, in reason, does he want?

MR. GORDON: I think the privilege given to taxpayers of the Province should be enough for the citizens of Charlottetown. Any one wanting to know what a person is taxed in is in a position to get the information, and I do not see what they want more than that.

The chairman then put the amendment, which was carried on the following division:

Premier Lea, who vacated his seat shortly before the motion was put, resumed it when the amendment had been carried.

On motion of Mr. Allen Clause 113 was opened for reconsideration for the purpose of correcting a grammatical error. Mr. Allen then moved, as another amendment to the clause, which deals with the publication of the City Accounts, that the said Accounts shall be published "not later than two months after the end of the financial year."

After considerable discussion the chairman ruled that the House, having been moved into committee to consider Clause 51, and the committee having consented to return to Clause 113, for the purpose of making a necessary change in the wording of a sentence, which change has been

Deal Completed For Japanese Radio Programs

TOKIO, May 1—(U.P.)—The Japan Radio Broadcasting Association, a private corporation under government control with exclusive right to make radio broadcasts in Japan, has concluded an agreement for exclusive interchange of international programs with the United States through the National Broadcasting Company.

The first of the international broadcasts from Japan was to be sent from Station JOAK, Towlo, on Emperor Hirohito's 30th birthday, April 29, and was to be re-broadcast throughout the United States.

The proposal for an agreement for exclusive cooperation was submitted by the Japan Associations by the National Broadcasting Company last month and adopted after some slight changes. National Broadcasting programs will be relayed to Japan for rebroadcast about May 20.

The Japan Broadcasting Associations, organized four years ago under government control, plans additional stations at Fukuoka and Kōkura, in the southern island of Kyūshū, within the next 18 months and at Aomori, in northern Honshū Island, and Kyoto, in central Honshū, within a year.

The Associations now operate three large stations: JOAK, Tokio; JOBK, Osaka and JOCK, Nagoya. Smaller stations are in Sendai, Hiroshima, Kumamoto, Shizuoka, Nagano, Okayama, Sapporo and Kanazawa. The organization has the exclusive right to radio broadcasting in the Empire proper and charges a fee of one yen a month to all holders of receiving sets. There are about 700,000 subscribers and the number is increasing.

The organization is based on the general plan of the British Broadcasting Company. Kenzo Iwahara, former head of the Shibaura Iron Works, is president.

Advertising programs are not allowed and the income of the organization is solely from subscribers. The company is a non-profit making concern and its president and directors serve without pay. Income now amounts to about \$30,000 a year which is used to pay off debts contracted when the company was started and to cover running expenses including those of employees, artists, research workers, etc.

LEGISLATURE FINDS IDEAL METHOD FOR FUND RAISING

HELENA, Mont., May 1—(U.P.)—The Montana legislature has found an ideal method of raising larger funds from the sale of fishing licenses.

The scheme, appealing to the so-called "superiority complex," allows fishermen to be honored with the designation "sportsman" through the purchase of a special license costing \$5.

The "sportsman's" license carries with it no privilege not granted in the regular license costing half as much.

PEE-WEE GOLF BANNED FOR FASCIST STUDENTS

ROME, May 1—(U.P.)—Fascist university young men have been forbidden to indulge in all "miniature" or table games, with exotic names and ridiculous titles such as ping pong, Tom Thumb, or Pony Golf.

Such games are condemned as being unworthy and undignified. "Fascist college boys," says the circular, "must give an example of sporting spirit and daring in the open air without following the snobbish exhibition of lounge lizards.
