ART EXPERT MUST LEAVE
BOSTON, Mass., Jan. 2.—Although he enjoys an international reputation as an expert and connoisseur of art, and was recently appointed curator of the 1,500 pictures at the Boston Museum of Fine Arts which are valued at approximately \$2,000,000, Philip A. Hendy, a young Englishman, was informed that he was not to be allowed as a "learned person" under the immigration laws and that the time limit allowed him as a visitor to the country could not be extended. Hendy said he would re-

turn to England shortly and re-enter the United States for the year's quota from England.
As the first to be given charge of the valuable collection at the Boston museum, he has been commissioned by the trustees to select new paintings required by the institution in the future. Hendy was admitted here as a visitor in September, 1929. His investigation of the immigration laws, he said, revealed that no particular time limit was placed on the stay of "learned persons" in this country, but individuals under the classification were limited to teachers and instructors in accredited schools and universities. A number of officials had told him that this definition could not be extended to cover workers in the field of art.
After his stay as a visitor expired, he was granted a six months extension last March was given another extension of six months this year. The second period of grace, rarely granted to visitors, expires shortly.
Hendy, a graduate of Oxford, will visit European art centres in the interests of the local institution.

MAPLEWOOD SCHOOL EXAMINATION

WOMEN SHARE WORK IN PORTUGAL WHEN HARD TIMES OCCUR
LISBON, Jan. 2.—There's no time to loaf for women in Portugal. Hard times have made workers out of nearly every Portuguese woman, and foreigners on their first visit to this nation often believe women do all the labor while men take it easy.
On the contrary, both do their share, the difference being that the women workers appear more in public.
The emancipation of Portuguese women in the last decade is almost phenomenal. Women now have access to jobs in the civil service, factories and offices. In the present hard times women knitted in homes.
In Lisbon there are 40 woman doctors, 20 lawyers, several notaries, five reporters, three fashion writers, scores of women poets and two women fliers. The retail fish trade is carried on almost exclusively by women.

CLAIM RACKET TO BE PROBED
BOSTON, Mass., Jan. 2.—The fake claim racket, which has grown rapidly since the compulsory automobile insurance law was enacted, received its first setback when the Boston Bar Association, acting in response to a public statement by Governor Allen two months ago, petitioned the Superior Court recently for the disbarment of two Boston lawyers, who are charged with deceit, malpractice and gross misconduct. At the same time, state official met representatives of leading insurance companies in an effort to weed out of the legal and medical professions members who handle fake accident claims.
Action of the insurance companies and state officials in meeting to discuss methods of fighting the false claim racket was regarded as an intimation that more disbarment p-

ceedings will be instituted as soon as the necessary preliminaries can be completed.
Some of the insurance companies, it was learned, have been conducting their own investigations into the actions of certain lawyers and doctors appearing for fake claimants, and the data thus accumulated will be used in ridding the state of unscrupulous professional men who depend upon false claims for a living.
Records obtained show that one lawyer, working with a certain doctor, handled as many as 200 claims a year against one insurance company. Other lawyers have had scores of similar cases.
After compiling records for two years, company officials found that certain lawyers promote fake claims and present them to the companies for settlement. The lawyers concerned plan on having these cases settled outside of court, and they are usually forgotten if the companies insist upon having them tried.

LEAGUE AGAINST SMOKING FORMED
BOSTON, Mass., Dec. 31.—Organizing the Women's Independence League, dedicated to a defence of women's right to smoke cigarettes, girls in the Museum of Fine Arts School, one of the largest institutions of its kind in the country, have initiated a battle against the newly formed Anti-Smoking League for Women.
The new organization has not as yet caused any alarm at Wellesley and other girls colleges. Mrs. Mary C. Young, dean of residence at Wellesley, issued a statement saying: "Out here at Wellesley the smokers have made their regulations. They may smoke in Alumnae Hall, on the shores of Lake Waban and in village tea rooms, though not in dormitories nor on the streets. The non-smokers are not bothered, so all are satisfied. We do not believe any moral question is involved, or any individual taste. It seems to us that a league to stop women from smoking is too officious."

SCOUTS FOUNDER SEEKS SUCCESSOR
LONDON, Jan. 2, Lord Baden-Powell, 73-year-old head of the Boy Scout movement, is seeking a successor to lead his 3,000,000 boys in all parts of the world. The question may be decided at the January meeting of the commissioners. The chief of international scouting has ruled out his own son and declined to nominate anyone himself. "I shall leave it to the movement itself," he explained.
Other leaders declare this question is the most important that has ever been raised in the twenty-two years' history of the Boy Scout movement. Lord Baden-Powell will be 74 next February. There is no question of "B.P." retiring, but he wishes the leadership problem solved. The points under consideration are these: Is there any one man in the movement who would be a suitable successor? Should he be called "Chief Scout" or should some other title be substituted?
Lord Baden-Powell favors an individual rather than a governing body to head the movement. "One head would be better than a commission. If we can find the right man," he said. "That is what headquarters is considering. A man who by his personality can inspire the whole movement is what is needed. He must be something more than a ceremonial head. If anyone takes it will not be because he particularly wants to, but because his fellows want him to and the man chosen may come from any rank."
About the title of the possible new chief, Lord Baden-Powell said: "That, too, I shall leave the movement to decide. I shan't care when I'm dead whether he is called Chief Scout or something else."

HIKING ROUND WORLD
HALIFAX, N. S., Jan. 2 Arriving here is the course of a projected journey around the world, mostly by foot that began at Washington in September. Joseph Sekulick, slim young Jugo Slavion, left to get a ship for Newfoundland, whence he plans to sail for England. At an average rate of 30 miles a day, Sekulick had hiked 2,811 miles when he reached here. He hopes to complete the globe circling tour at Washington in something less than four years. The total mileage of his planned trip is 33,100.
With a command of eight languages, Sekulick anticipates less difficulty in European and other countries than would otherwise be the case.

MINAS BASIN CLOSED
PARSBORO, N. S., Jan. 2.—(By Canadian Press) The Government steamer Pollard arrived at this port recently having collected the buoys in Minas Basin and officially marking the close of the shipping season here.
