"Y" Campaign
Makes Progress
Reports Show

\$3264.70 of the \$7000.00 objective was subscribed for, it was announced last night at the second report super meeting of the annual Y.M.C.A. financial campaign. Mr. W. E. Massey presided at the supper which was held in conjunction with the regular weekly meeting of the Y's Men's Club. His Worship Mayor P. W. Turner occupied the chair during the presentation of campaign reports. The team captained by Mr. Gordon McDonald was given a recognition prize for its work in yesterday's campaign. The previous night the Hi-Y Grads team headed by Mr. Clifford MacDonaldd led the field. Speakers included Dr. J.A. Clark, Major George Craig, Mr. W. E. Massey and Mr. Norville L. Luck, secretary of the local "Y". Why it had been necessary to increase the objective thirty per cent this year over last year was explained by Mr. Massey, chairman of the budget committee. The increased amount was to take care of a deficit, due to not reaching the 1936 objective and to extraordinary expenditure for building repairs. Of the \$1100 spent on renovating the "Y" building \$600 had been made up by private subscriptions and the remainder would have to come from the proceeds of this year's campaign.

ADDRESS TO HIS MAJESTY
On motion of Hon. Premier Campbell, seconded by Hon. J. P. McIntyre it was resolved that the following address be sent to His Majesty the King and that a humble address be sent to the Administrator of the Government requesting him to have the same conveyed to His Majesty. To The King's Most Excellent Majesty: Most Gracious Sovereign: We, Your Majesty's most loyal and dutiful subjects, the Legislature of the Province of Prince Edward Island, in Parliament assembled, desire on behalf of ourselves and of the people whom we represent, to give expression of our unflinching loyalty to Your Majesty's Person and Throne. The constancy and loyalty for which Your Majesty has been distinguished during the reign of your worthy father and your close resemblance to him in almost every respect gives us every assurance that the high examples set forth by him will be closely observed and faithfully followed by Your Majesty.

PUBLIC SERVICE ACT

After recess. On motion of Premier Campbell, the House resumed committee with Mr. Stewart in the chair, on the Public Service Act. On motion of the promoter, Sec. 2 was amended to provide that the required period of service of a public servant should not necessarily be continuous to qualify him as a permanent employee. Sec. 4 was amended to include married women as well as public servants so made a fund to be intended to provide for retiring allowances; (c) for the administration of the fund so established. On motion of Mr. Baker, public health nurses and Prince of Wales College teachers were struck out of the list in "Schedule A" of permanent public servants. The motion carried. Premier Campbell: I don't think that that elimination will have any substantial effect, as the public health nurses and teachers of the College have been very generally recognized by both parties as not being subject to political discrimination.

GASOLINE TAX ACT

On motion of Premier Campbell the House went into committee with Mr. Jones in the chair on an Act to provide for the imposition of a tax upon purchasers of gasoline. Sec. 1 defines "gasoline" as meaning "the product distilled from petroleum which, by combustion, develops the power required for operating motor vehicles and which is intended for such use. It also means all other liquid products which although known under another name fulfill the same purpose by the same means and for the same end, except kerosene." Sec. 3 provides that "from and after the passing of this Act every purchaser shall pay to the Provincial Treasurer, for the use of His Majesty, in the right of the Province of Prince Edward Island, a charge or tax at the rate of ten cents per gallon on all gasoline purchased or delivery of which is received by him."

Says Mud Road
Hardest Part
Of Journey

Mr. F. G. Spencer of Saint John, manager of the Spencer Theatres, leaves today for the mainland after spending several days in the province. Mr. Spencer is travelling to Moncton, via Canada Bay. The hardest part of the journey, he said, is from Charlottetown to Upton Airport over roads almost impassable with mud. He flew from Moncton here Monday. There had been two additions to the Spencer chain of theatres since last fall, the theatre manager said. This week a new one was being started at Kentville, N.S. He was pleased to find Mr. S.C. Cooper, manager of the Prince Edward Theatre greatly improved in health. Mr. Spencer said, Mr. Cooper has been ill since last fall.

MR. D. N. MACKAY

Mr. D. N. MacKay, First Queens, the next speaker, extended complimentary remarks to the Speaker, the Premier, Hon. Mr. Dennis and others. Improved economic conditions he attributed largely to Liberal policies. He trusted that under the guidance of the present Minister of Agriculture much would be accomplished. He had however, a complaint to make. Last year a number of farmers could not procure seed grain. Seed was allowed to be shipped to the United States at 50 cents and brought back and sold at 80. That was bad management and he hoped steps would be taken to prevent such an occasion arising again. He had seen a letter from the Minister giving advice to farmers, that when they threshed their grain they were to save their seed. That was good advice but what about the poor farmer who was compelled to sell every bushel to get enough to exist on? Mr. MacKay emphasized the value of proper tile under-drainage and suggested that the minister should review the problem. He deplored the holester killings on the public highway through reckless driving. He referred to a case in his own district which he thought should be reopened as the magistrate had taken too much on himself in bringing in a verdict of not guilty. The Premier, he said had done "a very courageous thing" in cancelling so many doctors' licenses to issue prescriptions. Mr. MacKay reiterated his prohibition sentiments and said he intended to stand by the Act.

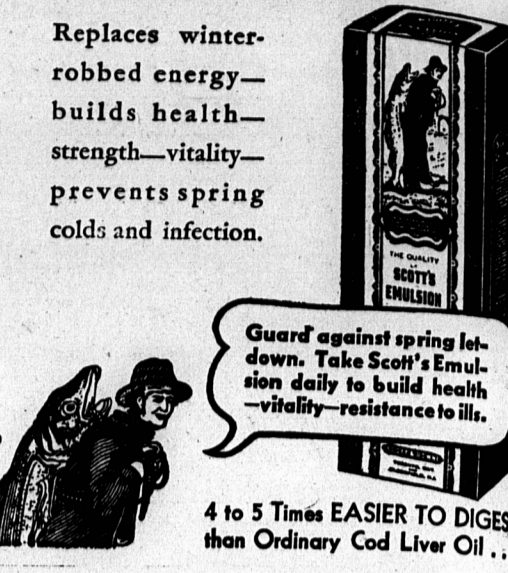
HON. MR. MCGUIGAN

Hon. Mr. R. McGuigan, Minister of Education and Public Health, said that while the education department expended a large amount of money, there was very little to show for it. The Government, he said, had no direct control. He expressed his appreciation of the work done in the Summerside High School. During the past year the people of Montague had pressed for a similar institution and last fall the high school was reopened there. Reference was made to the Bell scholarship established by the late Premier J. H. Bell which comprised two scholarships in each county, as well as annual prizes for students at Prince of Wales College. The late Mr. Bell, as a student, had himself won one of the two government scholarships, the speaker recalled. Coming to the question of the Education Curricula, Mr. McGuigan said there was great diversity of opinion among educational authorities. Even in the local press there are many different ideas expressed. It was all very well to have paved roads and better education but these things would be of no avail without public health. Mr. McGuigan said. The government took the only proper course by carrying on the Public Health department as it was carried on in other years. The only reductions made were in salary cuts. They had been no curtailment in service. Departmental activities in vaccination for smallpox and diphtheria, dental clinics, provincial laboratory diagnosis and control of diseases, etc. were reviewed, also the work of the Provincial Sanatorium, which was emphasized as of increasing importance and expense. Seven new beds established with the approval of the government were responsible for the increased expenditure last year. A nurse for outside cases had been employed by the Anti-Tuberculosis League. The death rate in 1936 was the lowest in our recorded history, and it is hoped eventually to rid the province of tuberculosis. Mr. McGuigan also reviewed the work of the Old Age Pensions department, \$21,000 more had been spent last year and the Government getting for a further increase this year.

MR. GEORGE BARBOUR

A "magnificent effort" had been made last year to implement the Liberal pledge to balance the budget. Mr. George Barbour, the next speaker, declared. The Public Works Minister had explained that the only Liberal expenditure made on the \$3,000,000 borrowing authority obtained at the 1935 special session was \$25,000 for the old P. E. I. Hospital. He gave bond quotations to indicate that the finances of the province had improved under Liberal rule. With regard to the administration of justice, Mr. Barbour said the Premier had reported that during the year 41 auto drivers had been convicted, and every one sent to jail. He questioned if any Premier had ever made a bolder statement than that and he challenged the Guardian to show a better record in any previous year. There had also been 87 cancellations of licenses. Mr. Barbour commended the reports of the Education and Agricultural Ministers. He thought the Premier and Minister of Public Works should address the House just as if there never would be another election.

Abbie Sisters Honor Capt. At Banquet

The next speaker, Mr. P. A. McIsaac, first expressed his appreciation of the resolution of condolence which the House had passed in connection with his recent bereavement. "When the Hon. Minister of Agriculture was speaking on the Budget, he referred to his recent trip, last October, to the ancient colony of Newfoundland," Mr. McIsaac continued. I had the pleasure of accompanying the Minister on that occasion on a trade mission to obtain additional markets outside the province for our surplus live stock and produce. I need scarcely remind you that one of our planks in our platform at the last election was to develop markets outside the province, and I am pleased to state that the efforts of our government, in this regard, have not been in vain. At the present time, orders are coming forward for weaners, pigs and calves, from outlying districts in Newfoundland, and present indications are such that there will be a brisk trade in these commodities as the season advances. Upon investigation, they found that there was a promising market for cattle in the neighboring mainland provinces. Thousands of pounds of beef and veal for instance, were being imported from Central and Western Canada into the Maritimes, even to Charlottetown, and sold in competition with what our own farmers were producing. One reason for this was because of the excellent quality of the imported meat in comparison with a great deal of what producers were offering to the trade here. It seemed then, that to remedy this situation it would be necessary to improve the quality of our live stock; to make some organized attempt to produce our local market, and get possession of that valuable market just at our door. Within the last year Mr. McIsaac made a trip to New Brunswick, company with the secretary of the Live Stock Marketing Board, and took up this matter with a large packing concern. "They assured us that it was their desire that Maritime live stock producers would supply their plant with the material; not only in connection with hogs, but all other live stock which they were processing and..."
