THE CIVIC SITUATION.

The Patriot of last evening published the following letter from Recorder Haszard to His Worship the Mayor in regard to the validity of the civic nominations:

Charlotte, Feb. 4, 1904.
His Worship Mayor Warburton, City.
DEAR SIR,—In answer to your request to be advised as to what effect, if any, the absence of the City Clerk would have upon the nomination for Mayor, Councilors, etc., made yesterday, I beg to say that I am of the opinion that the nominations made, sufficiently comply with the spirit of the Statute, and would advise that the elections be proceeded with in the usual manner.

Further The Patriot states, presumably on the authority of the Mayor, "that under instructions from the Mayor, Mr. McLaughlin, Clerk of the City Court, was and is acting City Clerk during Mr. Davidson's absence."

Here it may be observed that the Recorder's guarded statement carries with it the implication that if the spirit of the law has been, the letter of the law has not been complied with. As to the further statement that Mr. McLaughlin was and is acting under instructions from the Mayor, we have yet to learn that the Mayor, apart from the Council, has any power to appoint a City Clerk, or to relieve him from his duties, or to clothe any person with authority to discharge the City Clerk's duties. It is clear that "Some one has blundered."

SAW RYAN RUN FROM SCENE OF MURDER

(Continued from First Page.)

the direction of Cartis Crossing, where he lived, at 12.50. He did not have any bundle in his hands at the time. This contradicts Ryan's statement that he had waited about for the murdered man to flush a shirt, collar or cuffs he could have placed in his pocket.

The police have established the following facts thus far: Ryan loitered about the shop of the Chinaman for over an hour; he was the last to see the Chinaman alive; a revolver found on Ryan has been identified as the property of the Chinaman; a watch given Ryan's betrothed shortly after 1 o'clock strongly resembles one owned by the dead man. The motive for the crime was robbery as money drawer and trunk of the dead man were rifled.

Mrs. Kirk Ridgeway, who lives on Water street, Hanover was notified by the police to be present at the hearing of Ryan in Hingham court.

Mrs. Ridgeway saw Ryan pass the house, running furiously, at 12.50 on the day of the murder. Her house is about three-quarters of a mile from the Chinese laundry and about one-quarter of a mile from R D Clapp's rubber factory. She recognized Ryan as a man who worked in the rubber factory and who lived at the house of Fred Pierce. She took particular notice of him, because of the fact that while running very hard he pulled out his watch.

This caused her to involuntarily turn about and glance at her own clock. As she did so she commented to herself, "That man is five minutes late," as the employees of the rubber factories are expected to be at work at 12.45. He had no laundry bundle with him at that time.

Ryan left the factory according to the story of his half-brother, Fred Pierce, on Friday of last week because he was ill. Feeling better on Saturday, he went to the factory and collected what money was due him.

"On Thursday he paid me \$12 due me for board," said Pierce. "He did not need any money, as he earned plenty of it." This statement is contrary to the evidence of those who are doing business near the laundry.

They say that Pierce was at the corner of Broadway and Washington street, within 25 yards of Yea Yoke's laundry, at 10 minutes of 12. He went to Perry's barber shop on Washington street and asked if they had seen Cy Ryan. Perry told him "Yes," that Ryan had come into the store and gone out again. Perry did not know where. Pierce then made the remark that he was waiting for Ryan, who owed him some money.

Pierce left the vicinity of the laundry at about 12.05 o'clock. The police are looking up the case of a stranger who applied to Hest Tripp of the Howard House for a room a week ago last night. He had with him a spaniel dog which he led by a rope. He claimed to be a bartender from Providence and a perfect stranger in town. As he paid in advance and stated that he would leave next morning, he was not asked to register.

The stranger said that he had come from Boston that day to buy this dog which he had in South Hanover, and had missed the returning train. From 9 until 10 o'clock he remained around the hotel office, making inquiries about many people in the neighborhood and their location.

After eating his breakfast in the morning he disappeared leaving the dog behind him. The man was about 35 years of age and of good appearance.

The Howard House is opposite the laundry. Cyrus L. Ryan, who is held on the charge of murdering the Chinaman, steadfastly protests his innocence and repudiates all knowledge of the deed.

He cannot explain to the satisfaction of the police how he came in possession of a revolver that is identical to the one owned by Yea Yoke, and is now missing from among the dead man's possessions.

The police are now waiting for positive identification of a watch that was given by Ryan to his sweetheart, Miss Katie Murray, and is believed to be the property of the dead man. This watch was bought by the Chinaman five years ago from a local jeweler, and has been seen but by few people since.

Ryan's sweetheart, Miss Murray, stated that he gave it to her at 1 o'clock on the day of the murder, or about two hours after the Chinaman was killed.

One of the important findings of the inquest were the nail marks made on the Chinaman's neck by the person who strangled him. The cause of Yea Yoke's death was officially given out as due to drowning by having his face immersed in a washtub full of water until life was extinct. The strangling was done before death.

Fred Pierce, the half-brother of Ryan, who is making preparations for Ryan's defence, told a Traveler reporter to-day that he was satisfied Ryan bought the revolver found on him, several months ago from a man in Rockland, Mass. This is the revolver the police say belonged to the murdered man.

The explanation regarding the watch is as follows, according to Pierce: Ryan gave to his sweetheart, Miss Murray, money and the watch. The watch was not the one he carried usually. The watch was held by Ryan as security for a loan to a seaman on the steamship Olivette two years ago, and was never redeemed. Ryan it is said, loaned money to seamen, getting a high rate of interest for the same. This story is partly borne out by the statement of one James White a seaman now living in Hanover, who declares that when he was on the Admiral Farragut a member of the crew told him of receiving

a loan from one Cyrus Ryan of the Olivette.

Drug Clerk McDonald, the jewelry agent, who sold a watch to Yea Yoke, does not know the number of it, although he thinks he can identify it.

Conductor Bradford who ran the train on which Ryan and his betrothed rode, said that he received a dollar bill for fares, and is still keeping it. He says Ryan acted very nervously.
