over in other provinces they have large centres and it is in these more crowded places that criminals seek refuge.

His Lordship also pointed out that the law in the provinces less poverty than in any other part of Canada. It is a matter of congratulation that last year there were very good crops and that prices were good. From information he had received from the banks and other institutions. His Lordship was assured that never in this province has there been such successful collection of debts as last fall. This he said was an indication of a general prosperity.

There were also larger deposits in the bank. Therefore while we have a complaint in particular instances this should not blind us to the many advantages we enjoy. The citizen worth while is not the pessimist, the man who is always finding something wrong. There is always a silver lining to the darkest cloud and at the present there is not only a silver lining but there are very few clouds on the horizon.

His Lordship referred to our transportation problem as one of the most serious difficulties we are ameliorating and the railway management is trying to do what it can to better matters. We are very far from having perfection as yet but it is encouraging to note some improvement. We can always do more by a little quiet propaganda than by acquiring a reputation of being kickers. It was to be regretted that our efforts towards bettering conditions have been directed toward too many objects at once. We should concentrate upon our most important problems and settle one by one. The most important problem in connection with transportation seems to be the halting of our island railroad. This was a matter which should be stressed before the Railway Board.

There is also the question of how can we increase the revenues of the province. We have only about a million and a quarter acres of land and practically all of this land that is arable is occupied at present. So far as farming is concerned we have no land to which we can attract any large number of immigrants and it would be difficult to divide the farms any smaller than they are at present. Therefore how can we obtain more revenue. If we had more people the burden of government would be divided over a greater number but having only a limited number of people and the expense of government continually increasing there is only one remedy and that is by increased taxation. We all know how very difficult it is to raise revenue sufficient to meet the expenses of government. We have practically only two sources of revenue in this province that is to say what ever revenue we get must come from the Dominion government or must come from direct taxation. Our revenue from the Dominion government is fixed and cannot be increased unless by some means we secure additional subsidies. Everybody knows that taxation is not popular but how otherwise are the expenses of government to be maintained. What is the government. It is simply the principle of the provinces. The government simply acts by reason of

certain powers delegated to them by ourselves. When money is being spent by the government in the carrying on of public affairs it is done so not for the sake of the government but for the people generally. This problem is becoming increasingly fertile in as much as the expense of government are increasing from year to year. This is only natural. We are ourselves spending more today than we were ten or fifteen years ago. We require more today than would satisfy us then in the matter of education, roads and other public works. If this were more generally realized His Lordship believed that the people would willingly pay more towards the expenditures of the government which are made after all for the benefit of the people themselves.

His Lordship referred to the important work which has been carried on within the past two years in attracting tourists to our province and to the fact that this is a benefit not only to the hotels and merchants but everyone on the island.

one of the most celebrated yachts in the world, the SUNBEAM. This vessel which had been seen on nearly all the seven seas, was in 1916 presented to the Government of India as a hospital ship. Even from the historic and most ancient and honorable office of Lord Warden of the Cinque Ports—an appointment particularly coveted—he was not excluded. That year saw the end of his career in the House of Commons as he had returned from this first official experience overseas that Mr. Freeman-Thomas captured Hastings. This borough he continued to represent until 1906, when he was defeated and transferred his services to the Bodmin Division of Cornwall, for which he was the Parliamentary representative until 1910.

Mr. F. Y. Newton of Roblin, and Mr. John Kennedy of Morden, although not as strong in debate as their associates, are nevertheless both useful members and strong in their respective constituencies. Mr. Newton has shown himself very capable in dealing with such questions as Farm Loans and Irrigation Credits.

The report has gone out that Rt. Hon. Arthur Meighen is to be present and deliver an address. This would in itself insure a large attendance, for the federal leader of the party was to speak anywhere in this Province. We know it means much when we say it, yet without hesitation, we do say that nowhere in Canada is Mr. Meighen more highly esteemed than in his own Province of Manitoba.

The movement of the straws shows the direction in which the wind is blowing and the fact that at least one of the members of the House who in 1922 were elected as independents, have openly announced their intention to run as Conservative Candidates, deepens the feeling that the next election will bring the Conservative party back to power.

Although the party platform will not at this Convention receive its final revision (that will be done at the close of next session) the following questions will be carefully considered and discussed: (a) Law enforcement, (b) Rural credits, (c) Our educational policy (during the past three years numerous primary schools have been closed for lack of funds.) (d) Our suburban problems. (Here a most serious situation has arisen with which the Government has proven itself incompetent to deal.) (e) Provincial Income tax. (f) Municipal levy—an extra tax imposed upon the Municipalities by the Norris Government. Along with this will be discussed the necessity for a readjustment of our whole financial policy. (g) The need of adopting a wise policy dealing with farm lands sold at tax sales coupled with a wise selective immigration policy that will place producers on these lands again. No doubt before the Convention closes a resolution will be passed condemning the Bracken Government for its failure to strongly present Manitoba's freight rates case before the commission and most likely another one expressing sympathy with the Maritime Provinces in their desire to realize their pre-confederation aspirations.
